The Common Council met pursuant to adjournment.

By consent, Mr. Bigham, from the Committee on Streets and Alleys, submitted the following report :

INDIANAPOLIS, June 2, 1873.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN :—Your Committee on Streets and Alleys, to whom was referred sundry papers, have examined the same and would respectfully report as follows, to-wit :

FIRST.

A remonstrance was referred to your committee, signed by Andrew Wallace, William Dell and others, against improving the south sidewalk on Maryland street from Alabama street to Virginia avenue, and as the contract for said work has been let, there is now no way by which said work can be postponed, and we herewith report back the remonstrance.

SECOND.

A petition was also referred to us, signed by John H. Ohr and Charles Hasson, asking that an extra amount be allowed them for damages sustained by them in widening their sidewalks on the west side of north Meridian st., between St. Clair and Pratt st. As said damages and benefits were assessed by the City Commissioners and their report adopted by the Council, it would be establishing a very bad precedent to make parties extra allowances in such cases, we therefore herewith return the petition and recommend the prayer of the petitioners be not granted.

THIRD.

A petition was also referred to your committee from Julius Quiesser and others, property owners on Virginia avenue, asking that more stone crossings be put down on said avenue. As your committee have made an examination of said ave. and find that there is as many down now as should be down, we herewith report back said petition and recommend that the prayer be not granted.

FOURTH.

A remonstrance was also referred, signed by Charles Dehne, Eugene Renard and others, remonstrating against the passage of an ordinance for grading, bowldering, curbing and paving with brick the sidewalks on Liberty st. from Washington to Meek street. As said street is in a very good condition, we would recommend that the bowldering of the street be dispensed with, but that the outside edges of the sidewalks be curbed with stone, and the sidewalks paved with brick. As the property holders do not object to the last named improvement, we would recommend that the old ordinance introduced be stricken from the files, and in lieu thereof report the following ordinance :

An ordinance to grade and pave with brick, bowlder the gutters and curb with stone the sidewalks on Liberty street, from Washington to Meek st.

FIFTH.

A remonstrance was also referred to your committee, signed by Samuel Merrill and 17 others, remonstrating against the passage of an ordinance to pave with brick the sidewalks of Merrill street from Delaware to East street. We would recommend that the prayer of the remonstrants be granted, and that the ordinance be stricken from the files.

SIXTH.

A remonstrance was referred to your com., signed by Phelix Meiullard, Peter Schwartz and others, against the improvement of the alley east of Winston street, between the Bellefontaine railroad and Winston street. Your committee believing said improvement should be made, herewith return the remonstrance and recommend that said improvement be made.

SEVENTH.

A communication was referred to your committee, signed by F. A. Lehr, Moses McLain and others, property holders on Cypress street, in the southeast addition of the city, stating that Henry C. Rosebrook and Green Wright, the owners of lots 4 and 5, in square 14, etc., had dug the clay out of part of what is belonging to said street. We would recommend that the said communication be referred to the City Assessor to report whether said Cypress street is within the city limits.

EIGHTH.

A petition was referred to your committee, signed by Anton Banka, Frederick Gunsberg and others, asking that Rockwood street from East to Noble street be improve by grading and graveling the street, and paving the sidewalks with brick, and also to open said street from East to Noble street.

Your committee would recommed that said street be opened from East to Noble st. before any ordinance is passed for the improvement of the same.

NINTH.

A motion was referred to your committee granting D. Muzman the privilege of grading the alley in front of his property. Your committee would report that if said alley needs improving, that an ordinance be introduced for that purpose, and that the motion be not adopted.

TENTH.

A remonstrance was referred to your committee, signed by F. G. White and others, property holders, remonstrating against the passage of an ordinance for grading and paving with brick the sidewalks on Huron street from Noble

to Dillon street. As said sidewalks are in pretty good condition, we herewith report back the remonstrance and recommend that the ordinance be stricken from the files.

ELEVENTH.

At a regular meeting of the Common Council, held on the 21st day of April, 1873, the following motion was referred to the Committee on Streets and Alleys:

"There are some six or eight streets in the city where two are of the same name, and would recommend that some committee be authorized to change the names of the duplicates."

In pursuance of said motion, your committee would recommend the following: East Grant street to be named hereafter Leota street. Lindon st., from Huron street south-east of Dillon street, to be called Mitchell street. Nebraska street from Mayhew street north of First street and west of the Michigan road, to be called Morton street. Patterson street from Sixth to Seventh street, first street west of Mississippi street, to be called Gibson st. Sharpe street from Oriental street east, first street south of Washington st., to be called Alaska street.

TWELFTH.

A petition was presented from John Carlisle, asking the Council to pass an ordinance to grade and gravel from curb to curb West street from Washington to Market street. We would recommend that the above petition be referred to the Councilmen from the Fourth Ward.

We would also recommend that the ordinance now pending for the improvement of Potomac alley or street, from Mississippi to California street, be passed.

THIRTEENTH.

A communication was referred to your committee from John Sutherland, Thomas Dowling and Alexander Herron, members of the committee of the State Board of Agriculture, accompanied by resolutions adopted by said State Board, February 27, 1873, which are follows, to-wit:

Resolved, That the City Council of Indianapolis be respectfully requested to take such steps as will improve, open and declare as a public street what is known as the Fort Wayne Road, this being one of the principal avenues pointing to the Fair and Exposition grounds, and is essential to its success.

Resolved, That said Council be informed that it is very desirable that Alabama, Delaware, Pennsylvania and other streets be improved as far north as the Fair grounds before the time fixed for the holding of the Fair and Exposition.

Resolved, That the Council be requested to open a street or avenue, to be called Exposition avenue, which shall run west from the Fort Wayne Road

along the outside of the Fair grounds, and thence west to Illinois or Henderson street, said avenue to be 100 feet wide through the Fair grounds, and not less than 60 feet wide the rest of the distance.

Your committee have no objections to any of the improvements asked for provided it is done as other improvements are made, at the expense of the property on each side of the line improved, and for that purpose would recommend that a copy of said resolutions be furnished the Councilmen from said ward to introduce the proper ordinances, if they desire the improvements made.

FOURTEENTH.

An ordinance to repeal special ordinance No. 14, 1873, entitled an ordinance to provide for grading and graveling Coburn street and sidewalks, from East street to Madison avenue. As the work which this ordinance proposes to repeal is already under contract, we herewith report the ordinance back with the recommendation that the same be stricken from the files.

The Finance Committee find, on examination, that to meet an outstanding issue of bonds—"Series D"—issued July 1, 1871, and payable two years from date, for \$100,000, and the last installment of interest on the same of \$4,000; and, also, the semi-annual interest on "Series F," of bonds issued July 1, 1872, of \$4,000; and to meet current expenses for which no means are provided, a loan of \$125,000 ought to be made, and having ascertained that a sixty days' loan can be made of that amount at 8 per cent. per annum interest, they recommend that the accompanying ordinance be passed.
