## REGULAR SESSION.

The Common Council met in regular session.

The proceedings of the regular session, held October 4th, 1875, were read and approved.

Sealed proposals for constructing a three foot brick sewer in Illinois street, between Maryland and South streets; also, for erecting lamp posts, lamps and fixtures on Tennessee street, between Tinker or Seventh and Twelfth streets, were received, opened, read and referred to the Committee on Contracts.

Indianapolis, October 11, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—I was directed to enquire into the expensive use of gas in the Station House, tunnel and No. 5 Engine House, and report the same:

The gas bill of No. 5 Engine House includes the gas consumed in the northern Station House, which is connected with said engine house, and in which the gas is kept burning occasionally all night. This will account for the extra use of gas at that point.

The gas bill of the Central Station House is larger for October than it was for September by 1,600 feet. I had the meter changed at this point a short time ago, and find the consumption about the same as usual.

The consumption of gas in tunnel was 9,700 feet less in October than in September. The sidewalks of this tunnel are never used by any respectable persons, and I would recommend the closing up of the same as a useless expense in the consumption of gas.

#### SECOND.

In compliance with your instructions, I notified Mr. Ballard, the contractor for lighting and extinguishing the street lamps, that unless he complied with the terms of his contract, that the Council would proceed to annul the same on Monday evening, October 11th, 1875.

Since serving the above notice a large number of the street lamps were not lighted and entirely neglected, and complaints were so numerous and constant that I felt obliged to do something to have the lamps lighted and promptly attended to until your honorable body took some action in the premises,

On last Wednesday, October 6th, with Mr. Ballard's consent and with the approval of the Chairman of the Committee on Gas, I placed Mr. Ott in charge of the west

half of the city until Tuesday, October 12th, or until some permanent arrangements were made; Mr. Ott receiving his pay from money to be deducted from Mr. Ballard's account.

Since this arrangement was made the lamps have been properly lighted and attended to with but one or two exceptions in the east portion of the city. This proves conclusively that the city should be divided into two or more sections, and seperate contracts made for each, and by so doing we will have but little trouble with the lighting of the lamps, provided the contractors receive compensation sufficient to pay the boys for their labor.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—In regard to the ordinance for the improvement of East Ohio street with cedar block pavement, referred to me at your last meeting, I am of the opinion that an ordinance providing for such improvements as are contemplated in the ordinance in question, cannot be passed without the votes of two-thirds of all the members of the Council, unless such improvement is petitioned for by two-thirds of the owners of the whole line of lots fronting on that part of the street proposed to be improved, and in case of such petition it only requires a majority vote to pass the ordinance.

Section 68 of the general charter provides that in case of such petition by twothirds of the owners, the Council may cause the improvement to be made by a majority vote, and section 70 of the general charter provides that the Common Council may cause any of the improvements memtioned in section 68, without petition, with the concurrence of two-thirds of the members thereof. The power of the Council is limited by the grants in the charter.

The improvements specified in the Ohio street ordinance cannot be made and charged to the holders of the abutting property unless petitioned by two-thirds of such holders and ordered by a majority vote of Council, or unless ordered by a two-thirds vote of all the Council.

This construction of the charter is, I think, fully sustained by a decision of the Supreme Court, in 41 Ind., page 1.

The Ohio street ordinance, not being petitioned for by two-thirds of the property holders on that street, and having secured only seventeen votes in favor of its passage, was not, in my opinion, legally passed.

Indianapolis, October 11, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your Committee, to whom was referred the charges of bribery and corruption on the part of the Indianapolis Bridge Company, beg leave to report that they have had two sittings and examined a considerable number of witnesses; that the evidence was conclusive as to the fact that an attempt at bribery on the part of Mr. H. Laird, the agent of the aforesaid company, had been made, that individual declaring under oath that he wrote the note introduced by Councilman Madden, to Charles P. Fant, Committee Clerk, at the latter's solicitation, said Committee Clerk having assured him that the bridges could be secured for said Company for \$200.

While evidence in some respects was conflicting, in the opinion of your Committee there is sufficient therein to warrant the Council in preferring charges against said Committee Clerk of complicity in an attempt at bribery and corruption, and would recommend that such charges be preferred by the City Attorney, and said Clerk be summoned before the bar of the Council to answer thereto at an early day, and that meanwhile he be relieved from the duties of his position, and that said duties be under the charge and direction of the City Attorney, until the guilt or innocence of said Committee Clerk is determined.

Your Committee would further recommend that the Council in future do not recognize any bids of the Indianapolis Bridge Company so long as Mr. H. Laird is in their employ, and until they have disclaimed all knowledge of or connection with this attempt at bribery and corruption.

Indianapolis, October 11, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your Committee on Gas, to whom was referred the report of the City Civil Engineer of September 27th, 1875, submit the following, viz:

#### FIRST.

In reference to the first paragraph of the report, submit the following statement:

The Gas Company agree to light and furnish everything for the sum of \$35.00 per lamp and post, making the cost of 2,700 lamps and posts equal to \$94,500.00.

The present cost of the gas at this time is-

1,200 hours additional	. 16,200
Making total for the all night plan	\$91 128

The cost of the 1,200 hours additional would be \$16,200.00, and your Committee report in favor of adopting the all night plan, and recommend that the City Civil Engineer be directed to make a schedule in conformity with this recommendation.

#### SECOND.

In reference to the third paragraph of said report, we would offer the following recommendation, viz:

That the northwestern and southwestern districts, comprising all that part of the city west of Pennsylvania street and north and south of Washington street, be awarded to Charles Ott, for lighting, extinguishing and repairing the lamps in said district, for the sum of 22 cents per lamp and post.

That the northeastern district, comprising that part of the city north of Washington street and east of Pennsylvania street, be awarded to Joseph Raible, for lighting and extinguishing the lamps in said district, for the sum of 22 cents per lamp and post.

That the southeastern district, comprising that part of said city south of Washington street and east of Pennsylvania street, be awarded to James Neal, for lighting and extinguishing the lamps in said district, for the sum of 22 cents per lamp and post.

The above awards to be temporary, and to hold until the 12th of November, and the contracts and bonds to be made in conformity with this recommendation.

We would also recommend that the City Civil Engineer advertise for bids to be received on the 15th of November, for lighting, repairing, etc., the lamps for one year, said advertisement to conform with the ordinance concerning the same.

## THIRD.

An ordinance and remonstrance against the same, "providing for gas on Michigan

street, from Arsenal avenue to the U.S. Arsenal grounds," was referred to your Committee, and we recommend that said ordinance be stricken from the files.

Indianapolis, October, 4, 1875.

C. F. Darnell, Esq., Chairman of Committee on Gas Light :

Dear Sir:—In regard to your inquiry as to making a contract with the Gas Company to supply gas to the public lamps of the city upon a time table, increasing the number of hours burned, etc., permit me to say that we feel assured that the Gas Company would contract with the city for the unexpired time of the existing contract between the company and city, to-wit: 19th March, 1876, upon agreement as follows, viz:

1st. The city to put the lamps in good repair.

Then the Gas Company will furnish gas for them upon a time table of 3,200 hours per annum, the burner of each lamp to consume four cubic feet of gas per hour, and to be tested to that capacity under a pressure of fifteen-tenths lbs., and in addition to such supply of gas the Company will do the tighting, extinguishing and clean said lamps; will also furnish all the necessary material at their own expense and keep in repair said lamps.

All of which the Company will furnish, do and perform for the price of thirty-five dollars per annum, payable monthly.

By consent, Mr. Schmidt presented the following communication and resolution:

Indianapolis, October 11, 1875.

To the Mayor and Common Council of the City of Indianapolis:

The last Legislature made an appropriation to the Institution for the Deaf and Dumb for the purpose of enlarging and completing the sewerage for the same. The Board of Trustees have had a survey and plat of the proposed sewers made by the City Civil Engineer, according to which it is intended to run a sewer from the intersection of Washington street and State avenue to Ohio street, and there connect with the sewer already built by the city, extending along Ohio and Market to Noble street.

The Board of Trustees instruct me to petition your honorable body for the privilege of constructing this branch of the proposed sewer along State avenue to Ohio street, and to connect with the city sewer of the last named street.

The Board propose, without cost to the city, to make a two-foot brick sewer, according to the specifications adopted by the Council, and the instructions of the City Civil Engineer, and to allow the same to be used by the property holders along the route under the same regulations that other city sewers are used.

The length of the sewer that the institution propose to make is about seven hundred (700) feet inside the city corporate limits.

The reason for the change of the present sewer is two-fold. The one in use is not large enough, and it discharges into the creek six or seven hundred feet east of State avenue, and does not, on that route, afford fall enough. Down State avenue to Ohio street a fall of nine (9) inches to the hundred feet is obtained. This is the proper

route, in the opinion of the City Civil Engineer, in which to construct the aforesaid sewer.

As the season is already far advanced and the contractors are ready to begin work on the sewer, we humbly ask that our request be granted, if possible, at the present meeting.
