The Common Council met in regular session.

The proceedings of the regular session, held April 16th, and the adjourned session, held April 18th, 1877, were read and approved.

Mr. Bugbee, from the Committee on Contracts, submitted the following report :

Indianapolis, April 23, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—Your Committee on Contracts, to whom was referred the proposals presented to Council Monday evening, April 16, 1877, for grading and graveling Second street and sidewalks, where not already improved, between Meridian and Pennsylvania streets, have examined the same, and find them to be as follows, to-wit:

J. J. Palmer, 69 cents per front foot on each side, and where the sidewalks are improved a reduction of 18 cents per front foot to be made.

John Greene, 65 cents per lineal foot front on north side of said street, and for 55 cents per foot front on south side from Meridian street to the first alley east of Meridian street, and 60 cents per foot from said alley to Pennsylvania street.

J. G. Sickler, 37 cents per front foot on south side, where improved first 200 feet, and 60 cents per front foot on north side first 200 feet, and 54 cents per front foot on each side for balance of street.

R. Carr, 41 cents per foot front, where already improved, and 57 cents per foot front where not improved.

Henry Clay, 41 cents per foot front, where already improved, and 48 cents per foot front where not improved.

R. H. Patterson, 37 cents per foot front, where already improved, and 54 cents per foot front where not improved.

E. B. Elliott, 36 cents per foot front where already improved, and 49 cents per foot front where not improved.

Irwin & Hanna, 36 cents per foot front where already improved, and 48 cents per foot front where not improved.

J. McB. Shepherd, 36 cents per foot front where already improved, and 40 cents per foot front where not improved.

Jas. A. Garner & Co., 32½ cents per foot front where already improved, and 43 cents per foot front where not improved.

James Mahoney, 30 cents per foot front where already improved, and 44 cents per foot front where not improved.

John Richardson, 30 cents per foot front where already improved, and 37 cents per foot front where not improved.

John Low, 26 cents per foot front where already improved, and 34 cents per foot front where not improved.

John Low being the lowest and best bidder, your committee recommend that he be awarded the contract.
