Gentlemen:—The undersigned, attorney acting for and on behalf of Mrs. Catharine C. Bobbs, in relation to the widening of Dillon street, respectfully represents that she is the owner of a number of lots bordering on the east side of said street, from which ground must be taken to widen the street.

She has heretofore filed a plat of her land, and located a street known as Bobbs' street, which is east of and parallel with said Dillon street, through the the whole length of her land. She now, in view of widening Dillon street, hereby proposes to release all claim for damages against the city; provided, Bobbs' street, as it now exisis, be vacated; which, when done, will enable her to change the frontage of her lots, and will be injurious to none. The parties on the west side of Dillon street, opposite her premises, have been informed of this proposition, and are well satisfied, because the damages will be settled, as far as she is concerned, without expense or injury to any of them. She has never sold any of the lots, nor has Bobbs' street ever been opened or used by the public. The vacating of Bobbs' street will give her as much ground on the east side as will be taken off the west side of her lots, and leave room for an alley in place of Bobbs' street. Wherefore, she prays such action may be taken by the Council as may be consistant with the statutes, and consonant with the statements and proposition herein set forth.
