Inasmuch as the Board of Public Works was required to expend the sum of Fourteen Thousand Three Hundred Three Dollars and Fifty-nine Cents (\$14,303.59) for safety and precautionary measures in the form of temporary construction, partial demolition, and fire debris removal in Tomlinson Hall, in an emergency, and owes the Wilhelm Construction Company said sum for this service, this sum should be paid.

Section 3. It further appearing that upon the razing of the Tomlinson Hall building, plumbing, electrical, demolition, and barricade costs will be incurred, and reconstruction of a new West wall and Market entrance will be necessary, and bids for such work have been let by the Board of Public Works, at a cost of Fifty-seven Thousand Four Hundred Ninety-eight Dollars and Fifty-nine Cents (\$57,498.59).

Section 4. There accordingly exists a balance after the foregoing needed expenditures in the approximate amount of Forty-two Thousand Five Hundred One Dollars and Forty-one Cents (\$42,501.41); that the City Market, part of which heretofore was on the ground floor of Tomlinson Hall building, is in need of repairs at an estimated cost of this amount, or a greater amount.

Section 5. In view of the foregoing, said public fund is hereby allocated and transferred and made a part of the following specific budget items in the City General Fund, as follows, to-wit:

Section 6. Said funds 26 (a), in both the Board of Public Works and the Board of Public Safety, shall be and constitute encumbered funds which shall remain and constitute funds until such time as the total amounts appropriated thereto are used for the purposes set out in this Ordinance, and the City Controller is directed and ordered to so encumber said funds.

Section 7. The City Clerk is directed to post written notice of the pendency of this Ordinance in three (3) public places, notify the public generally that the Common Council will consider this Ordinance as to the second and third readings on the second (2d) day of June, 1958, and shall notify taxpayers that three per cent (3%) or more of the resident taxpayers of the City of Indianapolis, other than mere poll taxpayers, may file their written remonstrance to the proposed transfer of the funds involved herein.

Section 8. This Ordinance shall be in full force and effect, pro-

vided no lawful taxpayer's remonstrance be filed, from and after its passage and approval by the Mayor.
