GENERAL ORDINANCE NO. 100, 1958

An Ordinance to amend the Municipal Code of Indianapolis, 1951,

### GENERAL ORDINANCE NO. 109, 1958

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, and more particularly Title 4, Chapter 4-812 thereof, by the addition of sub-section 321 thereto, prohibiting the owner, driver or operator of any vehicle from parking, stopping or standing at all times on certain designated streets between certain designated points, and fixing a time when the same shall take effect.

### BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 8, Section 4-812 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, be, and the same is, hereby amended by the addition of sub-section 321 thereto, as follows, to-wit:

321	Olive Street	Both	Lexington Avenue	English Avenue

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

Section 2. That Title 4, Chapter 6, Section 4-602 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, be, and the same is, hereby amended by the addition of sub-sections 121, 122, 123, 124 and 125 thereto, to read as follows:

WHEREAS: In 1952 and 1953, traffic changes were made by delegation of power from this Council to the Board of Public Safety and the Traffic Engineer, and

WHEREAS: This delegation of power was later withdrawn by this Common Council for the purpose of exercising such control itself, and

WHEREAS: In such period of time by such delegation of power, Michigan Street and New York Street were designated as one-way streets respectively, from Dorman Street to Emerson Avenue and from Arsenal Avenue to Emerson Avenue, and

WHEREAS: By reason of the foregoing facts, the Code of 1951 does not list New York and Michigan Streets as one-way streets over the area as indicated hereinabove, and

WHEREAS: This Common Council believes such streets should be listed in the Traffic Code of the City of Indianapolis, as ordained one-way streets.

NOW, THEREFORE,  
BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That sub-sections (35) and (40) of said Section 4-602 of Title 4, Chapter 6, of the 1951 Municipal Code of Indianapolis, General Ordinance No. 140, 1951, be amended to read as follows:

Section 5-2911. Permit Required for Burning of any Building or Structure.—No person shall set fire to or burn, or cause the setting of fire to or the burning, or aid, counsel or procure the setting of fire to or the burning of any dwelling house, rooming house, apartment house, hote, shop, barn, stable, garage, or any other building, structure or outhouse, whether finished or unfinished, occupied or unoccupied, and whether owned by him or another, within the City of Indianapolis, unless the same is approved by the Bureau of Fire Prevention, the Chief of the Fire Department, and the Board of Public Safety, and upon such approval, a written permit for same be obtained from the City Controller upon the payment of a fee of five dollars (\$5.00) to said Controller, by the person to whom such permit is issued; provided further, that no such permit shall be issued unless the person to whom such permit is issued first posts a bond with and satisfactory to the City Controller, indemnifying all and any persons against any and all damage to property and injury to person caused by such burning.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

- (a) Massachusetts Avenue between Ohio Street and Vermont Street.
- (b) Virginia Avenue between Pennsylvania Street and Delaware Street.

Section 3. This ordinance shall be in full force and effect from and after is passage, approval by the Mayor, posting of the requisite signs and installation of parking meters, and compliance with all other laws pertaining thereto.


