GENERAL ORDINANCE NO. 24, 1960

An ordinance to amend the Municipal Code of Indianapolis,

1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8, Section 4-817 thereof, by the addition thereto of a subsection prohibiting parking, stopping or standing between the hours of 7:00 A.M. and 9:00 A.M. inclusive on the west side of Central Avenue from 38th Street to 52nd Street except on Saturdays and Sundays, providing for a penalty for the violation of same, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 25, 1960

An ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 9 thereof by the addition of subsections to Section 4-927, and Section 4-928, providing for 30 minute parking at a 5¢ rate for parking meters on both sides of Louisiana Street from McCrea Street to Meridian Street, and providing one hour parking at a 5¢ rate on both sides of Jackson Place also known as Jackson St., from McCrea St. to Meridian St., providing for a penalty for violation of same, repealing all ordinances or parts thereof in conflict therewith and fixing a time when the same shall take effect.

APPROPRIATION ORDINANCE NO. 5, 1960

An ordinance appropriating, transferring, reappropriating and reallocating a certain sum, tax levy money, from a certain designated item and fund in the Department of Public Works, Administration, created by virtue of the 1960 Budget, General Ordinance No. 75, 1959, as amended, to a certain designated item and fund in the Department of Public Safety, declaring an emergency and fixing a time when the same shall take effect.

APPROPRIATION ORDINANCE NO. 6, 1960

An ordinance reducing a certain specific and designated fund and item in the Department of Flood Control in the amount of Ten Thousand Dollars (\$10,000.00) and reappropriating the same to a certain designated item and fund in said department, created by virtue of the 1960 budget, General Ordinance No. 75, 1959, as amended, for the payment of salary for one additional Flood Control Engineer in the Department of Flood Con-

trol, hereby creating such position in said department, declaring an emergency and fixing a time when the same shall take effect.

SPECIAL ORDINANCE NO. 45, 1960

An ordinance annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect.

INTRODUCTION OF APPROPRIATION ORDINANCES

By Councilman Spoerle:

APPROPRIATION ORDINANCE NO. 9, 1960

AN ORDINANCE appropriating the sum of Eighty-five Thousand Seven Hundred Fifty Dollars (\$85,750.00) from the unexpended and unappropriated 1959 balance of the Aviation General Fund of the City of Indianapolis, to the fund now designated as the City of Indianapolis, Aviation Improvement Bond Fund of 1959, and fixing a time when the same shall take effect.

WHEREAS, the Department of Aviation has in its general fund an excess of Eighty-five Thousand Seven Hundred Fifty Dollars (\$85,750.00), which is not presently needed for current expenses, and

WHEREAS, the Department of Aviation, may not use any of said sum for necessary construction excepting upon authorization of the City Council and

WHEREAS, the Department of Aviation requires additional monies to preform major Repair and Rehabilitation of Airport Facilities in order to meet the needs of increased traffic at its Weir Cook Municipal Airport and to continue its high standard of operations,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. The Aviation General Fund of the City of Indianapolis, be and the same is hereby reduced in the sum of Eighty-five Thousand Seven Hundred Fifty Dollars (\$85,750.00), to-wit:

Reduce:

Aviation General Fund of the City of Indianapolis.....\$85,750.00

Increase:

Aviation Improvement Bond Fund of 1959 -----\$85,750.00

Section 2. The above transfer and appropriation is necessary to supplement existing funds received by the receipt of the sale of general obligation bonds of the City of Indianapolis, and to complete the work order previously authorized by Ordinance No. 11, 1959.

Section 3. That before passage of the ordinance, the Common Council of the City of Indianapolis, shall give ten days notice by posting written or printed notice thereof in at least three public places in the City of Indianapolis, stating the time and place, when and where the Common Council will meet to consider the proposed transfer.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

APPROPRIATION ORDINANCE NO. 10, 1960

AN ORDINANCE appropriating the sum of Three Hundred Twenty-five Thousand Dollars (\$325,000.00) from the unexpended and unappropriated 1959 balance of the Aviation General fund of the City of Indianapolis, to a 1960 Improvement Fund, to pay a portion of the cost of the construction and lighting of a new runway at Weir Cook Municipal Airport, and to hold or invest and reinvest in accordance with the laws of the State of Indiana relating to the holding or investing of public funds, and fixing a time when the same shall take effect.

WHEREAS, the Department of Aviation has in its general fund an excess of Three Hundred Twenty-five Thousand Dollars (\$325,000.00), which is not presently needed for current operating expenses, and

WHEREAS, the Department of Aviation may not use any of said sum for necessary construction excepting upon authorization of the City Council, and

WHEREAS, the Department of Aviation of the City of Indianapolis does require said Three Hundred Twenty-five Thousand Dollars to construct a new runway and associated facilities. Said funds will be the portion contributed by the Department of Aviation and will be matched in like amount by the Federal Government. The said runway will cause Weir Cook Municipal Airport to offer the safety and convenience necessary to continue its high standard in air transportation.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Aviation General Fund of the City of Indianapolis, be and the same is hereby reduced in the sum of Three Hundred Twenty-five Thousand Dollars, to-wit:

Reduce:

Aviation General Fund of the City of Indianapolis----\$325,000.00

and the same is hereby transferred therefrom, reappropriated and reallocated to the following designated fund:

Increase:

Airport Construction Fund of 1960 -----\$325,000.00

Section 2. The above transfer and appropriation is necessary because of an existing construction program. There are sufficient funds by virtue of the above reduction in the city budget to meet these appropriations and said appropriations will not result in any increase in the total budget.

Section 3. That before passage of this ordinance, the Common Council of the City of Indianapolis, shall give ten days notice by posting written or printed notice thereof in at least three public places in the City of Indianapolis, stating the time and place, when and where the Common Council will meet to consider the proposed transfer.

Section 4. This ordinance shall be in full force and effect from

and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

AN ORDINANCE establishing certain passenger and/or loading zones in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets in the City of Indianapolis, with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, Section 4-1001, and the Board of Public Safety after due investigation, having recommended the establishment of the same, the following passenger and/or loading zones be and the same are, hereby established in the City of Indianapolis, to-wit:

- (a) Beginning at a point 107 ft. south of the south curb line of 34th Street and extending 50 ft. south on the east side of Central Avenue for the use and occupancy of Charles L. Walker, Inc., 3351 North Central Avenue.
- (b) Beginning at a point 79 ft. northwest of the north curb line of Ohio Street and extending 35 ft. on the southwest side of Indiana Avenue for the use and occupancy of Sack's Brothers, 102 West Ohio Street.
- (c) Beginning at a point 82 ft. northwest of the north curb line of McCarty Street and extending 80 ft. on the northwest side of Sand Street for the use and occupancy of Hetherington & Berner, Inc., 701 Kentucky Avenue.

Section 2. That said loading zones are hereby declared to be sub-

ject to all existing traffic and parking regulations, and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

Which was read for the first time and referred to the Committee on Election.
