## GENERAL ORDINANCE NO. 97, 1960

## INTRODUCTION OF GENERAL ORDINANCES

By Councilman Moriarty:

### GENERAL ORDINANCE NO. 104, 1960

AN ORDINANCE to amend the Municipal Code of Indianapolis,  
1951. General Ordinance No. 140, 1951, as amended, and more  
particularly Title 4, Chapter 14, Section 4-1416 thereof, regulat-  
ing the sounding of a whistle at railroad grade crossings within  
the corporate limits of the City of Indianapolis and fixing a time  
when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 14, Section 4-1416 of the Munic-  
ipal Code of Indianapolis, 1951, be amended to read as follows:



4-1416. Sounding Whistle.—No person in charge of any locomotive shall sound, or permit to be sounded, the whistle or horn thereof for any public grade crossing within the corporate limits of the city which is protected by flasher lights, bells, watchmen, flagmen, or gates. Upon conviction for a violation of this section, a fine may be imposed in any sum not exceeding \$25.00.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

Which was read for the first time and referred to the Committee on Public Parks.

By Councilman Spoerle:

GENERAL ORDINANCE NO. 105, 1960

AN ORDINANCE amending the Municipal Code of Indianapolis 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8 thereof by the addition of a subsection to Section 4-814, prohibiting parking at all times except Sundays and Holidays on part of East 16th Street, further, by the addition of subsections to Section 4-821, prohibiting parking, stopping or standing between the hours of 3:00 P.M. to 6:00 P.M. inclusive except on Sundays on certain portion of North Meridian Street, 34th Street and West Morris Street, further, by the addition of a new Section, Section 4-834.3, prohibiting the parking, stopping or standing of vehicles on certain streets between the hours of 6:00 A.M. to 9:00 A.M. inclusive, except Sundays, providing a penalty for violation of same, repealing ordinances or parts thereof in conflict therewith, and fixing a time when the same shall take effect.

WHEREAS, the Bureau of Traffic Engineering of the City of Indianapolis has heretofore conducted various surveys of the traffic count and of the need for various parking restrictions and has recommended certain parking restrictions to the Board of Public Safety, and

WHEREAS, the Board of Public Safety of the City of Indianapolis

has considered said recommendations relating to parking restrictions and has determine that it is in the best interests of the City of Indianapolis and for its public safety to prohibit parking on certain streets at certain times:

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 8, Section 4-814 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be and the same is hereby amended by the addition thereto of the following subsection, to-wit:

Section 2. That Title 4, Chapter 8, Section 4-821 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be and the same is hereby amended by the addition thereto of the following subsections, to-wit:

Section 3. That Title 4, Chapter 8 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be and the same is hereby amended by the addition thereto of Section 4-834.3, as follows, to-wit:

Section 4-834.3. Parking, stopping or standing prohibited between the hours of 6:00 A.M. and 9:00 A.M. inclusive, except on Sundays on certain streets.

It shall be unlawful for the owner, driver or operator of any vehicle to park or stop the same or to permit the same to be parked or to stand at any time between the hours of 6:00 o'clock A.M. and 9:00 o'clock A.M. inclusive in the morning of any day of the week except Sundays, upon any of the fol-

lowing designated parts of the following designated streets in this city, to-wit:

Section 4. Any person, firm or corporation violating any of the provisions of this ordinance shall be subject to the penalties as provided in Title 4, Chapter 8, Section 4-831 of the Municipal Code of Indianapolis, 1951, as amended.

Section 5. All ordinances or parts thereof in conflict in whole or in part with the provisions hereinabove contained, are hereby repealed to the extent that they are in conflict with the above provisions, but only to that extent.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

President Wallace also introduced Mr. Geoffrey Samuel from Twickenham, London, England. Mr. Samuel is an exchange teacher and is now teaching Latin at Howe High School in Indianapolis.

Mr. Featheringill made a motion to adjourn which was seconded by Mrs. Spoerle, and the Council adjourned at 9:10 P.M.
