

PROCEEDINGS OF COMMON COUNCIL.

SPECIAL SESSION—APRIL 17, 1891.

The Common Council of the City of Indianapolis, met in the Council Chamber, on Friday evening, April 17th, A. D. 1891, at 8:00 o'clock, in special session, pursuant to the following call :

Indianapolis, Ind., April 16th, 1891.

To the Members of the Common Council :

The President and Vice President being absent, E. B. Swift, City Clerk, called the meeting to order. The roll was called, with the following result :

There being a quorum present, the Clerk announced that the next thing in order was the election of a temporary Chairman.

Councilman Rassmann nominated Councilman Murphy; who was chosen by unanimous consent.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

The City Attorney, on behalf of the Board of Public Works, introduced the following entitled ordinance, which was read the first time :

G. O. 9, 1891—An ordinance confirming and approving a certain agreement and contract made and entered into on the 15th day of April, 1891, by and between The City of Indianapolis and The Broad Ripple Rapid Transit Company, wherein said company is granted a certain right-of-way for the operation and maintenance of an electric railway within the City of Indianapolis.

On motion of Councilman Rassmann, the Rules were suspended for the purpose of placing G. O. 9, 1891, on its final passage; which was unanimously adopted by the following vote:


NAYS—None.


G. O. 9, 1891, was then read the second time, ordered engrossed, read the third time and passed, by the following vote:
