INTRODUCTION OF APPROPRIATION ORDINANCES.

By City Controller:

Appropriation Ordinance No. 6—1910: An ordinance appropriating the sum of fifteen hundred dollars (\$1,500.00) to and for the use of the Department of Public Safety, and fixing a time when the same shall take effect.

WHEREAS, There has heretofore been constructed and is now being operated a building at the corner of Miami and Adelaide streets, in the City of Indianapolis, which is known as the Pentecost Free Municipal Shelter House, which is devoted to the temporary accommodation of unfortunate persons who are without food and lodging or means to procure same, and to which the police department of the city have the continued privilege of sending all such persons as apply to such department for temporary aid; and,

WHEREAS, The continued maintenance and operation of such shelter house is and will be influential in the prevention of crimes and misdemeanors within the City of Indianapolis, and will be of material assistance to the police department in maintaining peace and order within the city; now, therefore,

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, That the sum of fifteen hundred dollars (\$1,500.00) be and the same is hereby appropriated to the use of the Board of Public Safety to be expended by such Board in aiding in the maintenance and operation of said Pentecost Free Municipal Shelter House.

SEC. 2. This ordinance shall be in full force and effect from and after its passage.

Which was read a first time and referred to the Committee on Finance.

By City Controller:

Appropriation Ordinance No. 7—1910: An ordinance providing for the appropriation of \$720.00 to and for the use of the Department of Finance, and fixing a time when the same shall take effect.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the sum of seven hundred and twenty dollars (\$720.00) be, and the same is hereby appropriated out of any moneys in the city treasury not otherwise appropriated, to and for the use of the Department of Finance. The amount herein appropriated to be used in the payment of the salary for the third assistant City Clerk.

SEC. 2. This ordinance shall be in full force and effect from and after its passage.

Which was read a first time.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

By Mr. Denny:

General Ordinance No. 10—1910: An ordinance concerning the registration and licensing of managers of barber shops, regulation of barber shops and barbering, providing for sanitation in barber shops, declaring violations and providing penalties.

SECTION 1. Be it ordained by the Common Council of the City of

Indianapolis, That every manager or owner of a barber shop in the City of Indianapolis shall, within five days after the taking effect of this ordinance, register his full name and location of said shop in a book to be kept for that purpose in the office of the Chief of Police of said city; and every manager or owner of a shop that is first opened for business after said ordinance takes effect shall, within five days after the opening of said shop, register in like manner. Said manager shall pay a yearly license fee to the City Controller, for which the sum of \$5.00 shall be paid. The City Controller is hereby authorized to issue license for the operation of barber shops upon the presentation of applications properly signed and approved by the Chief of Police, which shall entitle said manager to conduct said business for one year from date of issuance of said license. Said license shall be non-transferable.

SEC. 2. The owner and manager of any barber shop, and each of them, shall equip said shop and keep said shop equipped with both hot and cold running water and with all such appliances, furnishings and materials as may be necessary to enable persons employed in and about said shop to comply with the requirements of this ordinance.

SEC. 3. No owner and no manager of a barber shop shall knowingly permit any person suffering from a communicable skin disease or from a venereal disease to act as a barber in said shop.

SEC. 4. No person who, to his own knowledge, is suffering from a communicable disease or from a venereal disease shall act as a barber.

SEC. 5. Every manager of a barber shop shall keep said shop and all furniture, tools, appliances and other equipments used therein at all times in a cleanly condition.

SEC. 6. Every manager of a barber shop shall cause all combs, hair brushes, hair dusters and analogous articles to be washed thoroughly at frequent intervals in a 5 per cent. aqueous solution of carbolic acid and to be kept clean at all times, and shall cause all mugs, shaving brushes, razors, shears, scissors, clippers and tweezers to be sterilized from time to time as hereinafter provided.

SEC. 7. No barber shall use for the service of any customer a comb, hair brush, hair duster or any analogous article that is not thoroughly clean, nor any mug, shaving brush, razor, shears, scissors, clippers or tweezers that are not thoroughly clean or that have not been sterilized since last used.

SEC. 8. Every barber immediately after using a mug, shaving brush, razor, scissors, shears, clippers or tweezers for the service of any person, shall sterilize the same by immersing them in boiling water for not less than a minute, or, in the case of razors, scissors and tweezers, by immersing them for not less than ten minutes in a 5 per cent. aqueous solution of carbolic acid, or in alcohol of a strength not less than 65 per cent.

SEC. 9. No barber shall use for the service of a customer any towel or wash cloth that has not been boiled or laundered since last used.

SEC. 10. Every barber shall cleanse his hands thoroughly in clean, hot water immediately before serving each customer.

SEC. 11. No barber shall, to stop the flow of blood, use alum or other material unless the same be used as a powder or liquid and applied on a clean towel or in a similar manner.

SEC. 12. No barber shall use a powder puff, a sponge or a finger bowl, for or in the service of a customer.

SEC. 13. No barber shall permit any person to use the head rest of any barber's chair under his control until after the head rest has been covered with a towel that has been washed since having been used before, or by clean, new paper.

SEC. 14. No barber shall shave any person, when the surface to be

shaved is inflamed or broken out, or contains pus, unless such person be provided with a cup and lather brush for his individual use.

SEC. 15. No barber shall undertake to treat any disease of the skin.

SEC. 16. No person shall use a barber shop as a dormitory, nor shall any owner or any manager of a barber shop permit said shop to be used for sleeping purposes.

SEC. 17. Any person violating any of the provisions of these regulations shall, upon conviction thereof, be fined not more than twenty-five dollars for the first offense, and upon conviction for a second or subsequent offense, the court in addition thereto may revoke said license or imprison such person in the county jail for a period of not exceeding thirty days, or both.

SEC. 18. The owner and the manager of any barber shop, and each of them, shall keep a copy of these regulations, to be furnished by the City Controller, posted in a conspicuous place in said shop for the information and guidance of persons working or employed therein. The City Controller is hereby authorized to have printed copies of these regulations and supply owners or operators of barber shops with copies thereof.

SEC. 19. The word "barber" as used in these regulations means any person who shaves, or trims the beard, or cuts or dresses the hair of any other person for pay, and includes barbers, hair dressers, apprentices and shop boys. The word "manager" means any person having for the time being control of the premises and of persons working or employed therein.

SEC. 20. This ordinance shall take effect and be in force from and after its passage and approval by the Mayor and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation, printed and published in the City of Indianapolis, Indiana.

By Mr. Denny:

Special Ordinance No. 1—1910: An ordinance providing for the name of the street running north and south between Meridian and Pennsylvania streets, from Georgia street to Louisiana street, in the City of Indianapolis, and fixing a time when the same shall take effect.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, That the street running north and south between Meridian and Pennsylvania streets from Georgia street to Louisiana street, in the City of Indianapolis, be and the same is hereby named and shall in the future be known as Scioto street.

SEC. 2. Whereas, an emergency exists for the immediate taking effect of this ordinance, the same shall be in full force and effect from and after its passage.

Which was read a first time and referred to the Committee on Public Improvements.




