DEAR SIR: The Board of Park Commissioners would respectfully re-

This is a wall that was planned to be built three years ago when it had become evident that the action of Fall Creek during time of high water was washing the bank away. At that time an appropriation of \$7,000 was made to cover the estimated cost of constructing the wall, but bids received by the Board of Park Commissioners were higher than the amount appropriated, with the result that the wall was not built, and the sum appropriated reverted to the city's general fund. During recent high water a bad wash has developed in the bank at about this point, which threatens to undermine the boulevard payement unless a retaining wall be built.

General Ordinance No. 19-1910: An ordinance requiring railroad companies to maintain street lights at street crossings in the City of Indianapolis, where such companies run a car, engine, or train of cars over any street in the night time, providing for a penalty for the violation thereof, repealing all ordinances in conflict herewith, and fixing a time when the same shall take effect.

SECTION I. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That it shall hereafter be the duty of every railroad company running and operating a railroad through the City of Indianapolis, or through any part of said city, to keep and maintain an electric light at every point where the main track of said railroad company, upon which it runs any car, engine or train of cars during the night time, crosses or intersects at grade any public street in said city. Such electric light shall be of sufficient power to light the crossing of such railroad where it is placed and maintained, in such a manner as to enable citizens and other persons traveling and passing over such crossing to see the track or tracks and protect themselves from the danger of running trains on such railroad: *Provided*, Such light shall not be required to exceed in power those now in use for lighting the streets of said city.

SEC. 2. All lights provided in Section I hereof shall be kept lighted and burning during the hours of night time of every day in the year, beginning at thirty minutes after sunset and continuing to burn until thirty minutes before sunrise, of each day in the year.

SEC. 3. It shall be the duty of the City Clerk of said city to give such railroad companies notice of the requirements of this ordinance, within five days after the passage of this ordinance; which notice shall be served in the same manner as it is provided by law that summons in civil actions shall be served upon railroad companies.

SEC. 4. Any railroad company failing to place and maintain a street light at any street crossing as herein provided shall, upon conviction thereof be fined in any sum not exceeding fifty dollars (\$50.00), and each day that any such railroad company violates the provisions of this ordinance shall constitute a separate offense.

SEC. 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEC. 6. This ordinance shall be in full force and effect at the expiration of 60 days after its passage and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation, printed and published in the City of Indianapolis.
