INDIANAPOLIS, IND., July 8, 1910.

To the President and Members of the Common Council:

GENTLEMEN: Your Committee on Ordinances, to which was referred General Ordinance No. 42, 1910, entitled "An ordinance to regulate the use of carts, drays, hackney-coaches, omnibuses, automobiles, and every description of carriages and vehicles kept for hire or livery purposes, or solicited for transacting the business thereof, and street cars, and all other vehicles drawn or propelled by motive power, on certain streets of the City of Indianapolis," have had the same under consideration and respectfully report said ordinance back to the Council with the recommendation that the same be amended as follows: By striking out of and from Section 4 of said ordinance the following words: "heavily laden wagons, trucks, drays, gravel wagons, brick wagons," and inserting in lieu thereof the following words: "all heavy wagons, trucks, drays or other vehicles used for carrying heavy loads;" and also by striking out of and from Section 4 of said ordinance the following words: "except when delivering goods on this street," and by inserting in lieu thereof the following words: "except when delivering or calling for goods on said Washington street between said Senate avenue and Alabama street, and in such cases, said vehicles shall enter and leave said portion of Washington street at the nearest street crossing to the places of destination of such vehicles;" and that the following be added to said ordinance, namely: "SEC. 12. This ordinance shall be in full force and effect from and after its passage and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation printed and published in said city."

And we recommend that when said ordinance is so amended, the same do pass.
