ORDINANCES ON SECOND READING

Mr. Nicholson called for General Ordinance 22, 1929, for second reading. It was read a second time.

Mr. Harris presented the following written motion to amend General Ordinance 22, 1929:

Indianapolis, Ind., May 9, 1929.

Mr. President:

I move that General Ordinance No. 22, 1929, be amended to read as follows:

GENERAL ORDINANCE 22, 1929
(As Amended)

AN ORDINANCE amending General Ordinance No. 24, 1928, and all ordinances amendatory thereof and supplemental thereto, and fixing a time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That General Ordinance No. 24, 1928, establishing Daylight Saving Time in the City of Indianapolis from the second Sunday in May until the last Sunday in October, together with all ordinances amendatory thereof and supplemental thereto, be and the same is hereby amended so that for the year 1929, said Daylight Saving Time shall not take effect until Two (2) o'clock a. m., on the second Sunday of June.

Section 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

The motion to amend was seconded by Mr. Nicholson, and passed by the following roll-call vote:

Ayes, 5, viz: Mr. Harris, Mr. Meurer, Mr. Nicholson, Mr. Springsteen, President Raub.

Noes, 4, viz: Mr. Buchanan, Mr. Lieber, Mr. Rathert, Mr. White.

On motion of Mr. Nicholson, seconded by Mr. Harris, General Ordinance 22, 1929, as amended, was ordered engrossed, read a third time, and placed upon its passage.

General Ordinance 22, 1929, was read a third time by the Clerk, as amended, and passed by the following roll-call vote:

Ayes, 6, viz: Mr. Buchanan, Mr. Harris, Mr. Meurer, Mr. Nicholson, Mr. Springsteen, President Raub.

Noes, 3, viz: Mr. Lieber, Mr. Rathert, Mr. White.

Mr. Springsteen called for General Ordinance 25, 1929, for second reading. It was read a second time.

Mr. Springsteen presented the following written motion to amend General Ordinance 25, 1929:

Indianapolis, Ind., May 9, 1929.

Mr. President:

I move that General Ordinance No. 25, 1929, be amended by inserting after the word "any" in line 3 of Section B-715 the following words: "Lot or parcel of ground on which is located a," and inserting after the word "any" in line 5 of Section B-715 the words, "Lot or parcel of ground on which is located a."

General Ordinance 25, 1929, was read a third time by the Clerk, as amended, and passed by the following roll-call vote:

Mr. Harris, with the consent of the Council, withdrew his motion to amend Appropriation Ordinance 4, 1929, as presented at the Regular Meeting, May 6 (see Page 209). Mr. Harris then presented the following written motion to amend Appropriation Ordinance 4, 1929:

Indianapolis, Ind., May 9, 1929.

Mr. President:

I move that Appropriation Ordinance No. 4, 1929, be amended by striking out the words "Eleven Thousand" in the fifth line and substituting therefor the words "Five Thousand."

Section 2. Striking out the words "Eleven Thousand" in the fifth line of this section and inserting in lieu thereof the words "Five Thousand," and by adding after the phrase "stop signs" wherever it appears the words "complete with base."

Mr. Meurer, Mr. Nicholson, Mr. Rathert, Mr. Springsteen, Mr. White, and President Raub.

Mr. Springsteen called for Resolution No. 3, 1929, for second reading. It was read a second time.

On motion of Mr. Springsteen, second by Mr. Rathert, Resolution No. 3, 1929, was ordered engrossed, read a third time, and placed upon its passage.

Resolution No. 3, 1929, was read a third time by the Clerk, and passed by the following roll-call vote:

Ayes, 9, viz: Mr. Buchanan, Mr. Harris, Mr. Lieber, Mr. Meurer, Mr. Nicholson, Mr. Rathert, Mr. Springsteen, Mr. White and President Raub.

MISCELLANEOUS BUSINESS

The Council next considered the appointment of a Trustee for Utilities for the City of Indianapolis, pursuant to the request of the Mayor presented at the meeting of May 6th (see page 199).

Mr. Harris nominated Mr. A. Dallas Hitz. The nomination was seconded by Mr. Buchanan.

Mr. Nicholson moved that the nominations be closed. The motion was seconded by Mr. Buchanan.

Mr. Hitz was appointed as Trustee for Utilities by the following roll-call vote:

Ayes, 9, viz: Mr. Buchanan, Mr. Harris, Mr. Lieber, Mr. Meurer, Mr. Nicholson, Mr. Rathert, Mr. Springsteen, Mr. White, and President Raub.

On motion of Mr. White, seconded by Mr. Harris, the Common Council adjourned at 9:20 P. M.
