This is an emergency request due to the overthrow of the Manager Law, necessitating the employment of two sheriffs in each precinct instead of one; the use, repair and delivery of voting machines instead of paper ballots; the increase of Election Board officials due to the Council's increase of fifteen precincts, and other miscellaneous items enumerated in the ordinance which are self-explanatory.

While the Election Board is authorized by law to make these expenditures regardless of appropriation, it is the desire of the present Board to conform to the budget law so far as it is practicable.

INTRODUCTION OF GENERAL ORDINANCES

By Board of Works:

GENERAL ORDINANCE 84, 1929

AN ORDINANCE, regulating the use of public streets, alleys and bridges by motor vehicles and trailers, providing the maximum weights, loads and widths of such vehicles; authorizing special permits in case of weight and width exceeding the prescribed weights and widths; providing penalties for its violation and fixing a time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That, except as hereinafter otherwise provided, no motor vehicle, truck, trailer or semi-trailer, or combined unit of motor vehicle, or truck having four wheels or less, the gross weight of which, including the load, is more than twenty-eight thousand (28,000) pounds; and no motor vehicle or truck having a greater weight than twenty-two thousand four hundred (22,400) pounds on any one axle; and no motor vehicle, truck or trailer, having a greater weight than eight hundred (800) pounds per inch width of tire upon any wheel concentrated upon the surface of the highway, such width, in the case of rubber tires, to be measured between flanges of the rim; shall be used or operated upon any of the public streets, alleys or bridges of the City of Indianapolis.

That, except as hereinafter otherwise provided, no motor vehicle, truck, trailer or semi-trailer, or combined unit of motor vehicle or truck having four wheels or less, the width of which, including accessories, tires, body and any load thereon, is more than nine (9) feet, measured horizontally through any section of the above described vehicles, shall be used or operated upon any of the public streets, alleys or bridges of the City of Indianapolis.

In special cases of the above described vehicles, the gross weight of which, including the loads, shall exceed the respective weights hereinbefore prescribed, or the overall width of the above described vehicles shall exceed the width hereinbefore prescribed may be used or operated upon certain designated public streets, alleys and bridges under special permits granted as hereinafter provided.

Section 2. The special permit herein required for the operation of a motor vehicle, truck or trailer, the weight, including the load and width of which exceeds the limits prescribed in this ordinance, shall be in writing and shall be issued by and at the discretion of the Board of Public Works of the City of Indianapolis. The permit shall be issued for either a single trip or for one year, but not beyond the date of expiration of the registration of such vehicle. The permit shall state the weight, width, state license number and owner of motor vehicle, also streets to be used and the time limit for which it is issued. The permit shall be issued to the applicant when bond has been deposited in the office of the Board of Public Works. This permit shall be obtained before such vehicle is used on any street, alley or bridge.

Whenever any applicant shall present to the Board of Public Works his application for a single trip permit, to operate a motor vehicle, truck or trailer, the weight including load or width, of which exceeds the limits prescribed in this ordinance, he shall furnish to such Board a good and sufficient bond with surety to the satisfaction of said Board in the sum of Five Hundred (\$500.00) Dollars, conditioned upon the strict compliance with the terms of said permit as to route to be taken and time limits of trip, and to repair or compensate for repairs of any pavement, sidewalk, curb or sewer catch basin or manhole, etc., which might be damaged, and to pay all damages whatsoever occasioned by said trip.

Said bonds to be released by the Board of Public Works when any damages which might have occurred have been settled.

Whenever any applicant shall present to the Board of Public Works his application for a yearly permit to operate a motor vehicle, truck or trailer, the weight including load or width, of which exceeds the limits prescribed in this ordinance, he shall furnish to such Board a sufficient bond with surety to the satisfaction of said Board in the sum of Five Thousand Dollars (\$5,000.00), conditioned upon the strict compliance with the terms of said permit as to route to be taken, repairs or compensation for repairs for any pavement, sidewalk, curb, sewer catch basin or manhole, etc., which might be damaged and to pay all damages whatsoever occasioned by said vehicle for the year period, as issued by permit.

Said bond to insure repairs at any time when ordered by the Board of Public Works before the expiration of the bond, and shall be released by said Board when all damages which might have occurred have been settled.

Section 3. For the purpose of preventing undue injury to the city streets, alleys and bridges of the City of Indianapolis, the Board of Public Safety of the City of Indianapolis, through its Police Department, shall have the power to order entered of record to enforce this ordinance by checking the weights and widths of any vehicle, truck or trailer hereinbefore described at any time on any street at the Board's discretion and no motor vehicle, truck or trailer shall be operated over any street, alley or bridge in the City of Indianapolis in violation of this ordinance. For the same purpose hereinbefore mentioned, the Board of Public Works of the City of Indianapolis, shall have the power by order entered of record to issue or refuse to issue the permits hereinbefore prescribed and control the maximum weight and width of any motor vehicle, truck or trailer and the load transported thereby.

Section 4. It shall be unlawful for the owner or operator of any such vehicle to use any street, alley or bridge, whose weight or width exceeds the limits as designated hereinbefore or who violates the condition as stated on the permit, without a permit which must be carried upon the person at all times while operating the vehicle and shown to any officer empowered to enforce this ordinance.

Section 5. Any person, firm, co-partnership or corporation who shall violate any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any sum not less than ten dollars (\$10.00) nor more than three hundred dollars (\$300.00).

Section 6. The terms of this ordinance shall not apply to any of the public highways or bridges within the City of Indianapolis under the jurisdiction of or controlled by the State Highway Commission of the State of Indiana, nor upon any boulevard under the jurisdiction of the Park Board of the City of Indianapolis, nor to any vehicle of the Police or Fire Departments, nor to any ambulance or vehicle of any hospital or any vehicle owned or operated by the City of Indianapolis, while being used in their respective lines of duty.

Section 7. This ordinance shall take effect from and after its passage, approval by the mayor and publication according to law.

Section 1. That the sum of Seven Hundred Eighty-five Dollars (\$785.00), now in the City Controller's Fund No. 51, Interest and Exchange, be and the same is hereby transferred therefrom and re-appropriated to Board of Public Works Administration Fund No. 26, Other Contractual.

Section 2. This ordinance shall take effect from and after its passage, approval by the mayor and publication according to law.

AN ORDINANCE authorizing the sale, alienation and conveyance of certain real estate by the Board of Public Works of the City of Indianapolis, and fixing a time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the Board of Public Works of the City of Indianapolis be and is hereby authorized to sell, alienate and convey for cash, at public or private sale, for not less than the appraised value, which value is to be hereinafter determined by appraisers appointed by the judge of the Circuit Court of Marion County, Indiana, as required by law, of the following described real estate in Indianapolis, Marion County, Indiana, to-wit:

Lots Nos. 14, 15, 16 and 44 in Yandes Subdivision of Outlot 130 in the City of Indianapolis, together with improvements thereon.

That said real estate shall be sold at public or private sale, upon such notice or notices as the Board of Public Works may determine.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.
