Messrs Woodward, Pitts & Culley were appointed said committee.

March 31, 1851

Council met. present Messrs Loudon, Edwards, Buchanan, Durham, Pitts, Woodward, and Culley, President.

Minutes read and approved.

The President stated the object of the meeting to be to take into consideration the propriety of altering the plan and specification of the City School houses presented by the committee appointed to receive bids upon said work. But before proceeding to the consideration of the subject,

On motion of Mr. Pitts

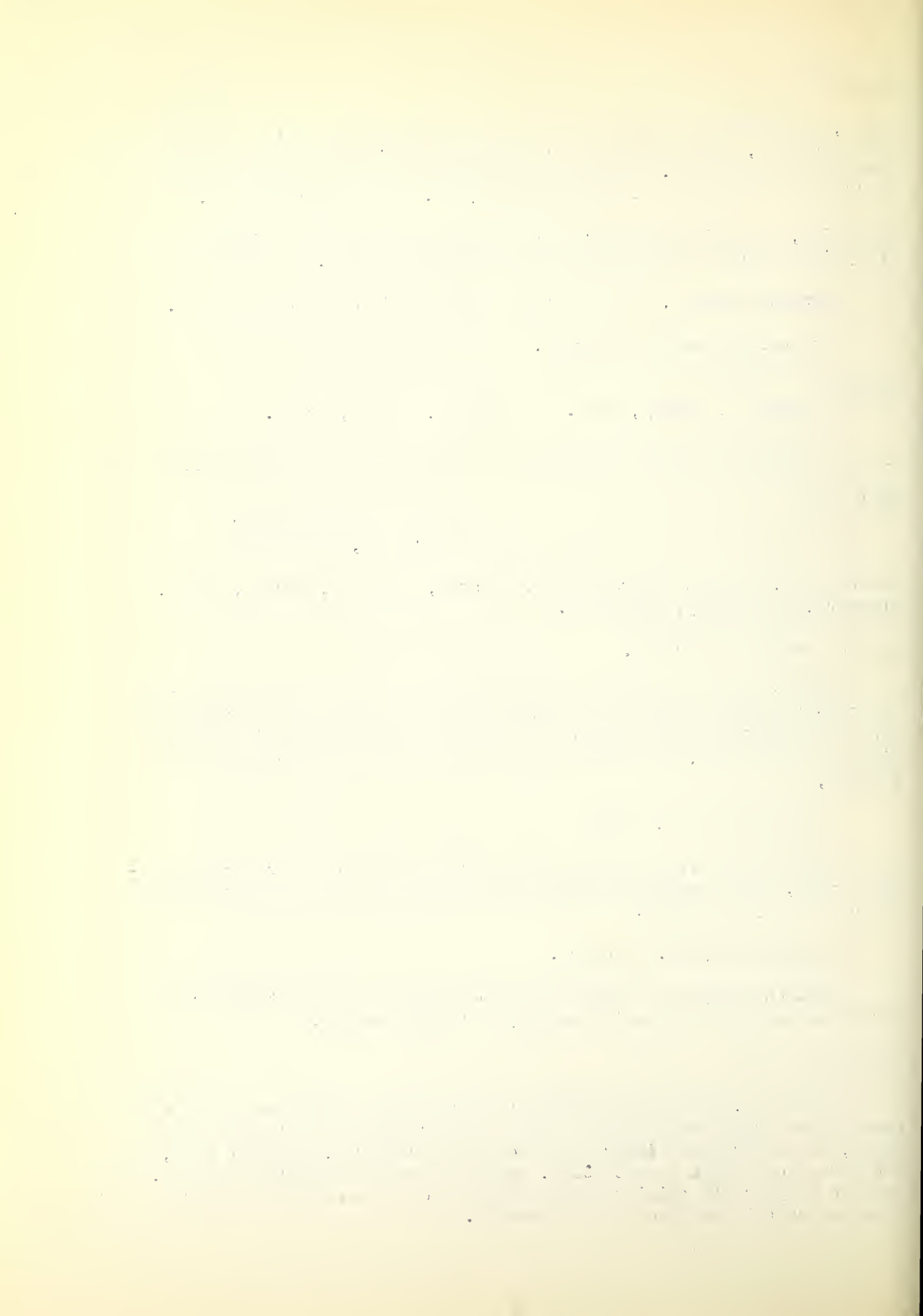
"The Committee on City Schools were instructed to procure a suitable table, and a sufficient number of chairs for each and every school house built by the city".

On motion by Mr. Woodward.

Mathew Tracy upon payment of five dollars to city Treasurer be permitted to peddle goods in the city for three months."

On motion it was

"Resolved, That the committee on Streets and alleys be directed to examine the bridge over Pogue's Run at the crossing of Meridian Street South, and ascertain whether the same can be repaired, and made safe, or whether a new bridge is necessary. And if it can be repaired to do so, but in case they are of opinion that a new bridge is necessary to advertise for bids and report the same to this Council.



Oliver Rice's acc/t for repairing well in 3d Ward amounting to \$7.00 was, on motion, referred to committee on wells.

On motion, the following resolution with the preamble was adopted:

"Whereas This Council is of opinion that the brick walls of the house fronting next to the alley forming part of the house lately occupied by Messrs Tomlinson as a Drug Store, and destroyed by the late fire, is in a dangerous condition, and likely to fall, thereby endangering life, therefore

"Ordered That the Marshal notify said Tomlinson to take down or secure said walls immediately and in the event they fail or refuse so to do to cause the same to be secured or pulled down, as may be thought best, at the expense of the owners of said property."

On motion by Mr. Buchanan, the following preamble and resolution was adopted.

"Whereas The damages done by Railroad is mainly owing to the depth of cut or height of embankment caused by said road, therefore

"Resolved That the Central Railroad and the Lawrenceburg and Cincinnati Railroad (Companies) be required to furnish the City Engineer with the grade of said Road as far as they are located in this city. And that the City Engineer be requested to examine said road and ascertain whether that portion of the city

can be graded to conform to the grade of said road and report the same to the Council at as early a period as possible".

On motion by Mr. Edwards,

"The committee, appointed to receive bids for School House were instructed to receive bids on the plan and specification presented, with the understanding that the City Council reserves to itself the privilege of making such alterations or amendments as may in their judgment be proper and right".

On motion Council adjourned
