GENERAL ORDINANCE NO. 66, 1963

AN ORDINANCE amending General Ordinance No. 52, 1963, prohibiting trucks of 20,000 lbs. or over, gross weight, from using certain sections of Franklin Road and 38th Street.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA

Section 1. Section 4-1303 of the City Code of Ordinances, General Ordinance No. 140, 1951, as amended, be amended by adding a new sub-section to Franklin Road, as follows:

Sub-Section (3). Heavy Trucks prohibited in certain Areas: All trucks having a gross weight with load in excess of 20,000 lbs.

are hereby prohibited from the use of any of the following streets located in the City of Indianapolis.

Section 2. Any person, firm or corporation violating the provisions of this Ordinance and section of the Code, shall be subject to the penalties provided in Section 4-1309 of General Ordinance No. 140, 1951, as amended.

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication as by law required, and upon Posting of Notice of such ban on such streets.
