BE IT RESOLVED by the Common Council of the City of Indianapolis that said Common Council and said City desire to have a civic center erected by the Indianapolis-Marion County Building Authority pursuant to Chapter 169 of the Acts of the Indiana General Assembly for the year 1963 (Regular Session) and Chapter 54 of the Acts of the Indiana General Assembly for the year 1953, and all acts amendatory thereof and supplemental thereto.

BE IT FURTHER RESOLVED that a copy of this resolution be certified to the Board of Directors of the Indianapolis-Marion County Building Authority and to the Auditor of Marion County.

BE IT FURTHER RESOLVED, that the Auditor of Marion County be requested and directed, upon receiving a similar resolution of the Board of Commissioners of Marion County, to cause a notice to be published as provided by law of a hearing to be held by the Board of Commissioners of Marion County and the Common Council of the City of Indianapolis on the question of whether the public interest will be promoted by the construction of a civic center.

BE IT FURTHER RESOLVED, that the Common Council of the City of Indianapolis, on behalf of the citizens of this City, extend its sincere sympathy and condolences to the family of PRESIDENT JOHN FITZGERALD KENNEDY.

BE IT FURTHER RESOLVED, that this Resolution be spread of record in the Journal of the Common Council of the City of Indianapolis and that a copy of this Resolution be forwarded to MRS. JOHN FITZGERALD KENNEDY, widow of the late President.
