BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City of Indianapolis, Indiana, be and the same is hereby extended so as to include the following described territory, which is hereby annexed to and made a part of the terri-

tory, constituting the City of Indianapolis, Indiana, and described as follows, towit:

A part of the Northeast Quarter of Section 23, and a part of the Southeast Quarter of Section 14, all in Township 16 North of Range 2 East in Marion County, Indiana, being more particularly described as follows, towit:

Beginning at a point on the Existing Corporation Line of the City of Indianapolis, Indiana, said point being the Intersection of the West line of High School Road and the North line of West 34th Street running thence West upon and along said Corporation line approximately 1,615 feet to the Intersection of the North right of way line of West 34th Street and the West right of way line of Interstate Highway #465; running thence North approximately 2,635 feet upon and along said West line and its extension North to the Intersection of said West right of way and the North right of way line of West 38th Street as extended West from High School Road, thence East upon and along said North Right of Way line approximately 1,556 feet to the West right of way line of High School Road, said point being on the present Corporation Line of the City of Indianapolis; running thence South upon and along said Corporation Line a distance of approximately 2,700 feet to the point of beginning. Containing 99 acres, more or less.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication according to law.

INTRODUCTION OF SPECIAL RESOLUTION

SPECIAL RESOLUTION NO. 2, 1964

WHEREAS, few changes and improvements have been made in the methods and techniques of collecting garbage and trash in the City of Indianapolis in recent years, and,

WHEREAS, the City continued to grow in population and has experienced rising costs of these Sanitary Department operations.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a study commission be appointed to consist of the present Board of Sanitary Commissioners, two Democrat and one Republican City Council members, and two private citizens appointed by the Mayor—such members to serve without compensation.

Section 2. That the sum of \$5,000 be appropriated from funds of the Sanitation Department for the employment of such clerical and technical staff as may be necessary to study garbage and trash collection techniques.

Section 3. The study shall include but not be limited to: the feasibility of ordinances requiring the installation of garbage disposers on all new construction inside the City; the cost of dismantling the garbage collection department and equipment; the cost of providing garbage disposers to each home residence inside the City at City expense, or as a credit against the real taxes of such property, or as a Barrett law assessment against each property; the amount of reduction in Sanitary Department operations that the elimination of garbage collection might produce new and additional sites for the disposal of trash; how existing eyesore sites might be trash filled to reclaim usable land; then need for additional dumping facilities; and the adequacy of fees for private dumping.

Section 4. The study commission is to make a written report to the Mayor and each member of the Common Council on or before July 1, 1964.

Mr. McGill moved that the Council strike General Ordinance No. 12, 1964 from the records. Mr. Moriarty seconded the motion.

The Clerk called the roll and the motion passed by the following vote:

On motion of Mr. Hasbrook seconded by Mr. Deluse the Council adjourned at 8:40 P.M.
