INTRODUCTION OF GENERAL ORDINANCES

GENERAL ORDINANCE NO. 88, 1964

Introduced by Councilman McGill:

AN ORDINANCE authorizing the Board of Public Works of the City of Indianapolis to purchase through its duly authorized Purchasing Agent, certain services to be paid for out of funds heretofore appropriated or available, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Works of the City of Indianapolis be and the same is hereby authorized and empowered to purchase through its duly authorized Purchasing Agent, the hereinafter designated services to be used by the Department, as indicated. The said services are to be purchased from the lowest and best bidder, or bidders, whose bids have been received and opened in public by said Board after advertisement therefor, as provided by law, and the total cost of said services shall not exceed the sum of money heretofore appropriated or available for the use of said Board.

BOARD OF PUBLIC WORKS Municipal Garage

Reqn. No. 7725—Repairs to roof at the Municipal Garage __\$3,261.90

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read for the first time and referred to the Committee on Works.

ORDINANCES ON SECOND READING

Indianapolis, Indiana, August 17, 1964

Mr. President:

I move that General Ordinance No. 83, 1964 be amended by inserting in Line 12 of Section 1, after the words "fire vehicles" the following: "official motor vehicles of City, County and State and any other type of motorized equipment used by them while and where actually engaged in authorized work upon the surface, or any other portions, or appurtenances to a highway, except that all such persons shall exercise reasonable care to avoid injury to any persons, or damage to any property."

On motion of Mr. Deluse, seconded by Mr. McGill, General Ordinance No. 87, 1964 was ordered engrossed, read for a third time and placed upon its passage. The Clerk read the Ordinance for a third time and it passed on following roll call vote:

Mr. Brydenthal called for a second reading of Special Ordinance No. 12, 1964. The Clerk read the Ordinance for a second time.

Mr. Hasbrook offered an amendment as follows:

Indianapolis, Indiana, August 17, 1964

Mr. President:

I move that Special Ordinance No. 12, 1964 be amended by adding after the words "professional strikebreakers" in the second line of the first paragraph of Special Ordinance No. 12, 1964 the words "OR PICKETS."

By adding after the word "strikebreakers" in the last line (9th) of Section 1 the words "OR PICKETS."

By adding in the first line of Section 2 after the word "firm" the words "LABOR UNION" and adding after the word "firm" in the sixth (6th) line of Section 2 the words "LABOR UNION."

By adding after the word "firm" in the first line of Section 3 the

words "LABOR UNION" and after the word "firm" in the seventh line of Section 3 of the words "LABOR UNION."

By adding after the word "firm" in the first line of Section 6 the words "LABOR UNION."

THOMAS C. HASBROOK, Councilman

Mr. Kuydendall moved that Special Ordinance No. 12, 1964 be tabled for further study.

This motion was seconded by Mr. Deluse and passed on the following roll call vote:

Ayes 6 viz: Mr. Deluse, Mr. Hasbrook, Mr. Egenes, Mr. Kuykendall, Mr. Moriarty and President Wallace.

Noes 3 viz: Mr. Brydenthal, Rev. Cummings, Mr. McGill.

Mr. Brydenthal suggested President Wallace send a letter to Metropolitan Plan Commission assuring them of Council support in their fight against violations.

On motion of Mr. Kuykendall, seconded by Mr. Deluse the Council adjourned at 8:23 P.M.
