

PROCEEDINGS OF BOARD OF ALDERMEN.

REGULAR SESSION—MAY 12, 1880.

The Board of Aldermen of the City of Indianapolis for the year 1880-1881, convened in first regular session, in the Aldermanic Chamber, on Wednesday evening, May 12th, A. D. 1880, at eight o'clock.

For the current year, the Board of Aldermen will consist of the following Members:

George T. Breunig, Clerk, called the Board to order, and stated that all the members elect had duly qualified as Aldermen; said Clerk then called the roll, which showed all the members of the new Board to be in attendance, except Aldermen Drew and Wood.

On Alderman Seibert's motion, Alderman Layman was called to the Chair as temporary Chairman.

Chairman Layman stated that the first business in order would be the election of President and President *pro tempore* for the ensuing year; that nominations for the aforesaid offices should now be made.

For President—Alderman Grubbs nominated Alderman Henry Coburn.

No other nomination being made, the Clerk was instructed to cast the unanimous vote of the Board for said nominee.

Alderman Henry Coburn having thus received eight votes, Chairman Layman declared that said gentleman had been duly elected President of the Board of Aldermen for the ensuing year.

For President *pro tempore*—Alderman Hamilton nominated Alderman James T. Layman.

No other nomination being made, the Clerk was instructed to cast the unanimous vote of the Board for said nominee.

Alderman James T. Layman having thus received eight votes, His Honor, President Coburn, declared that said gentleman had been duly elected President *pro tempore* of the Board of Aldermen for the ensuing year.

The Board of Aldermen having been thus duly organized, His Honor, the President, declared said body was prepared for the transaction of such business as might be brought before it.

The Proceedings of the Board of Aldermen, for the adjourned session, held on May 3d, and for the regular session, held on May 5th, 1880, having been printed, and placed on the desks of the Aldermen, said Journals were approved as published.

Gentlemen:—Your Committees on Contracts, to whom was referred sundry proposals, presented to Council, April 19th, 1880, have examined the same, and find them to be as follows, to-wit:

1st. For grading and graveling the alley between Park avenue and Broadway street, from Cherry street to Christian avenue

Gentlemen.—I have been directed by your honorable bodies to prepare an amendment to the Salary Ordinance of 1879, fixing the pay of Deputy City Assessors at \$1.75 per day, instead of \$1.50 per day, as provided in said ordinance. In view of the fact that the year is so near out, and as you have, by resolution, concurrently adopted, fixed the pay of said employees at \$1.75, I have thought it proper to suggest that the pay and per diem of said employees might be fixed and provided for in the regular appropriation ordinance. This would be sufficient, and would save the necessity of amending the old ordinance.

The following entitled ordinance was read the second and third times:

S. O. 43, 1880—An Ordinance to provide for grading and bowldering the northwest gutter, and curbing with stone the outer edge of the northwest sidewalk, of Fort Wayne avenue, from St. Marys street to St. Joseph street.
