Gentlemen:

The recent disclosure that the Indianapolis Common Council, under Chapter 107 of the acts of 1959, has the authority to establish salaries of the members of the Indianapolis fire and police departments brings with it additional responsibilities.

May we recommend that the Council appoint a committee as soon as possible to study the entire problem of police and firemen's salaries so at next year's budget hearing these salaries can be established with a minimum of negotiation or trouble.

The committee could give consideration to a program of tying the salary schedule to the cost of living index after such salaries have been established on a just and fair basis.

To build up the interest and capacity of the individual members of these departments, consideration could be given to the program in Oakland, California, where upon completion of certain police science courses the pay of the individual members of the department is increased on a sliding scale from five to 10 percent, according to how they qualify. Tacoma, Washington, has instituted a similar program for all city employees and there are probably other cities in the country that could be checked upon by the committee for further information.

Section 1. That Title 4, Chapter 8, Section 4-832, of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the deletion and repeal thereof of subsection 1, as follows:
