

# PROCEEDINGS OF BOARD OF ALDERMEN

REGULAR SESSION—JANUARY 14, 1889.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Monday evening, January 14th, A. D. 1889, at 7:30 o'clock, in regular session.

The report from the Chief Fire Engineer, appointing Jas. H. Davis and A. C. Muerer first and second assistants (see page 13, *ante*), was read, and the action of the Common Council thereon, was concurred in.

The following resolution (see page 14, *ante*), was read :

*Resolved by the Common Council and Board of Aldermen of the City of Indianapolis,* That there be, and is hereby, assessed and levied upon all real estate, personal, and real property, notes, bonds, stocks and choses in action, in the City of Indianapolis, Indiana, assessed and returned for taxation in and for said city, for the year 1888, a tax for general city purposes of ninety (90) cents upon each one hundred dollars (\$100) valuation of all such property, and the further sum of fifty cents on each poll, for general purposes.

*And Resolved further,* That the Auditor of Marion county, Indiana, be, and he is hereby, requested, authorized and directed, to place said taxes upon the proper tax duplicate, and the County Treasurer of Marion county, Indiana, be, and he is hereby, directed to collect the same for said City of Indianapolis, and make due report thereof.

And it was concurrently adopted, by the following vote :

The annual report from the Secretary of the Board of Health (see page 16, *ante*), was read and received.

The report of the City Clerk, relative to the appointment of City Commissioners, (see page 18, *ante*), was read and received.

The report from the Committee on Public Light and City Attorney, relative to the expiration of vapor light contract, (see page 18, *ante*), was read and received.

The following report and resolution from the Committee on Public Light, (see page 19, *ante*), was read :

To the Mayor, Common Council and Board of Aldermen:

*Gentlemen:*—Your Committee on Public Light, to whom was referred sundry motions, would respectfully submit the following :

We would recommend the passage of S. O. 144, which we herewith return to the files. We recommend that the following gas lamps be re-mantled: Lamp-post in front of 426 Indiana avenue; lamp-post at the mouth of the first alley north of Bicking street, on the south side of East street; lamp-post on the south side of Market street, between East and Liberty streets; lamp post on the north side of Market street, between Liberty and Noble streets. That the lamp-post located 80 feet north of Ninth street, be located at the northeast corner of Ninth street and Central avenue, under the direction of the Street Commissioner.

We would further recommend the passage of the following resolution :

*Resolved*, That the Sun Vapor Light Company be instructed to erect, under the direction of the City Civil Engineer, lamp-posts as follows: Four on Summit street; one on Herman street; four on Chadwick street; four on Carlos street; four on south Tennessee street, between Ray and Morris streets; four on Douglass street; two on Valley street, and three on Lexington avenue.

That Dr. S. E. Earp have charge of the Sanitary affairs of the city pending the settlement of the questions involved in the resolution just referred to the Judiciary Committee.

The report from the Committee on Public Property, reporting pay-roll for work done in Garfield Park (see page 20, *ante*), was read, and the action of the Common Council thereon, concurred in.

The report from the Committee on Railroads (see page 20, *ante*), was read, and the action of the Common Council thereon, concurred in.

The report from the Rental Committee (see page 20, *ante*), was read and received.

The following motion (see page 22, *ante*), was read, and referred to the Committee on Public Property :

That the City Civil Engineer be, and is hereby, instructed to set the proper corner stakes on Beacon street, from Bloomington street so Decatur street, so as to get the correct width of the street. Some of the property owners claim a seventy-five foot street, while others claim a sixty foot street.

The following proposition (see page 23, *ante*), was read, and referred to the Committee on Finance.

Resolved, That the Citizens' Street Railroad Company be, and is hereby, ordered to take up their turn-table on north Illinois street, in the neighborhood of Tenth street, and to make regular trips to Twelfth street—the same to be done in ten days after the passage of this resolution; if not done within that time, the Street Commissioner to do the same, and charge the expense to the above company. The City Clerk is hereby ordered to prepare and serve on said company a certified copy of this resolution.

Alderman Laut moved to refer to the Committee on Railroads.

Alderman Connett moved to lay the motion to refer, on the table.

Which motion failed of adoption, by the following vote :

AYES, 5—viz: Aldermen Connett, Smith, Taylor, Tousey, and President Wright.

NAYS, 5—viz: Aldermen Clark, Laut, Rail, Reinecke, and Reynolds.

Alderman Taylor moved to refer to the Committee on Finance.

Alderman Tousey moved to lay the motion on the table.

Which motion failed of adoption, by the following vote :

On motion by Alderman Connett, the action of the Common Council was concurred in, and the resolution concurrently adopted, by the following vote :

The following resolution (see pages 23 and 24, *ante*), was read :

WHEREAS, There seems to be no further use for the railroad track on Seventh street, between Illinois and Pennsylvania streets, and the same being not used and no connection is made with any other track; therefore

*Resolved*, That the City Clerk be, and is hereby, ordered and directed to serve a certified copy of this resolution on said company to remove the above tracks within thirty days after the passage of this resolution. If not done at the expiration of the above time, the Street Commissioner to do the same, and charge the expense to the above company.

Alderman Laut moved to refer to the Committee on Railroads.

Alderman Connett moved to lay the motion on the table.

Which motion failed of adoption, by the following vote :

AYES, 5—viz: Aldermen Connett, Rail, Smith, Taylor, and Tousey.

NAYS, 5—viz: Aldermen Clark, Laut, Reinecke, Reynolds, and President Wright.

On motion, the resolution was then referred to the Committee on Railroads, to report at the next meeting.

That Henry Clay be given an extension of ninety days in which to complete his contract to improve Ash street, from Lincoln avenue to Irwin street.

That the Street Commissioner be, and is hereby, directed to notify William H. English to repair the sidewalk in front of his property on McCarty street, between Tennessee street und Ann street.

That the Street Commissioner be, and is hereby, directed to notify Joseph V. McKernan to repair the sidewalk in front of his property on McCarty street, between Tennessee street and Ann street.

That Mrs. Stella Anderson be allowed to lay a brick sidewalk in front of her property on Gregg street, between East street and Park avenue, at her own expense, subject to the direction of the City Civil Engineer.

That the County Treasurer be instructed to deposit the five hundred thousand dollar Belt Railroad bonds in a safety deposit.

That tho Board of Police Commissioners be requested to inforce the city ordinances which prohibit the throwing of waste material into the streets and alleys of the city.

The following motions (see pages 26 and 27, *ante*), were read, and referred to the Committee on Streets and Alleys:

That C. M. St. Clair be given permission to construct a driveway across the sidewalk in front of his residence on North street; work to be done at his own expense, under the direction of the City Civil Engineer.

That the Street Commissioner be ordered to lay single stone crossing across Alabama street, on the north side of Wabash street.

The following motion (see page 27, *ante*), was read:

That the Street Commissioner be, and is hereby, ordered to at once comply with the orders from this body, to remove the unused street car tracks on Noble street, between Michigan street and Massachusetts avenue.

And on motion, referred to the Committee on Railroads, by the following vote:

AYES, 6—viz: Aldermen Clark, Laut, Rail, Reineke, Reynolds, and Tousey.

NAYS, 4—viz: Aldermen Connett, Smith, Taylor, and President Wright.

The following message was read, and the ordinance returned to the files of the Common Council:

To the President and Members of the Board of Aldermen:

*Gentlemen:*—At a meeting of tho Common Council held in the Council Chamber Monday evening, January 7th, 1889, the following motions were adopted:

“That the vote by which General Ordinance No. 57, 1888, was passed, be reconsidered”

“That G. O. 57, 1888, be recalled from the Board of Aldermen, and that said ordinance be referred to the Committee on Streets and Alleys and City Attorney, and that they be instructed to report an ordinance at the next regular meeting of this body.”

Alderman Tousey offered the following motion ; which was adopted :

That the Brush Electric Light Company be, and are hereby, ordered to remove the electric light towers on the corners of Pennsylvania and Washington streets; Pennsylvania and Ohio streets, and Illinois and Ohio streets. And that if said towers are not removed within thirty days from the date of the passage of this motion, that the Street Commissioner remove said towers, and collect the cost of said removals from said company. Also, that the City Clerk serve notice of this order upon said company, and notify this body of the date of service of said notice.

The following entitled ordinance, (passed by the Common Council,) was read the first time :

G. O. 58, 1888—An ordinance authorizing Jonathan O. Armour to lay and maintain a switch track across Georgia street and sidewalks, at its intersection with Missouri street.

The following entitled ordinance, (passed by the Common Council,) was read the first time :

G. O. 13, 1888—An ordinance requiring the Ohio, Indiana & Western Railway Company, and the Indianapolis Rolling Mill Company to station and maintain a Flagman at the intersection of their tracks with the Union Railway tracks on Tennessee street, in the City of Indianapolis, and providing a penalty for the violation thereof.

On motion by Alderman Connett, the Rules were suspended for the purpose of placing the above entitled ordinance—G. O. 13, 1888—on its final passage, by the following vote :

AYES, 9—viz: Aldermen Clark, Connett, Laut, Rail, Reinecke, Reynolds, Smith, Tousey, and President Wright.

G. O. 13, 1888, was then read the second and third times.


## PENDING ORDINANCES.

- S. O. 89, 1888—An ordinance to provide for grading and paving with brick, the north sidewalk of Market street, from Highland street to Hanna street.
- S. O. 115, 1888—An ordinance to provide for grading and paving with brick, the north sidewalk of South street, from Missouri street to Kentucky avenue.
- S. O. 118, 1888—An ordinance to provide for grading and paving with brick, the west sidewalk of Archer street, from Michigan street to John street.
- S. O. 122, 1888—An ordinance to provide for grading and paving with brick, the sidewalks of Hoyt avenue, from Linden street to the first alley east of Spruce street.
- S. O. 124, 1888—An ordinance to provide for grading and paving with brick, the north sidewalk of Merrill street, from Madison avenue to Delaware street.
