O. 59, 1888—An ordinance to amend Sections 9 and 10, of General Ordinance No. 2, 1887, entitled "An ordinance supplemental to the ordinance of the City of Indianapolis, on the subject of the general markets of said city; modifying and changing certain rules heretofore existing for the regulation and government of said markets; repealing all conflicting provisions; putting the Market-Masters on salaries, and requiring that all rents and fees of marketers shall be paid into the treasury;" ordained and established March 21st, 1887, and to regulate the time of holding markets.


