

# PROCEEDINGS OF BOARD OF ALDERMEN.

## SPECIAL SESSION—JUNE 19, 1889.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Wednesday evening, June 19th, A. D. 1889, at eight o'clock, in special session, pursuant to the following call:

### ORDINANCES ON SECOND READING.

The following entitled ordinance was read the second time:

G. O. 25, 1889—An ordinance fixing the license fee to be paid to the City of Indianapolis by all persons hereafter or heretofore acquiring license from the Board of Commissioners of Marion County, Indiana, and from all other persons, to sell intoxicating liquors in the City of Indianapolis, or outside of the City of Indianapolis, but within two miles of the corporate limits thereof, as provided for by the Act of the General Assembly of Indiana, approved March 11th, 1889.

### ORDINANCES ON THIRD READING.

The following entitled ordinance was read the third time:

G. O. 25, 1889—An ordinance fixing the license fee to be paid to the City of Indianapolis by all persons hereafter or heretofore acquiring licenses from the Board of Commissioners of Marion County, Indiana, and from all other persons, to sell intoxicating liquors in the City of Indianapolis, or outside of the City of Indianapolis, but within two miles of the corporate limits thereof, as provided for by the Act of the General Assembly of Indiana, approved March 11th, 1889.

And it was passed by the following vote :

AYES, 6—viz: Aldermen Connett, Reynolds, Smith, Taylor, Tousey, and President Wright.

NAYS, 1—viz: Alderman Laut.
