INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, that an ordinance entitled "An ordinance dividing the City of Indiamapolis, Indiana, into six councilmanic districts and (lefining boundaries thereof" being General Ordinance No. 19-1909, ap)proved June S, 1909, be and the same is hereby amended so that the boundaries of the following districts shall be and are hereby established and defined as follows, to-wit:

All that part of said city bounded as follows shall be and constitute the Third District:

## THIRD DISTRICI.

Commencing in the conter line of Alabman Street at its intersection with the center line of Fall Creek; thence in a mortheasterly direction, following the meandering, in the center line of Fall Creek to the center line of 'lhirty-eighth Street extended east to a point, said point being the north line of Section 19, township 1 (; north of range 4 east; thence west with saict line to the center line of the Allisonville Free Gravel Hoad; thence in a northeasterly direction along the center line of the Nlisonville Free Gravel Road to a point, said point being 250 feet north of the north line of said Section 19 , township 16 north of range 4 east: thencer west parallel to and 250 feet morth of the north line of said section 19, township $1(;$ north of range 4 east, to the east right of way line of the ( $:$.
