INTRODUCTION OF APPROPRIATION ORDINANCES.

By City Controller:

Appropriation Ordinance No. 23—1913: An ordinance appropriating the sum of \$6,000.00 to and for the use of the Department of Public Works and fixing a time when the same shall take effect.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the sum of six thousand (\$6,000.00) dollars be, and is hereby appropriated out of any moneys in the City Treasury, not otherwise appropriated, to and for the use of the Department of Public Works, the amount appropriated herein to be added to and form a part of the fund known as "City Civil Engineer Office Accounts."

SECTION 2. This ordinance shall take effect and be in force from and after its passage.

Which was read a first time and referred to the Committee on Finance.

By City Controller:

Appropriation Ordinance No. 24—1913: An ordinance appropriating the sum of \$2,500.00 to and for the use of the Department of Public Works and fixing a time when the same shall take effect.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the sum of twenty-five hundred (\$2,500.00) dollars be, and is hereby appropriated out of any moneys in the City Treasury, not otherwise appropriated, to and for the use of the Department of Public Works, the amount appropriated herein to be added to and form a part of the fund known as "Investigation of Sewage Disposal."

SECTION 2. This ordinance shall take effect and be in force from and after its passage.

Which was read a first time and referred to the Committee on Finance.

#### INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

By Mr. Denny:

General Ordinance No. 46—1913: An ordinance concerning the compensation of Assistant City Civil Engineers and other employes of the office of the City Civil Engineer in connection with the flood emergency engineering work of the City of Indianapolis, Indiana.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, that all assistant engineers and other employes of the office of the City Civil Engineer of the City of Indianapolis, Indiana, in connection with the flood emergency engineering work, shall receive the compensations hereinafter in this ordinance named and fixed for the positions held by each of them respectively.

SECTION 2. Assistant City Civil Engineers shall receive a salary at a rate not to exceed eighteen hundred (\$1,800.00) dollars per annum.

Transitmen shall receive a salary at a rate not to exceed twelve hundred (\$1,200.00) dollars per annum.

Levelers shall receive a salary at a rate not to exceed twelve hundred (\$1,200.00) dollars per annum.

Rodmen shall receive a salary at a rate not to exceed eight hundred forty (\$840.00) dollars per annum.

Chainmen shall receive a salary at a rate not to exceed seven hundred twenty (\$720.00) dollars per annum.

Axemen shall receive a salary at a rate not to exceed seven hundred twenty (\$720.00) dollars per annum.

Chief draftsman shall receive a salary at a rate not to exceed eighteen hundred (\$1,800.00) dollars per annum.

Assistant draftsmen, Class A, shall receive a salary at a rate not to exceed twelve hundred (\$1,200.00) dollars per annum.

Assistant draftsmen, Class B, shall receive a salary at a rate not to exceed ten hundred twenty (\$1,020.00) dollars per annum.

Assistant draftsmen, Class C, shall receive a salary at a rate not to exceed nine hundred (\$900.00) dollars per annum.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.

Which was read a first time and referred to the Committee on Public Works.
