INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

By Board of Public Works:

General Ordinance No. 65—1913: An ordinance approving a certain contract granting Kingan & Company, Ltd., the right to lay and maintain a sidetrack or switch from I. & V. Railroad across Kentucky Avenue, according to blue print attached, in the City of Indianapolis, Indiana.

WHEREAS, Heretofore, to-wit: on the 8th day of September, 1913,

Kingan & Co., Ltd., filed its petition before the Board of Public Works of the City of Indianapolis, as follows:

PETITION.

To the Board of Public Works, City of Indianapolis:

GENTLEMEN: We hereby make petition for the right and authority to build a switch from the I. & V. Railroad in a southeasterly direction across Kentucky Avenue, as shown on attached blue print.

NOW, THEREFORE, This agreement, made and entered into this 10th day of September, 1913, by and between Kingan & Co., Ltd., of the City of Indianapolis, County of Marion, State of Indiana party of the first part, and the City of Indianapolis, by and through its Board of Public Works, party of the second part.

WITNESSETH: That the party of the first part, being desirous of securing a right of way for a sidetrack or switch from I. & V. Railroad across Kentucky Avenue, in the City of Indianapolis, which is more specifically described as follows:

See Blue Print:

This switch intersects the North line of Kentucky Avenue at a point 235 feet more or less East, measured along the North line of Kentucky Avenue from the intersection of the North line of Kentucky Avenue with the East line of Belmont Avenue, and this switch intersects the South line of Kentucky Avenue at a point 248 feet more or less East, measured along the South line of Kentucky Avenue from the intersection of the South line of Kentucky Avenue with the East line of Belmont Avenue, hereby covenants and fully binds himself, his successors, legal representatives and assigns, that, in consideration of the grant of the privileges and authority herein given, he will lay, construct and maintain said track upon the terms and conditions hereinafter set forth, to-wit:

(1) They shall be so laid, improved and kept in repair as to be safe for persons on foot, in vehicles or otherwise, and shall, at all times, be subject to the orders of the Board of Public Works of the City of Indianapolis.

(2) Said track and switch shall be laid upon such grade as shall be established by said Board, and shall be put down under its supervision and to its satisfaction and approval. Said track shall be raised or lowered to conform to any grade which may, from time to time, be hereafter established, whenever so ordered, in writing, by said Board, and shall be made to conform in all respects with any ordinance passed by the Common Council or with any resolution or resolutions made by said Board, for the elevation or depression of said tracks.

(3) The crossing where said track intersects Kentucky Avenue shall, at all times, be kept improved and in repair and free from obstructions or defects of any kind. No car or cars shall be permitted to obstruct such crossing or to be thereon except for such time as may be absolutely necessary in moving them back and forth, and they shall be at no time stopped or detained thereon in such manner as to obstruct public travel.

(4) Said party of the first part agrees, upon the written order of said Board, made for any good cause affecting the interest of the City or the public welfare, to take up and remove said track; and upon said party's failure so to do, upon such notification in writing, of ten (10) days, to promptly pay the cost of having the same done, and the party of the first part hereby releases all claims for damages whatsoever that may arise by reason of such removal; and in removing said track or causing the same to be done, said Board shall in no wise become a trespasser.

(5) The party of the first part agrees to pave between said track to the entire satisfaction of the second party, and in case said tracks shall be or become out of repair or in need of being reconstructed, or become in any way defective (of which fact the said Board shall be the exclusive judge), it shall be the duty of the said party of the first part to promptly repair or remove same, failing in which, after notification in writing of ten (10) days, said Board shall do or cause the same to be done at the expense of the said party of the first part, and for which expense and cost the said party of the first part shall be liable.

(6) The said party of the first part herein binds himself to hold said party of the second part and said city harmless from any and all claims for damages growing out of the existence, maintenance or use of said track, and to pay any judgment, with costs, that may on that account be rendered against the said party or said city, and also to pay all necessary expenses that may be incurred by said city in defending against any such claims.

(7) Any violations of any of the provisions of this instrument by said party of the first part, or by any one for it or at its instance or with its permission, shall operate as an immediate and absolute forfeiture of the privileges and authority given or granted by this contract, provided, however, that the same may be terminated by said Board, as hereinbefore set forth.

Said party of the second part by virtue of the provisions of an act of the General Assembly of the State of Indiana, entitled "An act concerning municipal corporations," approved March 6, 1905, and in consideration of the things hereinbefore set forth and upon the terms and provisions stipulated, hereby gives, grants and duly vests said party of the first part the right, privileges and authority to lay and maintain an additional sidetrack or switch across Kentucky Avenue, in the City of Indianapolis, all as shown by the drawing attached hereto, filed herewith and for greater certainty marked "Exhibit A."

By City Controller:

General Ordinance No. 71—1913: An ordinance providing for the transfer of \$3,000.00 from a certain fund to a certain fund in and for the use of the Department of Public Works and fixing a time when the same shall take effect.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the sum of three thousand dollars (\$3,000.00) be, and is hereby transferred from the fund for Fire Headquarters and City Garage Building to a fund for the Reconstruction of the subway at Massachusetts Avenue and Tenth Street. All to and for the use of the Department of Public Works.

SECTION 2. This ordinance shall take effect and be in force from and after its passage.

Which was read a first time.

Mr. Blumberg moved that the rules be suspended and General

Ordinance No. 71, 1913, be placed on its passage, which motion failed to carry for want of a unanimous vote, as follows:

Ayes, 6, viz.: Messrs. Johnson, McCarthy, Demy, Owen, Blumberg and Troy.

Noes, 2, viz.: Messrs. Stilz and President Charles F. Copeland.

General Ordinance No. 71, 1913, was thereupon referred to the Committee on Finance.

By Mr. Stilz:

General Ordinance No. 72—1913: An ordinance concerning the inspection of weights, scales and measures, the abolition of fees with reference thereto, and the appointment of inspectors, declaring an emergency, and repealing ordinances in conflict therewith.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That no fees, charges or expenses of any kind shall be charged any person, firm or corporation, for the inspection, registering, sealing or stamping of any weight, scale or measure used in any way in the City of Indianapolis, and all such fees, charges or expenses in connection with such inspection are hereby abolished.

SECTION 2. The Board of Public Safety of the City of Indianapolis is hereby authorized to appoint six additional assistant inspectors of weights and measures, who shall be assistants to the chief inspector of weights and measures, and who shall be appointed upon the recommendation to the Board of Public Safety of such chief inspector.

SECTION 3. That the chief inspector of weights and measures, as otherwise provided, and the six additional assistant inspectors, as herein provided, shall be appointed by said Board of Public Safety, and shall serve during good behavior and shall not be removed for any political reasons, and only for good and sufficient cause, upon charges preferred before the Board of Public Safety after notice of the same and after an opportunity for a hearing upon such charges before such Board of Public Safety.

SECTION 4. That said assistant inspectors of weights and measures shall receive for their compensation, the sum of \$----- per month, payable as other salaries of city officials are paid, out of funds not otherwise appropriated.

SECTION 5. All ordinances and parts of ordinances in conflict herewith are now hereby repealed.

SECTION 6. Whereas an emergency exists for the immediate taking effect of this ordinance, the same shall be in force and effect from and after its passage.

Which was read a first time and referred to the Committee on Public Safety.

By Mr. Stilz:

General Ordinance No. 73—1913: An ordinance granting to the Indianapolis Salvage Corps the right to enter buildings on fire or exposed to fire, and to protect and save property therein.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, that power is hereby granted to The Indianapolis Salvage Corps, its officers and its men, to enter any building at any time for the purpose of inspection and any building on fire in said city, or which in their judgment is immediately exposed to fire, or in danger of taking fire from other burning buildings, and to protect and save property therein and to remove such property or any part thereof at or immediately after a fire, Provided, however, that nothing in this ordinance shall be so construed as to lessen in any way the authority of the fire department of said city or interfere with it in the performance of its duties.

SECTION 2. This ordinance shall take effect and be in force from and after its passage.
