

## ORGANIZATIONAL MEETING

Monday, July 7, 1969

The first meeting of the Unified City-County Council was held in the City Council Chamber on July 7, 1969, at 5:30 P.M.

Chairman Hasbrook in the chair.

The Chairman called the meeting of the Unified City-County Council to order for the purpose of organization.

The Clerk called the roll.

Present: Mr. Broderick, Mr. Egenes, Mr. Gorham, Mr. Hasbrook, Mr. Leak, Mr. McPherson, Mr. Moriarty, Rev. Williams, Mr. Boyd, Mr. Brown, Mr. Byrum, Mr. Cottingham, and Mr. SerVaas.

Absent: Mr. Forestal.

The Chairman announced that the first order of business would be for the organization of the City-County Council and the election of Officers and asked for nominations for President of the Unified Council.

Mr. Byrum made a motion to nominate Mr. Thomas C. Hasbrook. The motion was seconded by Mr. Gorham.

Mr. Cottingham moved that the nominations be closed and that the Clerk be instructed to cast the unanimous vote of those present for Mr. Hasbrook.

The motion was seconded by Mr. Leak.

The vote was cast as directed and the acting Chairman announced the election of Mr. Hasbrook as President of the Unified City-County Council. Mr. Hasbrook took the chair.

President Hasbrook asked for nominations for the office of Vice-President and Majority Leader.

Mr. Egenes nominated Mr. SerVaas, seconded by Mr. McPherson.

Mr. Leak moved that the nominations be closed and that the Clerk be instructed to cast a unanimous ballot for Mr. SerVaas.

The motion was seconded by Mr. Gorham.

The vote was cast as directed by the Clerk and President Hasbrook announced the election of Mr. SerVaas as Majority Leader and Vice-President of the Unified Council.

President Hasbrook announced the appointment of standing committees for the Unified Council as follows:

President Hasbrook stated that when the hearings are finished, the various committees will give their recommendations for the budget to the Council. This will be reviewed by the finance committee to provide a composite budget. Each committee will be given a citizen advisor to help the committee.

On motion of Mr. Leak, seconded by Mr. Gorham, the Unified Council adjourned at 6:00 P.M.
