INDIANAPOLIS, Feb. 28, 1870.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN :—We herewith submit an ordinance appropriating the sum of \$2,000, for the purchase of posts and lanterns for public gas lamps, and respectfully urge its immediate passage.

According to the estimates of the City Gas Inspector, ordinances providing for the erection of at least three hundred new gas lamps, have already been passed by the Council. It is our judgment that this aggregate will be increased to five hundred, before the end of the season. Under the charter of the Gas Company, the time for erecting lamps commences with to-morrow, March 1. Having but few posts on hand, it is important that preparations should be at once made for receiving proposals to furnish that article, so that a quantity might be manufactured or delivered before the end of the ensuing month, at the farthest. We therefore recommend that, on the passage of the accompanying ordinance, the City Gas Inspector be directed to advertise for proposals to furnish one hundred lamp posts, of an average weight of three hundred pounds.

GENTLEMEN:—Having considered "An ordinance to provide for the erection of a lamp post, lamp and fixtures complete to burn gas, except the service pipe, on the southwest corner of Pearl street and the first alley west of Meridian street," we would report:

That the alley above described is the one commencing immediately in the rear of Daggett & Co.'s store, coming out on Maryland street at the rear of the old Athaneum building. Believing that the alley further west (in the center of the square), and known as Bank or Severn alley, should be lighted, we would recommend that such an amendment be made in the ordinance. And there being no room for a lamp post at that point, we would also recommend that a bracket lamp be substituted for the post, and that said lamp be erected under the supervision of the City Gas Inspector.

The indicated changes being made, we recommend that the ordinance pass

GENTLEMEN:—Your petitioner, Thomas Brooker, respectfully shows to your honorable body, that he is the owner of lots Nos. 1 and 2, of out lot 23, corner Sixth and Tennessee streets, in said city of Indianapolis, and that one John W. Whinzates is the owner of lot No. 3 in same out lot, fronting on Tennessee street, for which Jesse Jones is agent, and who has requested petitioner to be joined in this petition.
