The Common Council met in regular session.

The proceedings of the adjourned session, held July 18, 1870, and
of the regular session, held July 23, 1870, were read and approved.

Sealed proposals for public work were opened and read by the City Clerk, and referred to the Committee on Contracts.

CALL OF THE ROLL.

Mr. Cottrell offered the following motion :

That the "Trades Union" be tendered the use of the Council Chamber, on Friday next.

Which was adopted.

Also, the following motion :

That Thomas Huggins be permitted to grade the alley on east side of his property, on McCarty street, contiguous to lot No. 33, in out lot No. 101, at his own expense.

Which was adopted.

Mr. Harrison offered the following motion :

That permission be, and the same is hereby granted, to Samuel J. Pickerell, to pave with brick, the sidewalk in front of his grocery store, No. 101, on Broadway, corner of Cherry street, the same to be done at his own expense, and under the direction of the City Civil Engineer.

Which was adopted.

Mr. Locke introduced Special Ordinance No. 154, 1870, entitled :

AN ORDINANCE to provide for grading and graveling Second street, between Illinois and Meridian streets, including the sidewalks.

Which was read the first time.

Mr. Marsee presented the following petition :

INDIANAPOLIS, July 30, 1870

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN :—The undersigned, owners of the real estate fronting on East Cumberland street, between South Delaware and the eastern terminus of East Cumberland street, respectfully petition your honorable body to pass an ordinance providing for the change of the name and designation of the street

now known and designated as East Cumberland street, from South Delaware street east, so far as said East Cumberland street has been opened, and named and designated as such; and ordaining that hereafter said East Cumberland street shall be known and designated as *East Pearl street*.

Your petitioners respectfully represent that a street extending from Pennsylvania street on the east, to Illinois street on the west, has been, and is still known, and designated as Pearl street, and is in the direct line of said East Cumberland street, and being in the business center of the city, tends to create a general impression that East Cumberland street is a continuation of Pearl street, thus causing confusion, which would be avoided by naming and designating the same as East Pearl street, as herein prayed for.

On motion, the whole question of building cisterns was referred back to the Chief Fire Engineer.

Also, the following motion :

That the Marshal be instructed to notify the Trustees of Roberts' Chapel to remove the bricks opposite said Chapel, on North Delaware street, immediately, in order that the improvement now in progress on said Delaware street may not be interrupted.

Mr. Weaver presented the following petition :

INDIANAPOLIS, July 30, 1870.

To the Mayor and Common Council of the City of Indianapolis.

GENTLEMEN:—The undersigned, citizens doing business on Pennsylvania street, near Washington, respectfully represent that, in consequence of the Citizens' Street Railroad Company having made the corner of Pennsylvania and Washington streets the starting place for nearly all their cars, and a monopoly by them of all the middle of said street at said corner, the express wagons have become a great annoyance and a great inconvenience at this great thoroughfare of the business and trade of the city. When the street cars are on the track and the express wagon at the curb stone, there is too little space left for the passage of vehicles of all kinds. Your petitioners, therefore, pray that the express wagons be prohibited from standing on said Pennsylvania street, between Washington and Market, and be assigned a place on Pennsylvania street south of Washington street.

Resolved, That the owners of the following described real estate, to-wit: lot No one (1), in square No. eighteen (18), in Drake's Addition to the city of Indianapolis, be and they are hereby required to fill and drain the same, as, in the opinion of this Council, there is a hole or excavation thereon, in which water has or may become so stagnant and noxious as to become a nuisance and injurious to the health and comfort of said city and of the inhabitants thereof, and that the Street Commissioner be, and he is hereby required to notify the owners thereof, as provided by an Ordinance passed April 23d, 1866, entitled "An Ordinance, providing for the drainage and filling up of ponds, excavations and holes, and prescribing penalties for the failure to fill up or drain the same," and that in case of the failure of the owners thereof to fill or drain the same, the Street Commissioner proceed to drain said excavation, as provided in said Ordinance.

The question being on the adoption of the resolution :

GENTLEMEN:—The undersigned respectfully petitions your honorable body to vacate so much of the south line of the National Road from the Michigan Road east to the old corporation line, so as to make the same straight; as it now is, there is an offset, and when graded and graveled will look badly. I have spoken to the Engineer about the matter, and he thinks the change should be made. Hoping that your honors will take some action as soon as convenient, as the sidewalk is now being made.

Mr. Brown moved, that when the Council adjourn, it adjourn to meet on Thursday August 4, 1870, at 7½ o'clock P. M., for the purpose of considering petitions to vacate streets and alleys.

GENTLEMEN:—Your Committee on Revision of Ordinances, to whom was referred a petition signed by James Sulgrove, C. E. Geisendorff and others recommending the appointment of Christian Schmidt for the position of City Scavenger, beg to report that, in our opinion, the grounds now used for the deposit of dead animals are too near the city limits, and should be sold, and others purchased at a greater distance and more suitable for the said purposes.

Your Committee do not deem it proper, on their part, to recommend any particular person for the position of Scavenger, and leave that matter entirely with the Council.

INDIANAPOLIS, July 30, 1870.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—Your Committee on Fire Department, to whom was referred the location of the new Steam Fire Company, would respectfully report, that in their opinion the house should be located on the corner of St. Joseph and Alabama streets. A lot 53 feet front on St. Joseph street, and running back 150 feet on Alabama street, can be purchased for \$2,800, half-cash, balance in one and two years, with 6 per cent. interest. We, therefore, recommend that the Mayor and City Attorney be authorized to close the contract for the purchase of the above named lot, and that the Chief Fire Engineer, with your Committee, be authorized to have plans and specifications of an engine house prepared, and submit the same to this Council for approval.

We would also recommend that the City Clerk be directed to advertise for proposals for furnishing the city with two thousand feet of best quality rubber hose; also, that the Chief Fire Engineer be directed to furnish this Council with the cost of a first class Hose Reel.

In regard to the extension of the Fire Alarm Telegraph, we would recommend that Fire Alarm boxes be placed as follows, to-wit: One at corner of Butler and Jackson streets; one at corner of Massachusetts avenue and Ash street; one at corner of College and Christian avenues; one at corner of Second and Illinois streets; one at Orphan Asylum; one on corner of Meridian and Fourth street; one at corner of Fourth and Mississippi streets; one on East Washington street, between the residences of W. P. Fishback and J. W. Ray; one on corner of Fletcher avenue and South street, and one at City Building
