The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

The proceedings of the regular session, held September 5, 1870, were read and approved.

Mr. Wiles, from the Committee on Contracts, made the following report:

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: The Committee on Contracts to whom was referred sundry proposals for building cisterns as advertised for, have examined the same, and find that Deney & Troman are the lowest bidders, their bid being 58 cents per barrel; the next lowest bidders being John A. Whitsitt and Thomas Dillon, at 62 cents per barrel. Messrs. Dewey & Trowman being the lowest bidders, we would recommend that they be awarded the contract.

An Ordinance to provide for grading and graveling Georgia street, between Pennsylvania and Delaware streets,

An Ordinance to provide for grading and graveling Chesapeake alley, between Pennsylvania and Railroad streets,

Which was read the first time.

Mr. Brown introduced General Ordinance No. 51, 1870, entitled :

An Ordinance relative to omnibus runners at the Union Depot, and the general protection and convenience of travelers in the city,

Which was read the first time.

Mr. Brown offered the following motions :

Moved, That the Street Commissioner be directed to notify the the owners of property on the west side of Meridian street, between Chesapeake alley and Georgia street, that the pavements not completed must be repaired within thirty days, or the same will be done by the city and the costs collected from the property owners.

Moved, That the City Engineer report to the Common Council an estimate of the work done by J. H. Robinson on his contract for straightening Pogues Run.

Which were adopted.

Mr. Cottrell introduced Special Ordinance No. 173, 1870, entitled,

An Ordinance to provide for the erection of lamp posts, lamps and fixtures complete to burn gas, except the service pipe, on Meridian street, between Delaware and East streets.

Which was read the first time.

Mr. Cottrell offered the following motion:

Motion, That the Street Commissioner be instructed to remove the Citizen's Railroad track off the sidewalk on the corner of Illinois and Tinker street, and the corner of Christian avenue and Fort Wayne avenue, within forty days from the passage of this motion.

Which was referred to the Judiciary Committee and the City Attorney.

Mr. Kahn introduced special Ordinance No. 174, 1870, entitled:

An Ordinance to provide for grading and graveling Vermont street, from East to Noble streets,

Which was read the first time.

Mr. Kahn introduced special Ordinance No. 175, 1870, entitled:

An Ordinance to provide for grading and paving with brick the south sidewalk of Michigan street, from Pennsylvania to New Jersey street,

Which was read the first time.

Also, Special Ordinance No. 176, 1870, entitled:

An Ordinance to provide for paving with brick the east sidewalk of Noble street, from Market to Vermont street,

Which was read the first time.

Also, Special Ordinance No. 177, 1870, entitled:

An Ordinance to provide for grading the alley between Davidson and Noble, Vermont and Michigan streets, running east and west,

Which was read the first time.

Mr. Kahn offered the following motion:

Moved: That the City Gas Inspector be instructed to inquire into the cause why Cherry street is not lighted the same as other streets, and report to this Council.

Which was adopted.

Mr. Kennington offered the following motions:

Moved: That the Street Commissioner be directed to build two foot bridges on Meridian and Phipps streets.

Moved: That the Street Commissioner be directed to build two foot bridges on Phipps street and Madison Avenue.

Which were adopted.

Mr. Locke introduced Special Ordinance, No. 178, 1870, entitled:

An Ordinance providing for grading and paving with hard brick the south sidewalk on Michigan street, between the canal and California streets,

Which was read the first time.

Mr. Locke offered the following motion:

Moved: That William Sheets be permitted to cut down to the grade of New York street the sidewalk in front of his property at the northwest corner of New York and Missouri streets, and that the Civil Engineer be directed to set the grade stakes.

Which was adopted.

Mr. Marsee offered the following motion :

Moved : That the Street Commissioner be directed to notify the I. C. and L. R. R. Co. to open the culvert under their track on the northeast side of Virginia avenue, within ten days from this date, and in case of their refusal or neglect to do said work, the Street Commissioner is directed to have it done, and report the cost of the same to this Council.

Which was adopted.

Mr. Newman presented the following :

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN: Chris. Lakey, your petitioner, represents to your honorable body that in opening Davidson street the contractors destroyed his garden on that part of said street, consisting of potatoes, cabbages, and other vegetables, worth fifteen dollars; that he was only the lessee of the premises, and did not have any right to remonstrate against the opening of said street, and his damages could not have been estimated by the City Commissioners. He therefore prays you to make him a suitable compensation for his damages, and as in duty bound he will ever pray.

Which was referred to the Committee on Claims.

Mr. Reagan offered the following motion :

Moved : That the City Marshal be notified to enforce the ordinance that relates to the crossing of streets and alley, and that the Union Railroad Company be compelled to plank between each track at the crossing of the first alley east of Tennessee, between Louisiana and South streets.

Which was adopted.

Also, the following motion :

Moved : That the City Marshal notify the Rolling Mill Company to discontinue the blowing off of water from the boilers on Ellen and

Ann streets, between Tennessee and Mississippi, as the citizens on said streets claim it to be injurious to their health, and a nuisance.

Which was referred to the Board of Health.

Mr. Reagan offered the following motions :

Moved : That the Street Commissioner be notified to clean up the gutters on the north side of Louisiana street, between Tennessee and Mississippi streets.

Moved : That the Street Commissioner notify the hub and last factory company to remove the timber on Garden street, between Tennessee and Illinois, and to keep said street open so as to cause as little obstruction as possible.

Which were adopted.

Also, the following motion :

Moved : That the Committee on Public Buildings be instructed to purchase furnaces for the city prison. Also, to contract for lighting rods for the same.

Which was referred to the Committee on Public Buildings, with instructions to report an estimate of the cost.

Mr. Shepherd presented the following petition :

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN : The undersigned, owners of the real estate fronting on Cumberland street, between Mississippi street and the canal, respectfully petition your honorable body to pass an ordinance providing for grading and graveling of the roadway and sidewalk of the above named portion of Cumberland street, with washed river gravel.

And your petitioners will ever pray, etc.

P. H. Griffith, 67½ feet ; A. N. Lawrence, 18½ feet ; J. L. & M. K. Fatout, 100 feet ; Frank Smith, 32 feet ; Jacob Traub, 16 10-12 feet.

Which was received.

Also, Special Ordinance No. 179, 1870, entitled :

An Ordinance providing for grading and graveling Cumberland street and sidewalks from Mississippi street to Missouri street.

Which was read the first time.

Mr. Shepherd offered the following motion :

Moved : That the Street Commissioner be and is hereby ordered to open the gutter on McCarty street, east of West street to Pogue's run, under the direction of the Civil Engineer.

Which was adopted.

Mr. Shepherd presented the following communication :

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN : The undersigned, John Berger, has the honor to communicate to you the following facts for your further consideration and action :

1. The contractors, Frederick Richter & Co., have recently entered with the city of Indianapolis into a contract for the construction and erection of a certain wall, situate somewhere on South Noble street, near the High Bridge, in this city, and have performed and finished that work. But the contractors have failed to comply with the terms of the specifications to said contract, in this: because they have built and erected the front side of the foundation only about one foot wide out of masonry, instead of about four feet wide, and have then the empty space in the rear of said wall (about three feet vacuum) filled up with gravel and dirt, contrary to the terms of the specifications alleged, thereby deceiving the proper authorities examining the work, to the great detriment of the city of Indianapolis.

2. The same firm of Richter & Co. have also entered with said city into contract for the construction and building of two abutments,

situate on Pogue's run, opposite the last factory, on South Illinois street, in the city of Indianapolis.

The contractors have completed their work, but they have failed to comply with the terms of the specifications to the contract in question in this: that they wilfully used and put down old and rotten mudsills, taken from some old bridge, and failed and neglected to use good, sound, and substantial material in the construction of said abutments, whereby the city of Indianapolis will sustain a great and material damage and loss.

The undersigned, having witnessed and observed all these tricks and delusions on the part of the said contractors, is willing and ready to corroborate these statements by proper evidence, if the authorities will see fit to investigate these matters.
