To His Honor, the Mayor, Members of the Council, and Board of Aldermen:

Gentlemen:—The following figures show my valuation of the taxable property in the city of Indianapolis for the year 1882:

Lots. Improvements. Personal Property. Total Valuation. \$23,538,815............\$16,043,700..........\$12,894,773...........\$52,477,288

Showing an increase over last year's valuation, of one million four hundred thousand dollars, which amount is made up of an increase in personal property of nine hundred thousand dollars, and an increase in improvements of five hundred thousand dollars, in round numbers. This return does not include the assessment made against the Railroads, which reports are now in the custody of the State Board of Equalization. They will be embraced in my final report. The amount of these returns last year, was three hundred thousand dollars. The polls number 14,452, an increase over last year of seven hundred and twenty-seven.

SPECIAL ORDER-CITY HALL AND MARKET HOUSE.

As a question of privilege, Alderman Hamilton offered the following resolution:

Resolved, That \$25,000 of the "Tomlinson Fund" on hand, be appropriated and used for the construction of a Market House on the east Market Space, and the balance for sewers; also, that the proceeds from the sale of the "Tomlinson Estate" now unsold, be appropriated and used for improvement and adornment of the public parks, as the Council and Board of Aldermen may direct.

Alderman Tucker, in behalf of the Committees on Finance, Judiciary and Public Property, submitted the following report:

To the President and Members of the Board of Aldermen:

Gentlemen:—Your Committees on Finance, Judiciary and Public Property, to whom was referred G. O. 51, 1882, an ordinance to provide for building a City Hall, etc., met on Friday evening, July 14th, and made careful examination of said ordinance, section by section. We believe that all amendments or changes that we might suggest, has been carefully guarded by a supplementary, or amendatory ordinance, that has been prepared and carefully examined by us, which will be presented to the Common Council for their action thereon, at their next regular meeting. We recommend that the action of the Common Council in the passage of ordinance G. O. 51, 1882, be concurred in; providing said supplementary or amendatory ordinance shall pass the Council also. In case said ordinance does not pass, we do hereby reserve the right and serve notice on this Board, that a motion to reconsider the action by which G. O. 51, 1882, was passed, will be made at the next regular session.

Since the above report was prepared, there has been a new ordinance introduced and passed the Council, containing all the amendments agreed upon by the committee, which we recommend that the same pass this body.

Your committee further recommend that, that work not be commenced on the
