# PROCEEDINGS OF COMMON COUNCIL.

# REGULAR SESSION—August 21, 1882.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, August 21st, A. D. 1882, at eight o'clock, in in regular session.

PRESENT—Hon. Isaac Thalman, President pro tem. of the Common Council, in the Chair, and 17 members, viz: Councilmen Brundage, Caylor, Cowie, Dowling, Fultz, Harrold, Hartmann, Koller, Mauer, Morrison, Pearson, Pritchard, Stout, Thalman, Ward, Weaver, and Yoke.

ABSENT—Hon. Daniel W. Grubbs, Mayor, and Councilmen Bedford, Bryce, Cole, Coy, Dean, Egger, Knodel, and Reichwein—8.

The proceedings of the first session of the Board of Equalization, held August 7th, 1882, and the regular session of the Common Council, held August 7th, 1882, having been printed and placed on the desks of the Councilmen, said Journals were approved as read.

#### REPORT FROM COMMITTEE ON CONTRACTS.

The Committee on Contracts, through Councilman Thalman, submitted the following report; which was concurred in, and the contracts severally awarded as recommended:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—The Committee on Contracts, to whom was referred sundry proposals presented to Council August 7th, 1882, have examined the same and find them to be as follows, viz:

1st. For grading and graveling the west sidewalk of Shelby street, from Prospect street to Pleasant Run, where not already done.

## REPORTS, ETC., FROM STANDING COMMITTEES.

The Judiciary Committee, through Councilman Pritchard, submitted the following report; which was concurred in:

Indianapolis, Aug. 21st, 1882.

To the Mayor and Common Council:

Gentlemen:-Your Judiciary Committee, together with the City Attorney, to

whom was referred sundry papers, report thereon as follows, to-wit:

The first is a petition by the Indiana National Bank, by V. T. Malott, President, showing that the City Treasurer refused to permit him to pay taxes for 1881, on lots 4, 5, 6 and 7, in square 64, city, for reason that, by his books, the taxes of 1879 were unpaid, when, in point of fact, the taxes of 1879 were paid.

The petition further shows that, by memorandum of books of City Treasurer, said lots are marked sold for taxes of 1879 and 1881, but, in point of fact, they were not

sold. The City Treasurer informs your Committee that the above facts are true.

We therefore recommend that the memorandum of said supposed sale be caucled, that proper entry be made on Treasurer's books showing taxes of 1879 paid, and that the City Treasurer be directed to receive taxes of 1881, without penalty and interest.

The second is the petition of F. McWhinney, showing that, on February 15th, 1881, he purchased at tax sale lot 9, in Bartholomew's sub. of I. & C. R. R. Co.'s addition to city, and that \$3.21 of the money paid was on account of improvements made on lot, when, in point of fact, there never was any improvements on said lot.

We therefore recommend that \$3.21, with interest from February 15th, 1881, be Respectfully submitted, refunded.

The bridge upon which they were standing was not built by the city, and was not in a public street. Only upon the ground of a gift, could the bill be paid. We question the right of the city government to make gifts to individuals out of public moneys. We therefore recommend that the claim be not allowed.

It was supposed by said Board that the money was in the vaults of the bank, while in point of fact it was, on April 1st, 1881, in United States bonds, deposited in the Corn Exchange Bank, of New York city. All the testimony taken in New York goes to show that the money supposed by the Board of Equalization to be in money was in United States bonds, and therefore not taxable.

But as the City Attorney has collected all the testimony he can find and is ready for trial, we recommend that the case be submitted to the Circuit Court for trial,

and that the city abide by the decision of said court.

Councilman Stout presented the following remonstrance; which was referred to the Committee on Streets and Alleys and Board of Public Improvements:

To the Honorable, the City Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, property holders on Central avenue, between St. Mary street and Eighth street, respectfully remonstrate against the passage of an ordinance—131—for grading, graveling the roadway, bowldering and curbing the gutters, and paving with brick the sidewalks of Central avenue, from the north line of St. Mary street, and a point on east line of Central avenue, opposite the north line of St. Mary street, to Eighth street, for the following reasons:

1st. There is now an ordinance (No. 129) before the Council for grading and graveling Central avenue and sidewalks, from St. Mary street to Eighth street, which ordinance we petitioned for, and which, in our opinion, requires an improvement suitable in every way to that street. This street is sparsely se tled and used mainly by wagons from the country. The sidewalks have but little travel on them, being seldom used except by residents on the street.

2d. The improvement we desire is equal in character to that of a very large number of streets in the city nearer the center of business and population.

3d. The necessary burthens upon real estate are serious, and contribute mainly to the present impossibility to sell it at rates considered very low, making it necessary, in our view, to levy no higher tax for its improvement than its necessary use by the public demands.

We therefore respectfully ask, for these and other reasons we might enumerate, you will give our remonstrance your serious consideration.

That the City Civil Engineer be directed to contract for such number of street signs (same as now in use) as may be needed from time to time to replace broken ones, and to place where not already located; and that he be directed to place such signs at any point needed on order of any Councilman or Alderman.

Councilman Ward offered the following motion; which was referred to the Committee on Public Light:

That a lamp post be erected on New Jersey street at the mouth of the alley between St. Jo and St. Mary streets,

Councilman Yoke offered the following motion; which was referred to the Committee on Water:

That the Committee on Water be, and are hereby, instructed to place a driven well at the intersection of Noble and South streets.

Councilman Yoke offered the following motion; which was referred to the Committee on Judiciary:

That the Citizen's Street Railway furnish this Council and the Board of Aldermen a time table for each street railway line in this city; also, the number of cars on each line.

On motion, the Common Council then adjourned.
