REPORTS FROM THE BOARD OF CITY COMMISSIONERS.

The Board of City Commissioners submitted the following reports; which were severally received:

To His Honor, the Mayor, Members of the Council and Board of Aldermen:

Gentlemen:—The undersigned, members of the Board of City Commissioners, duly appointed, qualified and acting under the provisions of the Statutes of the State of Indiana, in relation to the laying out, opening, widening, altering and vacation of streets and alleys, beg leave to submit the following report in the case of the petition of Kingan et al., to vacate a portion of Helen street:

1st. We met on the 26th day of September, 1884, in pursuance of notice of the City Clerk, found the papers in regular order, and by mutual agreement of the petitioners and a committee of the Council, it was agreed that fourteen feet, instead of eighteen feet, be vacated. We proceeded to view the ground and the surrounding property, and found that the petitioners were the sole owners of the ground on both sides of the street, with one exception; and the petitioners agreeing to obtain the consent of that party, on a general waver as to time, in order that the petitioners may proceed with the construction of a switch along the west side of Helen street, was agreed by the Board that the petitioners assuming the responsibility as to time, notify the interested property holders to meet the Commissioners on the 4th day of October, 1884, at 10 o'clock, A, M., at the City Clerk's office, to hear evidence and further consider the matter of said vacation.

2d. We made report of said facts to the City Clerk, and required said Clerk to have the petitioners notify Jason Carey's heirs to meet the City Commissioners on said 4th day of October.

3d. We further report that we met at the time and place named, and due service had been made on the interested parties and Simeon B. Carey, one of the Executors of the will of Jason S. Carey, appeared and a-ked that an adjournment be made to give opportunity to be heard by the attorney representing the Carey heirs. Whereupon the Board adjourned to meet on the 11th day of October, 1884, at 10 o'clock, A.M.

4th. We further report that we met as per adjournment, all interested parties

being represented, and it was mutually agreed that the potition for vacation be withdrawn; and it was also agreed by the representatives of the Carey heirs that no objection would be made by them to the laying down of a switch along the west side of Helen street.

We further report that the expenses attending the proceedings of the vacation of Helen street, have been forty-eight dollars.

We did, at that time and place, enter upon the consideration of the vacation of the alley above described We did, on said 15th day of August, proceed to view the ground and examine the alley proposed to be vacated, also the contiguous property along the line, and the property in the neighborhood, with a view of ascertaining what property would be benefited and what property damaged; and did then file with the City Clerk a report giving a description of the property, with the name of the owner of each particular lot, which report also instructed the City Clerk to have the potitioner particular and property when the protection of the property when the protection of the control of the cont Clerk to have the petitioners notify each property owner to meet the City Commissioners on the 13th day of October, 1884, in the City Clerk's office at 10 o'clock, A. M. Said report is filed herewith, as a part hereof, and marked exhibit "C."

That they did meet on the said 13th day of October, at the time and place named, and entered upon the further consideration of said vacation, by examining under oath various witnesses and interested parties in relation to vacating the alley herein described. Two of the interested property holders (Bernhard Koehring and Samuel Rodenberger) objected to closing the alley, on the ground that it would damage their property in value, and for rental purposes. Whereupon the City Commissioners agreed to report the facts to your honorable body, in accordance with the provisions of the Statutes of the State of Indiana, as contained in the 19th Section of said Act: "In case any property holder immediately upon the line of said street, alley, highway or square, who is directly interested therein shall object to such vacation, the City Commissioners shall report such facts to the Common Council,"

4th. The costs in this case have been \$33.00.

And Resolved further, That the Mayor and City Clerk be, and they are hereby, authorized to execute the obligation to be given for the loan above provided for in the name and on behalf of said city; and for the payment of any such obligation so

given, the faith of the City of Indianapolis is hereby irrevocably pledged.

We recommend the adoption of the foregoing resolution.

Dollars, on account of the Street Repair Department of the City of Indianapolis.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

Under this order of business the following entitled ordinances were introduced, and severally read the first time:

By Councilman Benjamin;

S. O. 139, 1884—An ordinance to provide for grading, bowldering and curbing the gutters, and paving with brick the sidewalks of Chesapeake street, from Illinois street to Tennessee street.

By Councilman Wharton:

S. O. 140, 1884—An ordinance to provide for paving with brick the north sidewalk of Ninth street, from Tennessee street to the first alley east of Tennessee street.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

Councilman Dowling, for Councilman Cowie, offered the following motion; which was adopted:

That the Toledo Oil Company be authorized to place a bowldered roadway across the sidewalk in front of their premises, corner of Market and Blackford streets, subject to the approval of the City Civil Engineer.

Councilman Edenharter offered the following motion:

That the Street Commissioner be directed to build a wooden bridge over Crooked Run at Walcott street, and south of Michigan street.

Councilman Thalman moved to refer the motion to the Committee on Bridges, and Board of Public Improvements.

Councilman Edenharter moved to lay the above motion on the table.

Which failed of adoption.

Councilman Thalman's motion was then adopted.

Councilman Newcomb offered the following motion; which was adopted:

That the Street Commissioner notify the owner or owners of the block situated on the west side of north Alabama street, from Pratt street to the first alley north of Pratt street, to repair the sidewalk in front of said block; and if not done in ten days, said Street Commissioner to repair the same at the expense of said property owner or owners.

Councilman Smither offered the following motion; which was referred to the Board of Public Improvements:

That the City Civil Engineer be, and is hereby, directed to have the contractor for paving sidewalks of California street, between North and Pratt streets, to put in double row of walk stones, and bowldered on all street and alley crossings.

Councilman Smither presented the following proposition; which was accepted:

I will take the Scales on West Market and put the same in repair and pay \$5.00 per month for the same, and also agree to weigh all city matter free of charge.

Councilman Thalman offered the following motion; which was adopted:

That the Committee on Public Health enquire as to the necessity of Sanitary Police officers, and under whose control they are acting.

Councilman Thalman offered the following motion; which was referred to the Committee on Railroads:

That W. L. Higgins have permission to lay a track, or railroad switch, across Alabama street, near Virginia avenue, as per plat herewith submitted.

Councilman Trusler presented the following Agreement, accompanied with resolution:

WHEREAS, Proceedings were had in the year 1878, looking to the widening of Shelby street to a uniform width of sixty feet, from Prospect street to the south corporation line, in the City of Indianapolis, which proceedings resulted in the submission of a report by the City Commissioners to the Common Council and Board of Aldermen, on the 4th day of November, 1878, favoring said widening, assessing benefits and awarding damages in said matter, which report was subsequently approved by said Council and Board of Aldermen;

And Whereas, damages in the sum of five hundred dollars were, by said report, awarded to Webb & McGehee, the supposed owners of Lots numbered 18, 19, 20 and 21, of Richter's subdivision of Cress' addition to the City of Indianapolis, for seven and one-half feet of ground to be taken off of the west ends of said lots, in such proposed widening, said five hundred dollars being allowed wholly as damages which would result to the brick building which then stood, and still stands, on said Lot 21, a portion of said building being on said seven and one-half feet to be taken in said widening;

And Whereas, it was ascertained by the City of Indianapolis for the first time after said proceedings were had, that the Hartford Orphan Asylum, of Hartford, Conn., was, during the time of said proceedings, the equitable owner of said lots, and afterwards became the legal owner thereof, by foreclosure and sale of the equity of redemption of said Webb & McGenee;

And Whereas, said Hartford Orphan Asylum was not notified of said condemnation proceedings, and was not therefore bound by the same, and did, during the time it continued to be the owner of said property, object to having said seven and one half feet taken off of the ends of said lots and to receive said five hundred dollars awarded to said Webb & McGehèe in lieu of its damages, should the same have been taken;

And Whereas, said Lots 18, 19, 20 and 21, are now the property of the under-

signed, by purchase from said Hartford Orphan Asylum;

And Whereas, said street has not yet been actually opened up and improved according to the new lines fixed by the proceedings aforesaid, and as shown by the map on file with the papers in said matter, a transcript of which is recorded in Mortgage Record No. 100, at page 535, in the Recorder's office of Marion County;

Aud Whereas, the undersigned is desirous that said street should be so opened up

and improved;

Now, therefore, In consideration of the payment to me of said five hundred dollars, I hereby consent that the City of Indianapolis may take said seven and one-halt feet off of the west ends of said Lots 18, 19, 20 and 21, and widen said street as contemplated; and I agree to protect and indemnify the City of Indianapolis against the payment of any part of said five hundred dollars over again, to said Webb & McGehee, should they at any time hereafter assert any claim thereto.

Moore; provided the parties furnish the City Attorney with abstract of title to his satisfaction, and provided the assessments have all been paid into the city treasury.

Councilman Pearson presented the following petition; which was referred to the Judiciary Committee and City Attorney:

To the Honorable, the Board of Aldermen, and Common Council of the City of Indianapolis::

Gentlemen:—Harrison Kemp, aged 51 years, a citizen and resident of Maywood, near said city, and for the past 20 years a citizen of Marion County, Indiana, shows that he is the owner of a sorrel mare, 8 years old, of the value of \$7500; that on Monday, October 27, 1884, in the afternoon, as your petitioner was driving his said mare over the bridge on West street over the Canal, she fell partly through said bridge, her hind legs passing through up to her body, and she was thereby bruised and scarred, and made lame in her hind legs, and your petitioner was unable to use her for eight days, and since then she is only able to render partial seavice, as she has not fully recovered; but your petitioner's necessities compel him to use her. That he never knew of any imperfection in said bridge until his mare was struggling to escape from the hole in the same. That he considers his damages for loss of time, medicine, farrier's bill and injury to his mare, at least fifteen dollars, which he asks your honorable body to order paid.

He also shows that immediately on releasing his mare from said bridge, he took her to Dr. L. N. Perry, 241 west Washington street, for treatment, who charged him \$5.00 therefor. And for an amicable adjustment of his said damages, he respectfully prays. And he makes oath that the matters set forth in the foregoing petition are true.
