# REGULAR SESSION.

The City Gas Inspector made the following report:

#### INDIANAPOLIS, Nov. 21, 1870.

#### To the Mayor and Common Council of the City of Indianapolis:

GENTLEMMEN: Mr. Locke's motion, directing the Street Commissioner to place guard-posts about the public gas lamps at the corners of streets and alleys, having been referred to me, with instructions to report a plan and the cost of the same, I would now state:

That the only feasible system of protection which suggests itself to my mind, is one that will guard the lamps in three different directions, viz: from any danger approaching them along the lines of the streets or alleys at the corners of which they are erected, as well as from any dangers at the angles thus formed.

The lamps are placed only one foot inside the curbing. The angle guard, therefore, should be in the curbing itself, for there is no room at that point for the placing of an independent guard post. I would suggest that it would be a good idea, hereafter, to cause special angle-curbing to be used at those intersections of streets and alleys where lamps are likely to be erected, and that this angle-curbing project from one foot to eighteen inches above the top line of the other curbing, and have its two ends and outer edge beveled away so as to throw off the wheel of any vehicle approaching the lamp in a diagonal direction. The side lines of this angle-curbing should be about two feet each.

The guard posts suggested should be of locust or cedar, sufficiently high above the surface of the ground to catch the axle of any vehicle

threatening injury to the lamp, and set in the ground deep enough to sustain a very heavy blow. Probably five feet would be length enough for the posts, which would allow of two feet below and three feet above ground. These posts should be at least five inches in diameter above ground, and set not nearer than one foot of the lamp.

I have made no inquiry as to the cost of the proposed angle-curbing, as I considered it would be impracicable to attempt the carrying out of any such idea this season.

The wooden guard posts, with the labor of placing same as suggested, cannot be estimated at less than one dollar per pair, or lamp.

As it is now past the middle of November, it is scarcely possible that the weather which is usual at this season of the year would long permit the work of putting in any ground-posts whatever; I would, therefore, recommend that the Councilmen of the different wards be allowed to furnish lists of such lamps as they may consider peculiarly liable to breakage by runaways, and that the Street Commissioner be then authorized to protect the same, according to the plans suggested, so far as time and opportunity will permit.

# INDIANAPOLIS, Nov. 21, 1870.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: Having considered the motion offered by Mr. Marsee on last Monday evening, directing the City Gas Inspector to place a lamp post at the corner of the new Station House, we would now report:

That we find provisions have already been made for lamps over the Station House door on Alabama street and on Pearl street, and that bracket lamp of the style now used for lighting our alleys, if so placed, would afford more than double the light of a single post lamp; these bracket lamps would not be so liable to breakage as a post lamp, and, being connected with the meterin the house, could be lighted and burned without regard to the time-table governing the lighting and extinguishing of public gas lamps.

A post lamp, with all its appurtenances, would cost \$30; the two bracket lamps would cost \$15,50, and the expenses of putting them in position, which, in our judgment, ought not to be over \$4,50, making a total of \$20.

We would, also, recommend that a like bracket lamp be placed over the door on the east side of the building, so as to light the yard.

The total expense of erecting these three lamps, we have every reason to believe, will not exceed \$30.

We would, therefore, recommend that these bracket lamps be placed on the Station House, instead of a post lamp at the corner of said building; and that your gas officer be empowered to contract for and superintend the placing of the same.
