Vice-President Bach announced that the first order of business would be the election of a Member to fill the vacancy caused by the resignation of Mr. Albert O. Deluse.

Mr. Wood presented the name of Thomas A. Moynahan, 1465 North Delaware Street. The motion was seconded by Mr. Ransom.

Vice-President Bach asked if there were any further nominations, receiving none, the Chair recognized Mr. Ropkey who moved that the nominations be closed. The motion was seconded by Mr. Ross and passed by the unanimous vote of the Council.

On motion of Mr. Wood, seconded by Mr. Ransom, the Clerk was instructed to cast the unanimous vote of the Council for Mr. Moynahan, and to certify to Mr. Moynahan that he had been duly elected a Member of the Common Council to fill the unexpired term of Mr. Albert O. Deluse.

The result of the vote on the above motion was as follows:

Mr. Moynahan was elected to fill the vacancy.

Mr. Wood asked for a recess. The motion was seconded by Mr. Ross and the Council recessed at 12:35 p. m.

The Common Council reconvened at 1:20 p. m. with the same members present as before.
