INTRODUCTION OF APPROPRIATION ORDINANCES

By the City Controller:

APPROPRIATION ORDINANCE No. 21, 1942

- AN ORDINANCE of the City of Indianapolis, Indiana, reallocating and appropriating the sum of Seven Thousand Dollars (\$7,000) now in the City Bond Fund as a part of the proceeds of the sale of "City of Indianapolis City Hospital Bonds of 1941", and fixing a time when the same shall take effect.
- WHEREAS, Section 1 of Appropriation Ordinance No. 5, 1941, as amended by Section 1 of Appropriation Ordinance No. 9, 1942, as now in effect and to which reference is here made, allocated for five specific purposes, the amount of the total proposed expenditures thereof at the City Hospital aggregating the sum of Two Hundred Fifty Thousand Dollars (\$250,000); and
- WHEREAS, the subsequent involvement of the United States in the present war, has precluded the carrying out in full of the five purposes and proposed expenditures thereof as so set out and appropriated in said ordinances, so that an additional reallocation in such estimated specific amounts is now necessary, and by a revision in the plans for the installation of five (5) new elevators, an estimated saving of Seven Thousand Dollars (\$7,000) in the appropriation thereof can be effected; and

WHEREAS, the war emergency has resulted in rising costs and it is now not possible to carry out the construction of the water filtration plant and the reconstruction of the surgical building, together with the necessary equipment at the original estimated cost, and an acute emergency exists, due to the war, which makes it immediately necessary and preferable that the City Hospital water supply be adequately protected and purified, and the necessary changes in the surgical building be completed; and the additional sum of Seven Thousand Dollars (\$7,000) so required can be obtained by the aforesaid reduction of said originally estimated expenditure for said elevators; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there is hereby appropriated from the sum specified in item 2 of Section 1 of Appropriation Ordinance No. 5, 1941, the sum of Seven Thousand Dollars (\$7,000), thereby revising the sum for the construction of elevators to Sixty-eight Thousand Dollars (\$68,000), and the amount so reduced is hereby reallocated and appropriated for the purposes set forth in items I and 3 of the original Appropriation Ordinance No. 5, 1941, as follows:

- 1. For the construction of a new aerating and filtration plant with a building to house the same, together with all necessary exterior and interior piping and all other necessary matters appurtenant thereto, the additional sum of Fifteen Hundred Dollars (\$1,500.00), making the total appropriation therefor the sum of Seventy-six Thousand Five Hundred Dollars (\$76,500.00).
- 2. For the reconstruction of the surgical building, together with all necessary equipment and resulting necessary construction charges, the additional sum of Five Thousand Five Hundred Dollars (\$5,500.00), making the total appropriation Seventy Thousand Five Hundred Dollars (\$70,500.00).

Section 2. For the repayment of the principal amount of the temporary loan herein authorized by this ordinance there is hereby appropriated to the city controller's 1943 budget fund No. 63—Payment of Temporary Loans (hereby established) out of the current revenues and taxes levied in the year 1942, payable in the year 1943, for the general fund of the City of Indianapolis, the sum of Seven Hundred Fifty Thousand Dollars (\$750,000); and for the payment of the interest thereon there is hereby appropriated to the city controller's 1943 budget fund No. 61-2—Interest on Temporary Loans, out of the above designated revenues and taxes the sum of One Thousand Five Hundred Dollars (\$1,500.00).

Said time warrants are to be signed by the mayor of the City of Indianapolis and the city controller, countersigned by the president of the Board of Health and attested by the city clerk of the City of Indianapolis, and the seal of the City of Indianapolis to be attached thereto, and said time warrants shall be payable at the office of the city treasurer in the City of Indianapolis, Indiana; and to the payment of said time warrants the current revenues and taxes levied in the year 1942, payable in the year 1943, for the School Health Fund of the Board of Health of the City of Indianapolis are hereby irrevocably appropriated and pledged.

Section 2. That for the repayment of the principal amount of the temporary loan herein authorized by this ordinance, there is hereby appropriated to School Health Fund No. 63—Payment of Temporary Loans (hereby established), out of the current revenues and taxes levied in the year 1942, payable in the year 1943, for the School Health Fund of the Board of Health of the City of Indianapolis, the sum of Twenty-five Thousand Dollars (\$25,000); and for the payment of the interest thereon there is hereby appropriated to School Health Fund No. 61—Interest on Temporary Loans, out of the above designated revenues and taxes the sum of Fifty Dollars (\$50.00).

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

GENERAL ORDINANCE No. 88, 1942

- AN ORDINANCE authorizing the City of Indianapolis to make a temporary loan in the year 1943 in the sum of Twenty Thousand Dollars (\$20,000) for the use of the Board of Health of said city in anticipation of and payable out of the current taxes of said Board of Health actually levied for the Tuberculosis Fund of said board and in the course of collection in the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.
- WHEREAS, the Board of Health of the City of Indianapolis, Indiana, is now and will continue to be until on or about the 15th day of May, 1943, without sufficient funds to meet payroll and necessary current expenses for the year 1943, payable out of the Tuberculosis Fund of said Board of Health; and
- WHEREAS, the first semi-annual installment of taxes levied by the City of Indianapolis for the year 1943 for the Tuberculosis

Fund of said Board of Health will amount to more than Twenty Thousand Dollars (\$20,000); NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the city controller of the City of Indianapolis is hereby authorized and empowered to negotiate a temporary loan in the year 1943 for use of the Board of Health of said city in anticipation of the current taxes of said Board of Health actually levied in the year 1942 and in course of collection in the year 1943 for the Tuberculosis Fund, not to exceed the sum of Twenty Thousand Dollars (\$20,000) without considering the interest thereon to be added thereto, for a period not to exceed the time hereinafter fixed in this ordinance, at a rate of interest not to exceed six per cent (6%) per annum, the rate of interest to be fixed by the lowest bidder bidding for said loan on an interest basis. Said loan shall run for a period not to exceed one hundred forty (140) days. The city controller is authorized to make sale of said time warrants after a notice thereof shall have been published by the city controller once each week for two consecutive weeks in two newspapers of general circulation, printed in the English language and published in the City of Indianapolis, and said sale to be not less than ten (10) days after the last publication of said notice. Said time warrants are to be signed by the mayor of the city of Indianapolis and the city controller, and countersigned by the president of the Board of Health, and attested by the city clerk of the City of Indianapolis, the seal of the City of Indianapolis to be affixed thereto, and said time warrants shall be payable at the office of the city treasurer of the City of Indianapolis, Indiana; and to the payment of said time warrants the current revenues and taxes levied in the year 1942, payable in the year 1943, for the Tuberculosis Fund of the Board of Health of the City of Indianapolis, are hereby irrevocably appropriated and pledged.

Section 2. That for the repayment of the principal amount of the temporary loan authorized by this ordinance there is hereby appropriated to Tuberculosis Fund No. 63—Payment of Temporary Loans (hereby established) out of the current revenues and taxes levied in the year 1942, payable in the year 1943, for the Tuberculosis Fund of the Board of Health of the City of Indianapolis, the sum of Twenty Thousand Dollars (\$20,000); and for the payment of the interest thereon there is hereby appropriated to Tuberculosis Fund No. 61—Interest on Temporary Loans, out of the above designated revenues and taxes the sum of Twenty-five Dollars (\$25.00).

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

AN ORDINANCE to amend Sections 1 and 2 of General Ordinance No. 60, 1939, as amended by General Ordinance No. 66, 1940, and General Ordinance No. 92, 1941, of the City of Indianapolis, Indiana; and providing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:
