INTRODUCTION OF GENERAL ORDINANCES

GENERAL ORDINANCE No. 54, 1943

AN ORDINANCE amending Sections 1 and 2 of General Ordinance No. 25, 1943, relating to the purchase and supply of personal equipment such as uniforms, supplies, etc., for members of the Indianapolis Police and Fire Departments, etc., and providing for the payment of certain monthly allowances at designated periods by the City Controller, and fixing a time when this ordinance shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Sections 1 and 2 of General Ordinance No. 25, 1943, relating to the purchase and supply of personal equipment, such as uniforms, supplies, etc., for members of the Indianapolis Police and Fire Departments, including Gamewell Division, etc., be and the same is hereby amended to read as follows, to-wit:

"Section 1. That beginning as of January 1, 1943, the City Controller of the City of Indianapolis, Indiana, be and the same is hereby authorized, empowered and directed to pay the annual sum of Sixty Dollars (\$60.00) in equal semi-annual installments (except as hereinafter designated for the year 1943), as uniform, clothing and equipment allowances from the special fund known as "Police and Firemen's Equipment Fund," to each and every member of the Indianapolis Police and Fire Departments (including such members as are attached to or serving with the Gamewell Division as well as policewomen and plain-clothes detectives) who has been a member for the last past twelve (12) months or longer; and to pay to each of said members who has been a member for less than twelve (12) months last past, in equal semi-annual installments (excepting as hereinafter designated), as uniform, clothing and equipment allowances from said special fund, a sum equivalent to Five Dollars (\$5.00) per month for each month of membership during the last past twelve (12) month period.

"Section 2. That the semi-annual installment payments of uniform, clothing and equipment allowances above provided shall be made on the first day of June and on the first day of December in each calendar year, EXCEPTING THAT, in order to effect the operation of this ordinance as of January 1, 1943, said equal annual install-

ments for the year 1943 only shall be paid on the first days of August and December, 1943."

Section 2. That this ordinance shall be in full force and effect after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

GENERAL ORDINANCE No. 55, 1943

AN ORDINANCE establishing certain passenger and/or loading zones in the City of Indianapolis, pursuant to the provisions of Section 26 of General Ordinance No. 96, 1928, as amended; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets in the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to and going from such premises, such owners or occupants having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as amended, relative to the establishment of passenger and/or loading zones, at the places hereinafter described, and the Board of Public Safety having caused investigation to be made thereof and having recommended their establishment pursuant to the terms of the aforesaid ordinance, the following passenger and/or loading zones be and the same are hereby established in the City of Indianapolis, to-wit:

Eighteen (18) foot loading zone on the east side of Illinois Street starting at a point one hundred fifty (150)

feet south of the curb line of 24th Street and extending south for a distance of eighteen (18) feet.

Eighteen (18) foot loading zone on the south side of St. Clair starting from a point twenty-five (25) feet east of the east curb line of Illinois Street and extending east for a distance of eighteen (18) feet.

Eighteen (18) foot loading zone starting at a point awenty-five (25) feet south of the south curb line of East Morris Street on the west side of Charles Street and extending south for a distance of eighteen (18) feet.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

BE IT FURTHER RESOLVED, that the City Clerk is hereby requested and empowered to keep a copy of the names, addresses, wages and salaries of all of said employees of the City of Indianapolis in such form so that the same may be permanently on file in his office and readily available for the use of the Common Council and other departments of the city and for the use of the general public; and the City Controller is hereby requested to advise the City Clerk of any changes in the personnel, addresses, wages and salaries of said city employees from time to time as they may occur.
