To the Honorable President and Members of the Common Council of the City of Indianapolis.

Gentlemen:

I am returning to you herewith without my signature, within ten days after its receipt by me, Special Ordinance No. 1, 1943.

My objections to Special Ordinance No. 1 are as follows:

- 1. Before any territory is annexed to the City of Indianapolis, a comprehensive study should be made by the City Planning Commission before such a step is taken. As I understand it, the Planning Commission was not considered in connection with the annexation provided for in this ordinance.
- 2. This ordinance annexes only the East side of Evanston Avenue from 59th Street to 62nd Street and will bring within the City limits only the residences located on the East side of Evanston Avenue. In my opinion, this will create considerable hardship on the residents there, will require them to transfer their children to other schools and in many instances will necessitate a readjustment of existing mortgages due to the increased taxes to be levied on these homes.
- 3. Even though these residences are not within the City limits, under present laws, the property owners can be assessed for the construction of any sewer serving their properties.

Please understand that I am in favor of enlarging the City of Indianapolis, but I believe this should be done only after a thorough and comprehensive study has been made of the areas to be annexed, by the City Planning Commission, and that annexations should not be made effective on a piece-meal basis.

GENERAL ORDINANCE No. 75, 1943

AN ORDINANCE prohibiting parking on a certain part of a certain street in the City of Indianapolis, Indiana; providing a penalty for the violation thereof; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That it shall be unlawful for the operator of any vehicle to park the same or suffer, permit or allow the same to be

parked at any time upon a certain part of a certain street in the City of Indianapolis, Indiana, described as follows:

On the west side of North Oriental Street from the south curb line of East Washington Street to a point seventy-five feet (75') north.

Section 2. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not to exceed one hundred eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE No. 76, 1943

AN ORDINANCE authorizing the Board of Public Works and Sanitation, through its duly authorized Purchasing Agent, to make certain repairs and purchase certain materials and equipment for the Municipal Airport of Indianapolis, Indiana; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Works and Sanitation of Indianapolis, Indiana, by and through its duly authorized Purchasing Agent, be and it is hereby authorized and empowered to make the following repairs and purchase the following materials and equipment for the Municipal Airport, to-wit:

Section 2. That said repairs and purchases shall be paid for out of funds heretofore appropriated to said Board, shall not exceed the respective amounts indicated, and shall be to the respective parties designated—such being the lowest and best bidders as heretofore duly determined by said Board in full compliance with law appertaining thereto.

Section 3. This ordinance shall be in full force and effect from and after its passage and appproval by the Mayor.

INTRODUCTION OF SPECIAL ORDINANCES

SPECIAL ORDINANCE No. 3, 1943

AN ORDINANCE accepting the sum of Twenty-Seven Thousand Three Hundred and Seven Dollars (\$27,307.00) from the United States Government for the use and benefit of the Indianapolis City Hospital, authorizing the Superintendent of said Indianapolis City Hospital to enter into an agreement with the said United States Government concerning a program for nurse cadets, providing for the acceptance of future sums from the

said United States Government under said program, establishing a fund for the deposit and withdrawal of said funds; and fixing a time when the same shall take effect.

- WHEREAS, the United States Government has proposed to the Indianapolis City Hospital and the City of Indianapolis to establish and subsidize a cadet nurse training course under the provisions of Public Law 74 of the 78th Congress of the United States; and,
- WHEREAS, said program provides for pre-cadet nurses during the first nine (9) months of the training period, junior cadet nurses following said nine (9) months training for a peeriod of from seventeen (17) months to twenty-one (21) months, and senior cadet nurses for those who have completed the required period of combined study and practice but have not completed the remaining time required for graduation; and,
- WHEREAS, the United States Government has proposed to pay to said Indianapolis City Hospital the following sums for the support and maintenance of cadet nurses: Pre-cadet nurses Fifteen Dollars (\$15.00) per month and junior cadet nurses Twenty Dollars (\$20.00) per month; and,
- WHEREAS, said program provides for the payment of expenses of senior cadet nurses by the Indianapolis City Hospital and the City of Indianapolis; and,
- WHEREAS, payments under said plan are to be made on a quarterly pre-payment basis for estimated expenditures, in accordance with the approved plan; and,
- WHEREAS, under the terms of said plan there has now been submitted to the Indianapolis City Hospital and the City of Indianapolis a payment of Twenty-Seven Thousand Three Hundred and Seven Dollars (\$27,307.00) by the United States Government for the quarter from July 1st, 1943, to and including October 1st, 1943; and,

WHEREAS, it is deemed advisable and in the best interest of the City of Indianapolis that the aforesaid plan and payments thereunder be accepted and approved; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Superintendent of the Indianapolis City Hospital be authorized and empowered to take whatever steps are necessary and to execute all necessary instruments to the effectual institution of said plan of the United States Government for cadet nurse training and that any and all acts and things done prior hereto by said Superintendent of the Indianapolis City Hospital in the furtherance of said program be and are hereby approved.

Section 2. That the Superintendent of the Indianapolis City Hospital be authorized and empowered to accept from the United States Government the check for Twenty-Seven Thousand Three Hundred and Seven Dollars (\$27,307.00), presently held by said Superintendent, to be applied upon said nurse cadet training program in accordance with the rules and regulations promulgated by the United States Government for the disbursement of said funds; that said check for Twenty-Seven Thousand Three Hundred and Seven Dollars (\$27,307.00) shall be kept in "Donations to City Hospital Funds", created by Special Ordinance No. 7, 1938, in a separate division of said fund, subject to disbursement by the Controller of the City of Indianapolis upon vouchers properly presented to said Controller by the Superintendent of said City Hospital, said Controller to make due accounting as in the case of other funds of the City of Indianapolis.

Section 3. That said Superintendent of the Indianapolis City Hospital is hereby empowered and authorized to accept and apply any future funds received under the aforesaid program from the United States Government in the same manner and under the same conditions as provided for the Twenty-Seven Thousand Three Hundred and Seven Dollars (\$27,307.00) in Section 2 of this ordinance.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
