The Common Council of the City of Indianapolis met in the Council Chamber at the City Hall, Saturday, January 1, 1944, at 12:00 Noon, with Frank J. Noll, Jr., City Clerk, acting as temporary Chairman, pursuant to the following call:

You are hereby notified that there will be a SPECIAL MEETING of the COMMON COUNCIL held in the Council Chamber on Saturday, January 1, 1944, at 12:00 o'clock noon, the purpose of such SPECIAL MEETING being to elect officers of the Common Council for the year 1944, who shall serve until the first Monday of January, 1945; the appointment of the Council's standing committees for the year 1944 and the appointment of the Council's representative on the City Plan Commission; to receive any communications from the Mayor and other city officials; receive reports from standing and special committees of the Council on all ordinances, resolutions and any other matters pending before the Council; the introduction of appropriation, general and special ordinances and resolutions; call for and consider ordinances and resolutions on second reading and final action and receive any amendments on ordinances and resolutions pending before the Council; consider any unfinished or new business before the Council; and call for and consider on second reading and final action, and receive amendments, the following ordinances and resolutions: Appropriation Ordinances Nos. 86, 87, 88, 89, 90, 48, 82, 83, 84, 85; General Ordinances Nos. 71, 85, 90; Resolution No. 11, (all in the year 1943); and any other acts incident thereto.

APPROPRIATION ORDINANCE No. 86, 1943

AN ORDINANCE of the City of Indianapolis, Indiana, appropriating the sum of Five Hundred Sixty Thousand Seven Hundred Ninety-Five Dollars and Eighty-Three Cents (\$560,795.83) from the proceeds of the sale of certain City of Indianapolis Barrett Law Deficiency Bonds for the payment of deficiencies in the various improvement funds, arising because of prepayment of assessments and the consequent stoppage of interest by operation of law or by the failure to collect interest to the due date of the prepaid installments thereof; and because of the diversion of certain funds paid on one improvement roll and account to the payment of bonds and coupons chargeable to another roll and account; and because of the loss of certain Barrett Law funds by the closing and insolvency of certain banks in which said funds were on deposit; and because of certain other diversions or misapplication of certain of such funds, resulting in the non-payment of certain bonds and coupons to which such collected funds should have been applied, not provided for in existing budgets and levies; and fixing a time when the same shall take effect.

Said public hearing will be held in the Council Chamber at the City Hall on the above named date, at the hour of 12:00 o'clock noon, at which time all taxpayers may appear and be heard on the question of the necessity for said additional appropriations.

The additional appropriations as finally made will be automatically referred to the Indiana Tax Board, 231 State House, Indianapolis, Indiana, which board will hold a further hearing within fifteen days at its office, or at such other place as may be designated. At such hearing, taxpayers objecting to any such additional appropriations may be heard. Interested taxpayers may inquire of the Indiana Tax Board as to when and where such hearing will be held.

The taxpayers of the City of Indianapolis, Ind., are hereby notified that the Common Council of said city, on the 6th day of December, 1943, by the adoption of General Ordinance No. 84, 1943, which ordinance was approved by the Mayor of said City on the 7th day of December, 1943, authorized the issuance and sale of City of Indianapolis Barrett Law Deficiency Bonds in the sum of Five Hundred Sixty Thousand Seven Hundred Ninety-Five Dollars and Eighty-Three Cents (\$560,795.83) for the purpose of providing funds for the payment of deficiencies in the various improvement funds, arising because of prepayment of assessments and the consequent stoppage of interest by operation of law or by the failure to collect interest to the due date of the prepaid installments thereof, and because of the

diversion of certain funds paid on one improvement roll and account to the payment of bonds and coupons chargeable to another roll and account, and because of the loss of certain Barrett Law funds by the closing and insolvency of certain banks in which said funds were on deposit, and because of certain other diversions or misapplication of certain of such funds, resulting in the non-payment of certain bonds and coupons to which such collected funds should have been applied, arising on account of portions of Barrett Law bonds and coupons maturing subsequent to January 1, 1929, for which no provision has been made in the existing budget and tax levies.

Said City of Indianapolis Barrett Law Deficiency Bonds will be payable serially over a period of twenty (20) years, beginning on July 1, 1945, and are to bear interest at a rate not exceeding four (4) per cent per annum, the exact rate of interest to be determined by bidding.

The net assessed valuation of taxable property in the City of Indianapolis is \$541,962,840.00 and the outstanding indebtedness of said city, exclusive of the above mentioned bonds, is in the amount of \$8,048,090.58.

Objections to the issuance of said bonds may be made by ten (10) or more taxpayers by filing a petition in the office of the auditor of Marion County, Indiana, within the time and in the manner prescribed by statute, which petition, if any, will be heard and considered by the State Board of Tax Commissioners in the manner provided by law.


