Since the passage of said General Ordinance No. 85, this committee has given careful consideration to the said appropriation ordinance together with other suggested matters pertinent to both of said ordinances.

When the matter of a codification of ordinances was proposed by the City Clerk he suggested that a compilation of statutes affecting the City of Indianapolis be also included. This suggestion was made because of the numerous amendments to the Cities and Towns law and the many supplemental acts making it difficult for anyone to readily ascertain the law. At that

time this proposal received the hearty approval of the city legal department.

Your committee now believes that the inclusion of a compilation of the statutes would not only be of great benefit to the city administration and to the public but would result in a larger sale of the publication, and at a much higher price.

Your committee therefor recommends that Appropriation Ordinance No. 84, 1943 be stricken from the files of this Council; that General Ordinance No. 85, 1943 be repealed and that a new and more comprehensive ordinance be introduced to take its place.
