Section 3. That any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00) to which may be added imprisonment not exceeding One Hundred Eighty (180) Days.

Section 5. This ordinance shall be in full force and effect upon its passage, approval by the Mayor, and publication according to law.


