Section 1. That it shall be unlawful for the operator of any vehicle to park the same or suffer, permit or allow the same to be parked at any time upon the following part of South Pennsylvania Street in the City of Indianapolis, to-wit:

(a) On the east side of South Pennsylvania Street from the south curb line of McCarthy Street to the north curb line of Ray Street.

Section 2. That it shall be unlawful for the operator of any vehicle to park the same or suffer, permit or allow the same to be parked for a period of time longer than one and one-half $(1\frac{1}{2})$ hours between the hours of 7:00 o'clock a. m. and 6:00 o'clock p. m. on any day of the week excepting Sundays and holidays on the following part of Ludlow Avenue in the City of Indianapolis, to-wit:

(b) On the east side of Ludlow Avenue beginning at the north curb line of East 18th Street and extending north a distance of five hundred (500) feet.

Section 3. That Section 44 of General Ordinance No. 96, 1928, as amended, be and the same is hereby amended to include the following sub-section, to-wit:

(129) McCarty Street, at its intersection with South Pennsylvania Street.

Section 4. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding One Hundred Eighty (180) days.

Section 5. This ordinance shall be in full force and effect upon its passage, approval by the Mayor, and publication according to law.

"18 foot 'loading zone' on the south side of East Michigan Street starting at a point 41 feet east of the east curb line of Arsenal Avenue and extending east a distance of 18 feet."

Section 2. This ordinance shall be in full force and effect upon its passage and approval by the Mayor.
