BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 26 of General Ordinance No. 96, 1928, regarding loading zones, as amended, be and the same is hereby amended to provide that "one-car" loading zones shall cover a space of twenty-five (25) feet, and that "two-car" loading zones shall cover a space of fifty (50) feet.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all law pertaining thereto.

AN ORDINANCE establishing a certain passenger and/or loading zone pursuant to Section 26 of General Ordinance No. 96, 1928, as amended; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That, for the purpose of providing the owners and/or occupants of certain premises fronting on a certain street in Indianapolis with ingress and egress for passengers, materials and supplies coming to or going from same, such owners and/or occupants having complied with all laws relative to the establishment of passenger and/or loading zones, and the Board of Safety having caused investigation to be made thereof and having recommended its establishment pursuant to the terms of Section 26 of General Ordinance No. 96, 1928, as amended, the following be and the same is hereby established as a passenger and/or loading zone, to-wit:

"36 foot 'loading zone' on the west side of South Meridian Street beginning at a point 60 feet south of the south curb line of Jackson Place and extend south for a distance of 36 feet."

Section 2. This ordinance shall be in full force and effect upon its passage and approval by the Mayor.

GENERAL ORDINANCE No. 87, 1944

AN ORDINANCE authorizing the City of Indianapolis to make a temporary loan in the sum of Seventy Thousand Dollars (\$70,000) for the use of Board of Trustees of the Firemen's Pension Fund of said city, in anticipation of and payable out of the current taxes for the Firemen's Pension Fund actually levied for said fund and in the course of collection for the final year in which said loan is made payable; and fixing a time when the same shall take effect.

WHEREAS, heretofore on the 30th day of October, 1944, the Board of Trustees of the Firemen's Pension Fund of the City of Indianapolis, Indiana, has, by resolution duly adopted, determined to make a temporary loan in the sum of Seventy Thousand Dollars (\$70,000) principal amount, without considering the interest thereon to be added thereto in a sum not to exceed Three Hundred Dollars (\$300.00), in anticipation of and payable out of the current taxes for the Firemen's Pension Fund actually levied and in the course of collection for the fiscal year in which loan is made payable, and has requested the Common Council of the City of Indianapolis to authorize such temporary loan; and

WHEREAS, the Board of Trustees of the Firemen's Pension Fund of the City of Indianapolis is now and will continue to be until on

or about the 15th day of May, 1945, without sufficient funds to meet the payment of pensions and benefits to retired members and dependents of deceased members and other death benefits, and for other necessary current and incidental expenses of the year 1945 as provided in the annual budget of 1945 payable out of the Firemen's Pension Fund; and

WHEREAS, the first semi-annual installment of taxes levied by the City of Indianapolis for the use of the Firemen's Pension Fund for the year 1945 will amount to more than Seventy Thousand Dollars (\$70,000); NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City Controller of the City of Indianapolis is hereby authorized and empowered to negotiate a temporary loan in the year 1945, for the use and benefit of the Board of Trustees of the Firemen's Pension Fund of the City of Indianapolis, Indiana, in anticipation of the current taxes for said Firemen's Pension Fund actually levied in the year 1944 and in the course of collection in the fiscal year 1945 for the use of the Firemen's Pension Fund, not to exceed the sum of Seventy Thousand Dollars (\$70,000); without considering the interest thereon to be added thereto, for a period not to exceed the time hereinafter fixed in this ordinance, at a rate of interest not to exceed four per cent (4%) per annum, the rate of interest to be fixed by the lowest interest bid for said loans. Said loan shall run for a period not exceeding One Hundred Thirty-Five (135) days. The City Controller is authorized to make sale of said time warrants after a notice thereof shall have been published once each week for two consecutive weeks in two newspapers of general circulation, printed in the English language and published in the City of Indianapolis, and said sale to be not less than ten (10) days after the last publication of said notice. Said time warrants are to be signed by the Mayor of the City of Indianapolis and the City Controller, countersigned by the president of the Board of Trustees of the Firemen's Pension Fund of said city, and attested by the City Clerk, and the seal of the City of Indianapolis to be attached thereto, and said time warrants shall be payable at the office of the City Treasurer of the City of Indianapolis, and to the payment of said time warrants the current revenues and taxes levied in the year 1944 and payable in

the year 1945 for the Firemen's Pension Fund of the City of Indianapolis are hereby irrevocably appropriated and pledged.

Section 2. That for the repayment of the principal amount of the temporary loan herein authorized by this ordinance there is hereby appropriated to Fire Pension Fund No. 63—Payment of Temporary Loans (hereby created) out of the current revenues and taxes for the year 1944, payable in the year 1945, for the Firemen's Pension Fund of the City of Indianapolis, the sum of Seventy Thousand Dollars (\$70,000); and for the payment of the interest thereon there is hereby appropriated to Fire Pension Fund No. 61—Interest on Temporary Loans, out of the above designated revenues and taxes the sum of Three Hundred Dollars (\$300.00).

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

GENERAL ORDINANCE No. 88, 1944

AN ORDINANCE authorizing the City Controller of the City of Indianapolis to make a temporary loan in the sum of Seven Hundred Fifty Thousand Dollars (\$750,000.00) in anticipation of current taxes of the City of Indianapolis actually levied and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

WHEREAS, the City of Indianapolis is now and will continue to be until on or about the 15th day of May, 1945, without sufficient funds to meet current expenses for the year 1945 for municipal purposes as provided in the annual budget of 1945; and

WHEREAS, the first semi-annual installment of taxes for the year 1945 will amount to more than Seven Hundred Fifty Thousand Dollars (\$750,000.00); NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City Controller is hereby authorized and empowered in the year 1945 to negotiate a temporary loan in anticipation of the current taxes for the general fund of the City of Indianapolis actually levied in the year 1944 and in the course of collection in the fiscal year 1945, not to exceed the sum of Seven Hundred Fifty Thousand Dollars (\$750,000.00) without considering the interest thereon to be added thereto, for a period not to exceed the time hereinafter fixed in this ordinance, at a rate of interest not to exceed four (4) per cent per annum, the rate of interest to be fixed by the lowest interest bid for said loan. Said loan shall run for a period not exceeding one hundred thirty-five (135) days. The City Controller is authorized to make sale of said time warrants, after a notice thereof shall have been published by the City Controller once each week for two consecutive weeks in two newspapers of general circulation, printed in the English language and published in the City of Indianapolis, and said sale to be not less than ten (10) days after the last publication of said notice. Said time warrants are to be signed by the Mayor of the City of Indianapolis and the City Controller, and attested by the City Clerk of the City of Indianapolis, and the seal of the City of Indianapolis to be attached thereto, and said time warrants shall be payable at the office of the City Treasurer in the City of Indianapolis, Indiana; and to the payment of said time warrants the current revenues and taxes thus levied in the year 1944, payable in the year 1945, for the General Fund of the City of Indianapolis, are hereby irrevocably appropriated and pledged.

Section 2. For the repayment of the principal amount of the temporary loan herein authorized by this ordinance there is hereby appropriated to the City Controller's 1945 budget fund No. 63—Payment of Temporary Loans (hereby established) out of the current revenues and taxes levied in the year 1944, payable in the year 1945, for the General Fund of the City of Indianapolis, the sum of Seven Hundred Fifty Thousand Dollars (\$750,000.00); and for the payment of the interest thereon there is hereby appropriated to the City Controller's 1945 budget Fund No. 61-2—Interest on Temporary Loans, out of the above designated revenues and taxes the sum of Two Thousand Two Hundred Fifty Dollars (\$2,250.00).

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor, and compliance with all law pertaining thereto.

AN ORDINANCE authorizing the City of Indianapolis to make temporary loans in the year 1945 for the use of the Department of Public Health and Charities as follows: One Hundred Twenty-Five Thousand Dollars (\$125,000.00) for Department of Health General Fund; Twenty-Five Thousand Dollars (\$25,000.00) for the School Health Fund of said Department; and Twenty Thousand Dollars (\$20,000.00) for the Tuberculosis Fund of said Department; all of said loans to be made in anticipation of and payable out of the current taxes of said Department of Public Health and Charities actually levied for the funds above set out and in the course of collection for the fiscal year in which said loans are made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loans shall mature; and fixing a time when the same shall take effect.

WHEREAS, certain funds of the Department of Public Health and Charities of the City of Indianapolis, namely,

1. Department of Health General Fund
2. Tuberculosis Fund
3. School Health Fund

do not at this time contain, and will not, without temporary loans, contain sufficient monies to meet payrolls and current expenses of the year 1945 as provided in the annual budget of 1945 necessary for the carrying on of the functions of said Department and payable out of Funds above specified of said Department of Health beyond the 10th day of January, 1945; and

WHEREAS, the first semi-annual installment of taxes levied by the City of Indianapolis for general Department of Health purposes for the year 1945, will amount to more than One Hundred Twenty-Five Thousand Dollars (\$125,000.00); for the School Fund of said Department for the year 1945 will amount to more than Twenty-Five Thousand Dollars (\$25,000.00); and for the

Tuberculosis Fund of said Department for the year 1945 will amount to more than Twenty Thousand Dollars (\$20,000.00); NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City Controller of the City of Indianapolis is hereby authorized and empowered to negotiate in the year 1945, temporary loans for the use of the Department of Public Health and Charities of said city, in anticipation of the current taxes of said Department actually levied in the year 1944 and in course of collection in the year 1945 for the use of the designated funds of said Department set out herein, as follows: Department of Health General Fund, One Hundred Twenty-Five Thousand Dollars (\$125,000.00); Tuberculosis Fund Twenty Thousand Dollars (\$20,000.00); and School Health Fund Twenty-Five Thousand Dollars (\$25,000.00), without considering the interest thereon to be added to the respective loans, for a period not to exceed the time hereinafter fixed in this ordinance, at a rate of interest not to exceed four per cent (4%) per annum, the rate of interest to be fixed by the lowest interest bid for said loans. Said loans shall run for a period not to exceed one hundred thirty-five (135) days. The City Controller is authorized to make sale of said time warrants for said temporary loans after a notice thereof shall have been published by the City Controller once each week for two consecutive weeks in two newspapers of general circulation, printed in the English language and published in the City of Indianapolis, and said sale shall not be less than ten days after the last publication of said notice. Said time warrants are to be signed by the Mayor of the City of Indianapolis, and the City Controller, countersigned by the President of the Board of Health, and attested by the City Clerk, the seal of the City of Indianapolis to be attached thereto, and said time warrants of said respective loans shall be payable at the office of the City Treasurer of the City of Indianapolis; and to the payment of said time warrants the current revenues and taxes levied in the year 1944, payable in the year 1945, for the Department of Health General Fund, the Tuberculosis Fund, and the School Health Fund of said Department of Public Health and Charities of the City of Indianapolis, are hereby irrevocably appropriated and pledged.

Section 2. That for the repayment of the principal amounts of the temporary loans herein authorized by this ordinance there are

hereby appropriated out of the above designated current revenues and taxes levied in the year 1944, payable in the year 1945, to the following designated 1945 Budget funds of the Department of Public Health and Charities:

GENERAL ORDINANCE No. 90, 1944

AN ORDINANCE amending Section 44 of General Ordinance No. 96, 1928, as amended, to certain parts of East 19th Street preferential; also regulating parking on certain streets in the City of Indianapolis; providing a penalty for violation thereof; and fixing a time when this ordinance shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 44 of General Ordinance No. 9, 1928, establishing certain preferential streets in the City of Indianapolis, Indiana, be amended to include the following parts of East 19th Street, to-wit:

“East 19th Street preferential from Monon Railroad right-of-way east to Hillside Avenue (with the exception of Martindale Avenue)—it to remain preferential over 19th Street.”

Section 2. That it shall be unlawful for the operator of any vehicle to park the same or suffer, permit or allow the same to be parked for a longer period of time than one and one-half (1½) hours between the hours of 7:00 o'clock a. m. and 6:00 o'clock p. m. on every day of the week excepting Sundays and holidays, upon the following parts of streets in the City of Indianapolis, Indiana, to-wit:

“On both sides of South Delaware Street from the south curb line of McCarty Street south to the north curb line of Wyoming Street, and on the south side of East McCarty Street from the west curb line of Delaware Street west to the railroad elevation.”

“On both sides of West Morris Street from the west end of the White River Bridge to the east curb line of Kentucky Avenue (1,000).”

Section 3. Any person violating any provision of Section 2 hereof shall, upon conviction, be fined in any sum not exceeding \$300.00, to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 4. This ordinance shall be in full force and effect upon its passage, approval by the Mayor, and publication according to law.

GENERAL ORDINANCE No. 91, 1944

AN ORDINANCE providing for the issuance, without any charge excepting for postage, of certified copies of birth certificates to be used in connection with the filing for Veteran's Benefits by Veterans, members of their immediate families and/or dependents upon presentation of a proper referral card.

WHEREAS, many veterans of wars of the United States, members of their immediate families and/or dependents are required to furnish copies of birth certificates, marriage ceremonies and death records in connection with filing for veteran's benefits; and

WHEREAS, Copies of all such records and certificates, excepting birth certificates, are now furnished to them free of charge by the County Clerk and State Board of Health,—such birth certificates being furnished by the City Health Department at a charge of fifty cents (50c); and

WHEREAS, It seems desirable for the purpose of uniformity, as well as a token of appreciation for their services rendered to the country in time of war, that birth certificates should also be issued free of charge to such veterans, members of their immediate families and/or dependents; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That veterans of wars of the United States, members of their immediate families and/or dependents be and the same are hereby exempted from any charges except postage (in case of mailing) for the issuance of copies of birth certificates to be used in connection with filings for Veteran's Benefits, and that such copies of such certificates, including certification, are to be free of charge for such purpose, upon presentation by said applicant and/or applicants of a written referral card executed by a responsible veterans agency recognized and approved by the City Controller.

Section 2. This ordinance shall be in full force and effect upon its passage, approval by the Mayor and compliance with all laws pertaining thereto.
