

REGULAR MEETING

Monday, January 7, 1974, 7:00 p.m.

A Regular Meeting of the City-County Council of Indianapolis-Marion County convened in the Council Chambers of the City-County Building at 7:00 p.m., Monday, January 7, 1974. President Hasbrook in the Chair. Councilman Griffith opened the meeting with prayer, followed by the Fledge of Allegiance.

SPECIAL ORDINANCE NO. 2, 1973, changing the name of a certain street in Marion County, Indiana.

SPECIAL ORDINANCE NO. 3, 1973, extending the boundaries of the Fire Special Service District of the City of Indianapolis, amending the Code of Indianapolis and Marion County, 1973, and fixing a time when the same shall be effective.

President Hasbrook called for presentation of petitions and turned the gavel over to Councilman SerVaas. Councilman SerVaas stated the next order of business would be the election of officers of the City-County Council for the year 1974. - WHEREAS, Phyllis W. Waters served this community for 57 years as a political, educational and cultural leader; and
- WHEREAS, Phyllis W. Waters influenced and enriched the lives of thousands of young people in this community through her 51 years of service to the Indianapolis Public Schools as a teacher; and
- WHEREAS, Phyllis W. Waters served this Council as a City Councilwoman in 1967; and
- WHEREAS, Phyllis W. Waters served her community and fellow citizens by her service to the Indiana State Teachers Association, the Indiana Civil Rights Commission, the Girl Scouts of America, the YMCA, the Indiana Education Commission, the Board of Directors of the Indianapolis-Marion County Public Library, the Indianapolis Museum of Art, the Indianapolis Urban League, Citizens Forum, Inc., the Children's Museum, the Indianapolis Zoological Society, and the Greater Indianapolis Information, Inc.; and
- WHEREAS, Phyllis W. Waters served the Republican Party as a Precinct Committeewoman and as a Ward Chairman; now, therefore:
- BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

INTRODUCTION OF PROPOSALS

PROPOSAL, NOS. 1-22, 1974. Introduced by Councilman Egenes. The Clerk read the proposal entitled "A proposal for Rezoning Ordinances certified from the Metropolitan Development Commission on December 21, 1973;" and the President referred them to the Committee of the Whole to be heard under Special Orders—Final Adoption.

PROPOSAL NO. 23, 1974. Introduced by Councilman McPherson. The Clerk read the proposal entitled "A proposal for a General Resolution approving the annexation and incorporation of an additional territory into the Indianapolis Sanitary District;" and the President referred it to the Public Works Committee.

PROPOSAL NO. 24, 1974. Introduced by Councilman Kimbell. The Clerk read the proposal entitled: "A proposal for a General Ordinance amending the Fire Code, Title 5 of the "Code of Indianapolis and Marion County, 1970" as amended, modifying certain provisions of said Fire Code and establishing standards for fire hydrants;" and the President referred it to the Public Safety Committee.

PROPOSAL NO. 25, 1974. Introduced by Councilman Cottingham. The Clerk read the proposal entitled: "A proposal for a Fiscal Ordinance amending the CITY-COUNTY ANNUAL BUDGET FOR 1974 and appropriating the sum of \$18,102.00 for certain purposes of the Juvenile Court of Marion County by reducing the Unappropriated County General Fund;" and the President referred it to the County and Townships Committee.

PROPOSAL NO. 26, 1974. Introduced by Councilman Hasbrook. The Clerk read the proposal entitled: "A proposal for a General Resolution requiring the libraries in the Indianapolis Public Library System to establish, maintain and operate a "current" file of materials relating to the business of the Indianapolis City-County Council;" and the President referred it to the Rules and Policy Committee.

PROPOSAL NO. 27, 1974. Introduced by Councilman Kimbell. The Clerk read the proposal entitled: "A proposal for a General Ordinance prohibiting the discharge of fire arms and regulating hunting in the Consolidated City and fixing penalties for violation thereof;" and the President referred it to the Public Safety Committee.

PROPOSAL NO. 28, 1974. Introduced by Councilman Byrum. The Clerk read the proposal entitled: "A proposal for a General Resolution approving the actions of the Transportation Board with respect to certain capital improvements within the Metropolitan Thoroughfare District;" and the President referred it to the Transportation Committee.

SPECIAL ORDERS—PUBLIC HEARING

President Hasbrook called for proposals eligible for public hearing. Members of the public were invited to be heard on proposals eligible for public hearing. The Council recessed to the Committee of the Whole at 7:40 p.m. and reconvened at 8:20 p.m.

During the recess, Proposal No. 496, 1973, was heard.

PROPOSAL NO. 496, 1973. President Hasbrook stated that the Petitioners and Remonstrators on Proposal No. 496, 1973, would each have fifteen minutes to present their case. James Beatty, attorney for the Petitioners, spoke in favor of the proposal and presented slides for emphasis. Attorney James Quinn and several remonstrators spoke in opposition to the proposal.

After lengthy discussion during which Councilmen Griffith and Clark spoke in opposition to the proposal, Councilman Clark moved, seconded by Councilman Griffith, that Proposal No. 496, 1973, be rejected. A PROPOSAL FOR A GENERAL ORDINANCE amending the "Municipal Code of Indianapolis, 1951," as amended, and more particularly Title 4, Chapter 6 thereof, ONE-WAY STREETS AND ALLEYS, providing penalties, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

Section 1. Title 4, Chapter 6, Section 602 thereof, ONE-WAY STREETS AND ALLEYS be, and the same is hereby amended by the DELETION of the following:

West Michigan St. Blake St. White River Pkwy., West Dr.

Direction District
West 16

Section 2. Title 4, Chapter 6 thereof, ONE-WAY STREETS AND ALLEYS, is hereby amended by the addition of the following section:

Section 605. INTERIM ONE-WAY STREETS

The streets hereinafter described shall be one-way streets during the period indicated. At the end of the interim period, the traffic flow on said streets shall be as provided by this code without reference to this section.

Section 3. This amendment shall be subject to the penalties as provided in Title 1, Chapter 1-601, of the Municipal Code of Indianapolis 1951, as amended.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.
