Mr. McKinney also held directorships in a number of corporations across the country. He was an Army Colonel during the Second World War. He held two federal posts in his lifetime: Assistant Director of the Office of Contract Settlement and Chairman of the Defense Housing Com-

mission. In addition, Frank E. McKinney Sr. served as the Marion County Treasurer for four years. He was a former treasurer of the County and State Democratic Central Committees, a former Vice-Chairman of the Democratic National Finance Committee, and a former National Chairman of the Democratic Party. He maintained partial ownership and directorship in several professional athletic teams and served on dozens of foundations, clubs, boards, and commissions. He was a member of St. Luke Catholic Church and was named by Pope Pius XII to be a member of the Knights of Malta, one of the highest honors for a Catholic layman.

Section 3. The City-County Council does hereby acknowledge Frank E. McKinney, Sr. as one of the leading citizens in the history of this community and does hereby acknowledge his exemplary life in this memorial record.

Captain Greene was an Indiana State Police Officer for seven years prior to his service with the Indianapolis Police Department. He was president of the Christ the King Home School Association; a coach, manager, and officer of the White River Little League; and a nine year veteran of the Indiana National Guard. As a tribute to his ability and perseverance, in 1972, under his direction of the Homicide Branch of the Indianapolis Police Department, no murders were unsolved in the City of Indianapolis.

#### CITY-COUNTY GENERAL ORDINANCE NO. 3, 1974

A GENERAL ORDINANCE amending the Fire Code, Title 5 of the Code of Indianapolis and Marion County, 1970, as amended, modifying certain provisions of said Fire Code and establishing standards for fire hydrants.

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

Section 1. Section 5-1005 of Title 5 of the "Code of Indianapolis and Marion County, 1970" is amended by adding an additional sub-paragraph (3) to read as follows: Notwithstanding the other provisions of this section, the only portable fire extinguisher equipment required for apartment type buildings shall be those set out in the following schedules:

Type 1. Enclosed common entry hall, 2-1/2 story, apartment.

Requirement: Type 1 - 2A 10BC fire extinguisher on 2nd and 3rd floors.

Type 2. Two story, 4 units per entry (2 upstairs, 2 downstairs), patio door on all units.

A. Balcony on rear of second story units - no stairway

Requirement: 2A 10BC fire extinguisher in hall and/or 1A 10BC fire extinguisher in individual units on the floor level required.

B. Balcony on rear, stairway, patio door.

Requirement: One (1) 2A 10BC fire extinguisher per common entry

C. Rear Entry from first floor hall with first floor apartments having patio exits.

Requirements: One (1) 2A 10BC fire extinguisher per common entry

Type 3. One story, outside entrance to all units (motel type) or two stories outside stairway, no rear entrance.

Requirement: None

Type 4. Three stories or less with an outside entrance to each unit, and an enclosed Common Entry Hall or Corridor.

A. No rear entrance, patio door or balcony, 1 stairway

Requirement: One (1) 2A 10BC fire extinguisher per common entry

B. Stack on back of units with outside stairway

Requirement: One (1) 2A 10BC fire extinguisher per common entry

Type 5. Up to three story corridor type unit with two or more ingress or egress points per floor and more than four units per corridor.

Requirement: 2A 10BC fire extinguisher in hall and/or 1A 10BC fire extinguisher in individual units on the floor level required; and/or

A 2A 10BC fire extinguisher is required on each corridor floor, travel distance between extinguishers to be no more than 75 feet, provided there is no other access to individual units other than the corridor.

Type 6. Three or more stories, elevator type, two or more stairways, no standpipes.

Requirement: 2A 10BC fire extinguisher, in hall and/or 1A 10BC fire extinguisher in individual units on the floor level required; and/or

A 2A 10BC fire extinguisher is required on each corridor floor, travel distance between extinguishers to be no more than 75 feet, provided there is no other access to individual units other than the corridor.

Type 7. Three or more stories, elevators, two or more stairways, with standpipes, built-in fire hoses.

Requirement: 2A 10BC fire extinguisher in hall and/or 1A 10BC fire extinguisher in individual units on the floor level required; and/or

A 2A 10BC fire extinguisher is required on each corridor floor, travel distance between extinguishers to be no more than 75 feet, provided there is no other access to individual units other than the corridor.

Type 8. Townhouses

Requirement: None

Type 9. Laundry Rooms

Requirement: A 2A 10BC type ABC Fire Extinguisher shall be placed at the entrance to all laundry rooms. Extinguishers can be placed either inside entrance door or located on outside of entrance door.

- Section 2. Section 5-207 of Title 5 of the Code of Indianapolis and Marion County, 1970, be, and is hereby amended by adding an additional clause after clause No. (6) to be numbered (7) and read as follows:
  - (7) The existence of recognized hazards, practices, and conditions which might cause loss of life or property.
- Section 3. Title 5 of the Code of Indianapolis and Marion County, 1970, as amended, be, and is hereby, further amended by adding an additional section to be numbered 5-2627 which shall read as follows:
  - 5-2627. Fire Hydrant Standards.—whenever the provisions of this Code require the installation of a fire hydrant, whether on public or private property, such hydrant shall meet the following specifications: (1) It shall be equipped with five-inch valves; (2) It shall be constructed with two 2-1/2 inch hose nozzles, with national standard threads of 7-1/2 per inch; (3) It shall be equipped with one 4-1/2 inch steamer nozzle with six "V" threads per inch; (4) It shall be constructed to be opened by turning clockwise a national standard pentagon operating nut; (5) The source of water supply shall be buried five feet below the ground level at the hydrant; (6) The hydrant shall be constructed a break-off feature to prevent the hydrant from leaking when damaged by collision.

Section 4. Title 5 of the Code of Indianapolis and Marion County, 1970, as amended, be, and is hereby, further amended by deleting Section 5-257 in its entirety.

Section 5. This Ordinance shall be in full force and effect from and after adoption.
