Upon recommendation of the Street Commissioner, the Board of Public Works and Sanitation respectfully requests that you cause to be prepared an ordinance appropriating the sum of \$4,513.00, from the unexpended and unappropriated balance of the General Fund 1936 into Street Commissioner's Sewer Sanitation Division No. 12-2, and submit the same to the Common Council at its next meeting with the recommendation of the Board that the same be passed.

This additional appropriation is made necessary due to the increased amount of work caused by the sewers getting older and a greater liability to maintain, coupled with the increased amount of

new buildings where this department is compelled to locate the sewer connection.

Last year the Street Commissioner requested that the sewer department be increased to 40 hours per week but the County Tax Adjustment Board reduced the same to 32 hours.

This department cannot take care of the numerous complaints without increased working hours.

INTRODUCTION OF APPROPRIATION ORDINANCES

APPROPRIATION ORDINANCE NO. 24, 1937

AN ORDINANCE appropriating to a certain designated fund in the Street Commissioner's budget the sum of Four Thousand Five Hundred Thirteen Dollars (\$4513.00) from the unappropriated and unexpended 1936 balance of the general fund, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Four Thousand Five Hundred Thirteen Dollars (\$4513.00) is hereby appropriated from the unappropriated and unexpended 1936 balance of the general fund to the Department of Public Works, and said sum is allocated to the following designated fund of said department, as per 1937 budget classification:

Section 2. The sum appropriated by Section 1 hereof is made necessary by the increase of the weekly working hours of the employees in the sewer sanitation division of the Street Commissioner's Department of the Department of Public Works, from 32 hours to 40 hours.

Section 3. This ordinance shall be in effect from and after its passage and approval by the Mayor.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES

SPECIAL ORDINANCE NO. 5, 1937

AN ORDINANCE annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect.

BE IT ORDAINED BY COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City of Indianapolis, Indiana, be and the same is hereby extended so as to include the following described territory, which is hereby annexed to and made a part of the territory constituting the City of Indianapolis:

Beginning at the southeast corner of the north half of the northwest quarter of Section Five (5), Township Fifteen (15) North, Range Three (3) East, Marion County, State of Indiana; thence west along the south line of the north half of the northwest quarter of the aforesaid Section (5), a distance of 2543.4 feet to the southwest corner of the north half of the northwest quarter of the aforesaid Section Five (5); thence south along the west line of the northwest quarter of the aforesaid Section Five (5), to the southwest corner thereof; thence west, along the south line of the northeast quarter of Section (6) in the aforesaid township and Range, to the southwest corner of the northeast quarter of the aforesaid Section Six (6); thence north along the west line of the northeast quarter of the aforesaid Section Six (6) to the northwest corner of the south half of the northeast quarter of the aforesaid Section Six (6); thence east along the north line of the south half of the northeast quarter of the aforesaid Section Six (6) a distance of 752.4 feet to a point; thence south 35 degrees east, a distance of 399.96 feet to a point; thence north 43 degrees 30 minutes east, a distance of 419.10 feet to a point in the north line of the south half of the northeast quarter of the aforesaid Section Six (6); thence north 26.7 feet to a point; thence east on a straight line, a distance of 1386 feet to a point in the west line of the northwest quarter of the aforesaid Section Five (5), a distance of 1475.10 feet south of the northwest corner thereof; thence north along the west line of the northwest quarter of the

aforesaid Section Five (5), a distance of 545.10 feet to a point; thence east, parallel to the south line of the north half of the northwest quarter of the aforesaid Section Five (5), a distance of 2543.4 feet to a point in the east line of the north half of the northwest quarter of the aforesaid Section Five (5); thence south along the east line of the north half of the northwest quarter of the aforesaid Section Five (5), a distance of 630.7 feet to the place of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

GENERAL ORDINANCE NO. 35, 1937

AN ORDINANCE amending Section 3 and 24 of General Ordinance No. 87, 1935, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 3 of General Ordinance No. 87, 1935, generally known as the Taxicab Ordinance, be amended to read as follows:

“Section 3. Any person, persons, firm, company, association, partnership or corporation issued licenses under this ordinance shall be entitled to have a renewal license issued for each year for each license issued under this ordinance, provided an application for such renewal license is filed with the City Controller within ten (10) days of the date of the expiration of any such license, and provided that said applicant otherwise qualifies for such licenses by complying with all the provisions of this ordinance required as conditions precedent to the issuance of the renewal licenses.

“Any of such licenses may be transferred and assigned to any person, firm, partnership, association or corporation upon application to the City Controller, who, upon payment of a transfer fee of fifty cents (50c) for each of such transfer, shall duly transfer such licenses. Any such licensee may also transfer such license from one cab to another of which such licensee is the owner and/or operator, provided that the first cab be permanently retired from service, upon application to the said controller and the payment of a transfer fee of fifty cents (50c).

“Any such transfer or renewal of license shall be granted upon the application of the person or party who is registered in the office of the Secretary of State of Indiana as the owner of the vehicle for which said license was issued, and where such license was issued jointly to the owner of such vehicle and any other person, firm or corporation designated in the application for such license as an operator having use or control of such vehicle, such transfer or re-

newal shall be granted upon the application of the owner of such vehicle, without requiring the signature of the operator designated as having use or control of such vehicle.

"The City Controller may require any such applicant for transfer or renewal of such license to exhibit the certificate of title issued by the Secretary of State of Indiana for the vehicle for which license was issued, and the person or party in whose name such vehicle is registered in the office of the Secretary of State of Indiana shall be deemed to be the owner thereof.

"If the City Controller shall determine that the public interest is affected by any such application for transfer or renewal of license, he may refer such application for transfer to the Board of Public Safety, and shall grant or refuse such application for transfer of such license upon such terms and conditions as the Board of Public Safety shall fix."

Section 2. That Section 24 of General Ordinance No. 87, 1935 be amended to read as follows:

"Section 24. Any license issued under the provisions of this ordinance may be suspended by the Mayor upon violation by any licensee of any provision of this ordinance, for such period as the Mayor may determine. The Mayor may also revoke at any time any license issued hereunder upon the violation by any licensee of any provision of this ordinance."

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

AN ORDINANCE approving the action of the Board of Public Safety with reference to the transfer of taxicab licenses for the year 1936-1937, numbers 150, 151, 153, 155 and 158, to Thurman C. Ramsey, and fixing a time when the same shall take effect.

WHEREAS, the Board of Public Safety of the City of Indianapolis, on the 18th day of May, 1937, did approve the transfer to Thurman C. Ramsey of taxicab licenses for the year 1936-1937, numbered 150, 151, 153, 155 and 158; NOW THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA :

Section 1. That the common council of the City of Indianapolis, acting under the provisions of Section Six (6) of General Ordinance No. 87, 1935, (as amended by General Ordinance No. 41, 1936), does hereby approve, ratify, and confirm the said action of the Board of Public Safety as set out in the preamble of this ordinance.

Section 2. This ordinance shall be in effect after its passage and approval by the Mayor.
