SPECIAL ORDERS, PUBLIC HEARING

PROPOSAL NO. 111, 1981. This proposal appropriates \$1,500,000 for the County Administrator for construction of the jail modification and addition. Councillor West, sponsor of this proposal and Chairman of the Public Safety and Criminal Justice Committee, stated that this proposal has not been heard in Committee, but would be heard March 26, 1981. Councillor West moved, seconded by Councillor Borst, to postpone Proposal No. 111, 1981, until the next regularly scheduled meeting of the Council on April 6, 1981. The Council gave their consent to postpone Proposal No. 111, 1981.

PROPOSAL NO. 116, 1981. Councillor West stated that this proposal appropriates \$9,824 in the Crime Control Fund for purposes of Superior Court, Criminal Division, Probation Department. In the Public Safety and Criminal Justice Committee on March 11, 1981, Proposal No. 116, 1981, received a "Do Pass" recommendation by a unanimous voice vote. Councillor West explained that this proposal reappropriates a portion of the LEAA grant that has not been spent. President SerVaas asked if any members of the Public wished to testify. There being none, Councillor West moved, seconded by Councillor Gilmer, for adoption of Proposal No. 116, 1981. Proposal No. 116, 1981, was adopted on the following roll call vote; viz:

Proposal No. 116, 1981, was retitled FISCAL ORDINANCE NO. 23, 1981, and reads as follows:

CITY—COUNTY FISCAL ORDINANCE NO. 23, 1981

A FISCAL ORDINANCE amending the City-County Annual Budget for 1981 (City—County Fiscal Ordinance No. 73, 1981), appropriating an additional Nine Thousand Eight Hundred Twenty-four dollars (\$9,824) in the Crime Control Fund for purposes of the Marion County Superior Court - Criminal Division - Probation Department and reducing the unappropriated and unencumbered balance in the Crime Control Fund.

**BE IT ORDAINED BY THE CITY—COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:**

SECTION 1. To provide for expenditures the necessity for which has arisen since the adoption of the annual budget, Section 2.05 of the City-County Annual Budget for 1981, be and the same is hereby amended by the increases and reductions hereinafter stated for the purposes of providing appropriation of remaining 1980 Crime Control Funds in the 1981 budget.

SECTION 2. The sum of Nine Thousand Eight Hundred Twenty-four dollars (\$9,824) be, and the same is hereby appropriated for the purposes as shown in Section 3 by reducing the unappropriated balances as shown in Section 4.

SECTION 3. The following additional appropriations are hereby approved:

SPECIAL ORDERS, UNFINISHED BUSINESS

PROPOSAL NO. 61, 1981. This proposal authorizes the issuance of economic development revenue notes for Henry J. Price & Lorraine M. Price in the amount of \$440,000. Councillor Tintera requested that this proposal be held in Council and Council consent was given.

PROPOSAL NO. 62, 1981. This proposal appropriates \$13,440 for the Marion County Sheriff for one additional employee. Councillor West gave the report of the Public Safety Committee. Councillor Rhodes stated that the Committee recommended "Do Pass As Amended" by a vote of 4-3. Councillor Miller moved, seconded by Councillor Gilmer, to refer Proposal No. 62, 1981, back to the Committee to be studied and have it postponed for 90 days. Councillor West requested that the 90-day provision be deleted from the motion, and consent was given. Proposal No. 62, 1981, was referred back to the Public Safety and Criminal Justice Committee by the following roll call vote; viz:

PROPOSAL NO. 103, 1981. Introduced by Councillor SerVaas, this proposal declares the expansion of the Marion County Jail as a necessity and authorizes construction through the Marion County Building Authority. This proposal was heard in the Public Safety and Criminal Justice Committee on March 3, 1981, at which time it received a "Do Pass As Amended" recommendation by a vote of 6-0-1. On March 9, 1981, Proposal No. 103, 1981, was sent back to Committee for further discussion. The Public Safety and Criminal Justice Committee discussed calling for a Committee of the Whole to discuss Judge Dillin's order dealing with a jail facility to house 1,000 people, indoor and outdoor recreation, medical and dental facilities, and private meeting places for prisoner-attorney discussions. Councillor West noted that the Committee voted 4-2 to request a Committee of the Whole. After further discussion, President SerVaas referred Proposal No. 103, 1981, back to the Public Safety and Criminal Justice Committee.

PROPOSAL NO. 66, 1981. This proposal repeals Section 9-4 of the Code "Location of cemetery". Councillor Durnil reported that this proposal has been heard in the Metropolitan Development Committee where it received a "Do Pass" recommendation by a vote of 4-2. Councillor Durnil moved, seconded by Councillor Clark, for adoption of Proposal No. 66, 1981. Councillors Parker and Strader requested that this proposal be sent back to Committee to have a formal presentation from the Department of Metropolitan Development, seconded by Councillor Journey. Councillor Dowden, Sponsor of this proposal, stated that the language on the books was old and had no relevance with today. Councillor Miller called for the question, seconded by Councillor Tintera. Proposal No. 66, 1981, was then sent back to the Metropolitan Development Committee with consent of the Council.

PROPOSAL NO. 100, 1981. This proposal authorizes changes in the personnel compensation schedule of the Probate Division, Marion County Superior Court. Councillor West stated that this proposal was heard in the Public Safety and Criminal Justice Committee at which time Commissioners' Maximum Salary was amended from \$25,294 to \$25,733, and it received a "Do Pass As Amended" recommendation by a vote of 6-0. Councillor West asked that the "Amended Version" be substituted, seconded by Councillor Cottingham. Consent was given. Councillor West moved, seconded by Councillor Cottingham, for the adoption of Proposal No. 100, 1981, As Amended, and it was adopted on the following roll call vote; viz:
