*PROPOSAL NOS. 128-132, 1975.* Introduced by Councilman West. The Clerk read the Proposals entitled: "Proposals for Rezoning Ordinances certified from the Metropolitan Plan Commission on March 21, 1975;" and the President referred them to the Committee of the Whole to be heard under Special Orders—Final Adoption.

*PROPOSAL NO. 133, 1975.* Introduced by Councilman Cottingham. The Clerk read the Proposal entitled: "A Proposal for a Fiscal Ordinance amending the City-County Annual Budget for 1975 and appropriating an additional \$900 in the City General Fund for purposes of the Board of Voters Registration and reducing certain other appropriations for that office;" and the President referred it to the County and Townships Committee.

*PROPOSAL NO. 134, 1975.* Introduced by Councilman Gorham. *PROPOSAL NO. 138, 1975.* Introduced by Councilman Gorham. The Clerk read the Proposal entitled: "A

Proposal for a General Ordinance further amending Title 4, Chapter 3, Section 306 thereof, establishing preference at intersections of a newly constructed residential street;" and the President referred it to the Transportation Committee.

The Clerk read the Proposal entitled: "A Proposal for a General Ordinance amending City-County General Ordinance No. 57, 1974, to change the salaries and number of personnel authorized for the office of the Juvenile Court;" and the President referred it to the Public Safety and Criminal Justice Committee.

*PROPOSAL NO. 151, 1975.* Introduced by Councilman Cottingham. The Clerk read the Proposal entitled: "A Proposal for a General Ordinance amending City-County General Ordinance No. 57, 1974, to change the salaries and number of personnel authorized for the offices of the County Auditor, County Clerk, and Prosecuting Attorney;" and the President referred it to the County and Townships Committee.

*PROPOSAL NO. 152, 1975.* Introduced by Councilman Cottingham. and number of personnel authorized for the Children's Guardian Home;" and the President referred it to the Community Affairs Committee.

*PROPOSAL NO. 154, 1975.* Introduced by Councilman Griffith. The Clerk read the Proposal entitled: "A Proposal for a Fiscal Ordinance amending the City-County Annual Budget for 1975 and appropriating an additional Twenty-three thousand four hundred eighty-seven dollars (\$23,487.00) in the County Welfare Fund for purposes of the County Department of Public Welfare, Children's Guardian Home, and reducing the unappropriated, unencumbered balance in the County Welfare Fund;" and the President referred it to the Community Affairs Committee.

The Clerk read the Proposal entitled: "A Proposal for a Fiscal Ordinance appropriating \$4,751,000 in the City Market Renovation Fund for purposes of renovation of the City Market and reducing the unappropriated and unencumbered balance in the said fund;" and the President referred it to the Public Works Committee.

The Clerk read the Proposal entitled: "A Proposal for a General Resolution authorizing expenditure of block grant funds for Indianapolis Community Development activities pursuant to application under Title 1 of the Housing and Community Development Act of 1974;" and the President referred it to the Community Affairs Committee.

A FISCAL ORDINANCE amending the CITY-COUNTY ANNUAL BUDGET FOR 1975 (City-County Fiscal Ordinance No. 42, 1974) and appropriating an additional Sixty-five thousand six hundred dollars (\$65,600.00) in the County Welfare Fund for purposes of the County Department of Public Welfare and reducing the unappropriated and unencumbered balance in the County Welfare Fund

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

Section 1. To provide for expenditures the necessity for which has arisen since the adoption of the annual budget, Section 6 of the City-County Annual Budget for 1975 be, and is hereby, amended by the increases and reductions hereinafter stated for the purposes of participation by the County Department of Public Welfare in programs funded under Title II of the Comprehensive Employment and Training Act.

Section 2: The sum of Sixty-five thousand six hundred dollars (\$65,600.00) be and the same is hereby, appropriated for the

purposes as shown in Section 3 by reducing the appropriations as shown in Section 4.

Section 3. The following additional appropriations are hereby approved:

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

Section 1. To provide for expenditures the necessity for which has arisen since the adoption of the annual budget, Section 5 of the City-County Annual Budget for 1975 be, and is hereby, amended by the increases and reductions hereinafter stated for the purposes of employing additional personnel as part of the Comprehensive Employment and Training Act Grant:

Section 5. This Ordinance shall be in full force and effect from and after adoption, following public hearing, and approval by the State Board of Tax Commissioners.

- L. The Chief Probation Officer of the Marion County Criminal Court
- M. The Chief Probation Officer of the Marion County Juvenile Court
- N. The Executive Director of the MCCJCC, who is appointed by the Chairman of the MCCJCC, and who shall sit as a non-voting member representing the Staff of MCCJCC; provided that, in the case of tie vote among MCCJCC members, the Executive Director may cast the tie breaking vote.
- O. The Mayor of the City of Indianapolis, who shall sit as ex-officio member of the MCCJCC.

Section 3. The following shall be advisory members to the MCCJCC:



- A. The Chief of Police of the Beech Grove Police Department
- B. The Chief of Police of the Lawrence Police Department
- C. The Chief of Police of the Speedway Police Department
- D. A representative of the Indiana State Police Department
- E. The Director of Region V of the Indiana Criminal Justice Planning Agency
- F. The Executive Director of the Office of Youth Development of the City of Indianapolis
- G. The Superintendent of the Indianapolis Public Schools

Section 4. It shall be the responsibility of the MCCJCC to determine the needs and problems of their particular offices and agencies and to suggest answers and help find solutions to these needs and problems.

Section 5. The MCCJCC shall also be charged with the following duties and responsibilities:

- A. To confer with appropriate city, county, regional, and federal agencies concerned with the administration of criminal justice for the purpose of improving crime control programs and policies;
- B. To confer with the appropriate city, county, regional and federal agencies for the purpose of securing funds for the support of the MCCJCC and for initiating programs of crime control and criminal justice reform, and on behalf of the city and county, to enter into contracts for grants of federal, state, or other funds to the city and county for such purposes;
- C. To advise the criminal justice agencies on improved policies and programs;
- D. To conduct research, operate programs, and conduct studies of crime control and criminal justice; and to contract with other public or private agencies and engage consultants for such research programs and studies;
- E. To prepare and public such reports and sponsor such conferences as appropriate;

- F. To appoint and direct subcommittees or task forces as appropriate to carry out the responsibilities of the MCCJCC, membership on such task forces or subcommittees to include, but not be limited to, members of the MCCJCC;
- G. To submit to the Mayor and the City-County Council an annual report on MCCJCC activities for the year;
- H. The MCCJCC may expand its activities into appropriate areas with the approval of the Mayor and the City-County Council.

Section 6. All City and County agencies of government and officials thereof shall furnish the MCCJCC with information as is necessary to carry out the purpose and responsibilities of the MCCJCC, provided however, that no agency will be required to furnish information that is defined as being privileged under applicable laws.




