President Ropkey called the meeting to order.

Present: Ernest C. Ropkey, President and seven members, viz: George A. Henry, James A. Houck, Carl A. Hildebrand, Chas. A. Morgan, Maurice E. Tennant, Leo F. Welch, Clarence I. Wheatley.

Absent: Fred C. Gardner.

President Ropkey announced the first business in order to be the election of Officers for 1934.

Mr. Welch made a motion to nominate Mr. Ropkey as President of the Common Council for the coming year. The motion was seconded by Mr. Morgan. Mr. Morgan moved that the nomination be closed. Mr. Henry seconded the motion which motion was carried.

Attention is called to Item 11—Salaries—in the Fire Department Budget, providing for the pay of "50 First and Second Grade Substitutes at \$1,732.45" per year. All new appointees to the Fire Department have the status of Second Grade Substitutes for not less than one year, and at a salary of \$1,425.00 per year. In order that there may be no misunderstanding, the Board of Safety requests that an ordinance be prepared and adopted fixing the pay of Second Grade Substitutes in the Fire Department for the year 1934 at \$1,425.00 per year, payable out of funds appropriated for the pay of 50 First and Second Grade Substitutes.

Attention is called to a similar situation in the Police Department. It will be noted that no appropriation was made for the pay of Second Grade Patrolmen. All new appointees to the Police Department hold the status of Second Grade Patrolmen for not less than one year at a salary of \$1,425.00. It is requested that in the ordinance transferring funds to pay Second Grade Patrolmen for 1934 that the Council fix their salaries at \$1,425.00 per year for 1934.

## INTRODUCTION OF APPROPRIATION ORDINANCES.

## APPROPRIATION ORDINANCE No. 1, 1934.

AN ORDINANCE, appropriating the sum of Fifteen Hundred Dollars (\$1,500.00) from the anticipated unappropriated and unexpended balance of the General Fund for the year 1933, and transferring the same to the World War Memorial Bond Fund, and fixing a time when the same shall take effect.

*Be it ordained by the Common Council of the City of Indianapolis, Indiana:*

Section 1. That there be and there is hereby appropriated out of the anticipated unappropriated and unexpended balance in the General Fund for the year 1933 and transferred therefrom to the World War Memorial Bond Fund the sum of Fifteen Hundred Dollars (\$1,500.00).

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

#### APPROPRIATION ORDINANCE No. 2, 1934.

AN ORDINANCE, appropriating certain moneys from the unexpended appropriation for the year 1933 of the General Fund of the Department of Public Parks to certain numbered funds and fixing a time when the same shall take effect.

WHEREAS, on December 31, 1933, there was carried over into the year 1934 a balance in the unexpended appropriation of the General Fund of the Department of Public Parks for said year 1933 a total sum of more than \$100,000.00, which amount had been appropriated for the year 1933 to various numbered funds, and

WHEREAS, since the making of the budget for 1934 certain unanticipated projects have been undertaken by the Department of Public Parks in order to furnish labor for the C. W. A., and

WHEREAS, an emergency has therefore arisen making it necessary for the appropriating of certain moneys from said unexpended balance to certain numbered funds for the purchase of material for said projects,

NOW, THEREFORE,

*Be it ordained by the Common Council of the City of Indianapolis, Indiana:*

Section 1. That there be and there is hereby appropriated out of the unexpended appropriation of the General Fund of the Department of Public Parks from the year 1933 and appropriated and transferred to the various items of said Park Department funds as hereinafter set forth, to-wit:

Fund No. 41, Building Materials.....	\$ 514.00
Fund No. 42, Sewer Materials .....	6,471.00
Fund No. 43, Street and Alley Materials.....	15,600.00
Total.....	<u>\$22,585.00</u>

Section 2. This ordinance shall take effect from and after its passage, approval by the Mayor and publication according to law.

**GENERAL ORDINANCE No. 1, 1934.**

AN ORDINANCE, authorizing the City Controller of the City of Indianapolis to make a temporary loan or loans in the sum of Six Hundred Fifty Thousand Dollars (\$650,000.00) in the anticipation of current revenues of such city actually levied and in the course of collection for the fiscal year in which such loan or loans are made payable out of the current revenues of said city for such year, authorizing the rate of interest to be charged therefor, providing for legal notice, appropriating the sum of Six Hundred Fifty Thousand Dollars (\$650,000.00) for the payment of the bonds and setting aside the sum of Nine Thousand One Hundred Sixty-four Dollars and Thirty-eight Cents (\$9,164.38), heretofore appropriated by General Ordinance No. 56, 1933, as Item 612—Interest (on temporary loans)—Current Obligations, Department of Finance, Section 2 thereof, for the payment of the interest thereon, and fixing a time when the same shall take effect.

WHEREAS, the said City will be and continue to be until the 15th day of May, 1934, without sufficient funds to meet current expenses for municipal purposes; and

WHEREAS, the first semi-annual installment of taxes for the year 1934, collectable on or before the 15th day of May, 1934, will amount to more than Six Hundred Fifty-nine Thousand One Hundred Sixty-four Dollars and Thirty-eight Cents (\$659,164.38), NOW, THEREFORE,

*Be it ordained by the Common Council of the City of Indianapolis, Indiana:*

Section 1. The City Controller is hereby authorized and empowered to negotiate a temporary loan or loans in anticipation of the current revenues of said City actually levied and in the course of collection for the fiscal year of 1934, not to exceed the total sum of Six Hundred Fifty Thousand Dollars (\$650,000.00) for a period not to exceed the time fixed in this ordinance, at a rate of interest not to exceed six percent (6%). The City Controller is further authorized to negotiate such loan or loans in the following amounts:

Two Hundred Fifty Thousand Dollars (\$250,000.00) on January 15, 1934, to run for a period not to exceed one hundred twenty (120) days thereafter, at a rate of interest not to exceed six percent (6%); Two Hundred Fifty Thousand Dollars (\$250,000.00) on February 28, 1934, to run for a period not to exceed seventy-six (76)

days thereafter, at a rate of interest not to exceed six percent (6%); One Hundred Fifty Thousand Dollars (\$150,000.00) on March 31, 1934, to run for a period not to exceed forty-five (45) days thereafter, at a rate of interest not to exceed six percent (6%). The sale date of said bonds or other evidence of indebtedness shall not be later than January 12, 1934, and after the publication of notice of determination thereof to issue bonds, warrants or other evidence of indebtedness for such temporary loan as provided for by law and this ordinance; said loan shall be let to the lowest and best bidder after the determination to issue the same has been published by at least one publication, one day, in two newspapers in the City of Indianapolis. The Mayor and City Controller are hereby authorized and directed to execute the proper obligations of the City of Indianapolis for the above mentioned amount; and to the payment of such obligation the faith of the City is hereby irrevocably pledged.

Section 2. The sum of Six Hundred Fifty Thousand Dollars (\$650,000.00) is hereby appropriated to Fund No. 63, office of the City Controller; and the sum of Nine Thousand One Hundred Sixty-four Dollars and Thirty-eight Cents (\$9,164.38), heretofore appropriated by General Ordinance No. 56, 1933, as Item 612—Interest (on temporary loans)—Current Obligations, Department of Finance, Section 2 thereof, be and the same is hereby set aside for the payment of the interest on such temporary loan.

Section 3. This ordinance shall be in full force and effect from and after its passage.

Section 1. That the sum of Twenty-eight Thousand Five Hundred Dollars (\$28,500.00), now in Department of Public Safety, Police Department, Fund No. 11—Salaries and Wages Regular, First Grade Patrolmen, be and the same is hereby transferred therefrom and reappropriated to Department of Public Safety, Police Department, Fund No. 11—Salaries and Wages Regular, Second Grade Patrolmen.

Section 2. That the sum of Three Thousand Dollars (\$3,000.00) now in Department of Public Safety, Police Department,

Fund No. 22—Heat, Light and Power, be and the same is hereby transferred therefrom and reappropriated to Department of Public Safety, Police Department, Fund No. 44—General Materials.

Section 3. That the sum of Five Hundred Dollars (\$500.00), now in Department of Public Safety, Police Department, Fund No. 22—Heat, Light and Power, be and the same is hereby transferred therefrom and reappropriated to Department of Public Safety, East Market Fund No. 41—Building.

Section 4. That the sum of Two Hundred Dollars (\$200.00), now in Department of Public Safety, East Market Fund No. 25—Repairs, be and the same is hereby transferred therefrom and reappropriated to Department of Public Safety, East Market Fund No. 41—Building.

Section 5. That the sum of Two Hundred Dollars (\$200.00), now in Department of Public Safety, Fire Department Fund No. 72—Equipment, be and the same is hereby transferred therefrom and reappropriated to Department of Public Safety, Fire Department Fund No. 54—Rents.

Section 6. That the sum of Fifteen Hundred Dollars (\$1,500.00), now in City Plan Commission Fund No. 11—Attorney, and the sum of Six Hundred Dollars (\$600.00), now in the Thoroughfare Plan Fund, be and the same are hereby transferred therefrom and reappropriated in their total sum of Twenty-one Hundred Dollars (\$2,100.00) to City Plan Commission Fund No. 11—Draftsman.

Section 7. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

### GENERAL ORDINANCE No. 3, 1934.

AN ORDINANCE, fixing the salaries of Second Grade Patrolmen in the Police Department and of Second Grade Substitutes in the Fire Department for the year 1934, and fixing a time when the same shall take effect.

*Be it ordained by the Common Council of the City of Indianapolis, Indiana:*

Section 1. That from and after the date of their appointment, all persons hereafter appointed to the police force under the Board of Public Safety shall receive the rank of Second Grade Patrolman and shall not be promoted from such rank until at least one (1) year

after such appointment, and shall receive a salary of Fourteen Hundred Twenty-five Dollars (\$1,425.00) per year for a period of one (1) year.

Section 2. That from and after the date of their appointment, all persons hereafter appointed to the Fire Department under the Board of Public Safety shall receive the rank of Second Grade Substitutes and shall not be promoted from such rank until at least one (1) year after such appointment, and shall receive a salary of Fourteen Hundred Twenty-five Dollars (\$1,425.00) per year for a period of one (1) year.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Finance.

Mr. Houck asked for suspension of the rules for further consideration and passage of General Ordinances Nos. 1 and 2, 1934. The motion was seconded by Mr. Welch, and passed by the following roll call vote:

Mr. Houck called for General Ordinance No. 1, 1934, for second reading. It was read a second time.
